Work Session

HB 3687 A

Prohibits a supermajority vote requirement for any question related to a county or city charter.

Public Hearing

HB 2977 A

Increases the state transient lodging tax.

HB 3390 A

Prescribes the method for creating a ballot title and explanatory statement by a joint legislative committee for any amendment to the Oregon Constitution that passes both houses of the Legislative Assembly during the 2025 regular session and is referred to the people by the Legislative Assembly and for any Act that passes both houses of the Legislative Assembly during the 2025 regular session if the Act is referred to the people by either the Legislative Assembly or by referendum petition.

HB 3525 B

Requires, for each dwelling unit rented by a landlord for which the source of drinking water is an exempt well in a ground water management area, that the landlord collect and test samples of drinking water from the dwelling unit for arsenic, coliform bacteria, lead and nitrates.

HB 3940 B

Imposes a tax on the distribution of oral nicotine products.

HB 3954 A

Prohibits the Adjutant General from assisting or allowing the United States Department of Defense or any branch thereof to communicate with any individual or unit of the Oregon National Guard for purposes of calling the individual or unit into active service unless the active service is for a certain listed reason.

HB 3970 A

Modifies the list of persons who may receive services and assistance funded by the Emergency Housing Account.

Note change: HB 2977 A, HB 3390 A, HB 3525 B, HB 3940 B, HB 3954 A, and HB 3970 A added.
