

A-Engrossed House Bill 2005

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Changes the laws on when people who are mentally ill can be made to get treatment. Changes the laws on what happens to a person charged with a crime who is not fit to go to trial. Changes the laws on some facility siting. (Flesch Readability Score: 80.4).

[Digest: The Act tells OHA to study mental health. (Flesch Readability Score: 82.3).]

[Requires the Oregon Health Authority to study behavioral health. Directs the authority to submit findings to the interim committees of the Legislative Assembly related to health not later than September 15, 2026.]

[Sunsets on January 2, 2027.]

Describes when a person is in need of treatment because the person is a danger to self, a danger to others, unable to provide for basic personal needs or has a chronic mental disorder. Describes the evidence that the court may consider when determining whether a person is in need of treatment because the person is a danger to self, a danger to others, unable to provide for basic personal needs or has a chronic mental disorder.

Modifies the diversion from commitment process. Creates a new procedure for determining when a person is incapacitated for purposes of a declaration for mental health treatment. Modifies the declaration for mental health treatment form. Describes when a declaration for mental health treatment obviates the need for involuntary treatment.

Modifies provisions regarding the sharing of information regarding certain persons receiving mental health treatment.

Includes certain attempted criminal conduct in the types of criminal conduct for which a person may be committed as an extremely dangerous person with mental illness.

Directs the Judicial Department to collect and analyze data regarding tribal and state interactions relating to certain involuntary treatment of tribal members. Establishes the Task Force on the Intersection of Tribal and State Forensic Behavioral Health.

Establishes maximum periods of commitment and community restoration services for criminal defendants determined to lack fitness to proceed. Establishes procedures for requesting extensions to the maximum periods up to a specified total time period. Sunsets the maximum periods on January 1, 2028.

Modifies the process for court determinations on fitness to proceed. Specifies what the court may consider when making the determination and procedures for the hearing on the determination.

Directs the court to determine, upon finding a defendant to lack fitness to proceed, whether the defendant may only be discharged to certain secure facilities.

Modifies the process by which a committed defendant, determined to no longer require a hospital level of care, is discharged to other placements. Establishes procedures for objecting to proposed placements and court procedures when no placements are identified.

Requires local governments to allow, within an urban growth boundary, siting of residential treatment facilities, residential treatment homes or crisis stabilization centers within additional land use zones.

Declares an emergency, effective on passage.

2 Whereas Oregon has a high population of individuals who report living with mental illness, and
3 who need mental health and substance use disorder treatment; and

4 Whereas the Oregon Legislative Assembly finds that the increase in fentanyl and methamphet-
5 amine use has led to an increase in individuals who need a higher level of mental health and sub-
6 stance use disorder care; and

7 Whereas the United States and Oregon Constitutions protect the rights of defendants in the
8 criminal justice system and defendants must be mentally fit to proceed in their criminal cases, and
9 if a defendant is not fit to proceed because of a mental illness, the case must be paused until the
10 defendant is restored to fitness; and

11 Whereas there has been a steady increase in the number of individuals in the last several years
12 who are found not fit to proceed, or “unable to aid and assist” in their own defense; and

13 Whereas many of these individuals who are charged with a crime and determined to be unable
14 to aid and assist in their own defense who are referred to the Oregon State Hospital for care are
15 not admitted within seven days, as required by a federal court order; and

16 Whereas the population of individuals admitted to the Oregon State Hospital has shifted to in-
17 creasing numbers of aid and assist patients rather than guilty except for insanity and civilly com-
18 mitted patients; and

19 Whereas increased demand for restoration services for defendants at the Oregon State Hospital
20 has limited the beds available for individuals obtaining treatment through civil commitment; and

21 Whereas ensuring the rights of defendants to timely transportation to a therapeutic setting for
22 restoration treatment will require significant financial investments and strategic initiatives from the
23 state; and

24 Whereas the state must protect the rights of victims of crime and ensure improved public safety;
25 and

26 Whereas public safety improves when individuals can access mental health treatment and ser-
27 vices within the criminal justice system, the Oregon State Hospital and the community; and

28 Whereas protecting the rights of defendants while ensuring public safety requires solutions of
29 many different types and the recognition that one idea will not solve this problem; and

30 Whereas the three branches of Oregon’s government are committed to ongoing efforts, both in
31 statute and in budget allocations, to solving this ongoing dilemma; and

32 Whereas the Oregon Legislative Assembly has determined that additional treatment capacity is
33 critical to support Oregonians in need of mental health and substance use disorder treatment and
34 has committed increased funding to support additional treatment capacity; and

35 Whereas it is the intention of the Oregon Legislative Assembly to increase support and capacity
36 for individuals needing mental health and substance use disorder care and treatment, and to reduce
37 the delay in admittance experienced by defendants needing restoration services at the Oregon State
38 Hospital; now, therefore,

41 **CIVIL COMMITMENT**
42 **(Person with a Mental Illness)**
43

44 **SECTION 1. Sections 2 and 3 of this 2025 Act are added to and made a part of ORS 426.070**
45 **to 426.170.**

1 **SECTION 2.** (1) A person has a mental illness and is in need of treatment for purposes
2 of ORS 426.005 to 426.390 if the person is in need of treatment because the person:

- 3 (a) Is a danger to self;
- 4 (b) Is a danger to others;
- 5 (c) Is unable to provide for basic personal needs; or
- 6 (d) Has a chronic mental disorder.

7 (2) A person is a danger to self for purposes of this section if, because of a mental dis-
8 order:

9 (a) The person engaged in or threatened to engage in behavior that resulted in or was
10 likely to result in serious physical harm to self; and

11 (b) Taking into consideration the person's particular history and circumstances, it is
12 reasonably foreseeable that the person will engage in such behavior in the near future, even
13 if such behavior is not imminent.

14 (3) A person is a danger to others for purposes of this section if, because of a mental
15 disorder:

16 (a) The person engaged in or threatened to engage in behavior that resulted in or was
17 likely to result in physical harm to another person; and

18 (b) Taking into consideration the person's particular history and circumstances, it is
19 reasonably foreseeable that the person will engage in such behavior in the near future, even
20 if such behavior is not imminent.

21 (4) A person is unable to provide for basic personal needs for purposes of this section if,
22 because of a mental disorder:

23 (a) The person is unable to provide for basic personal needs that are necessary for the
24 person to avoid reasonably foreseeable serious physical harm in the near future, even if the
25 serious physical harm is not imminent; and

26 (b)(A) The person is not receiving such care as is necessary to avoid such harm; or

27 (B) If the person is involuntarily confined in a custodial setting, it is reasonably fore-
28 seeable that upon release the person will not receive such care as is necessary to avoid such
29 harm.

30 (5) A person has a chronic mental disorder for purposes of this section if:

31 (a) The person is a person with a chronic mental illness, as defined in ORS 426.495; and

32 (b) Within the previous three years the person has twice been placed in a hospital or
33 approved inpatient facility by the Oregon Health Authority under ORS 426.060.

34 **SECTION 3.** (1) When determining whether a person has a mental illness and is in need
35 of treatment, the court may consider information that assists the court in making its de-
36 termination, including but not limited to any of the following:

37 (a) The person's insight into the person's mental illness.

38 (b) The impact of the person's insight or lack of insight on the person's ability to follow
39 a recommended treatment plan.

40 (c) The likelihood that, absent treatment, the person will become a danger to self, a
41 danger to others or unable to provide for basic personal needs, as described in section 2 of
42 this 2025 Act, in the near future.

43 (d) When possible, a clinical perspective on paragraph (c) of this subsection.

44 (2) When determining whether a person is in need of treatment because the person is a
45 danger to self as described in section 2 of this 2025 Act, the court may consider information

1 that assists the court in making its determination, including but not limited to any of the
2 following:

3 (a) The person's recent overt acts causing or attempting to cause serious physical harm
4 to self.

5 (b) Recent acts placing the person in circumstances that resulted in or were likely to
6 result in serious physical harm to self.

7 (c)(A) The person's recent threats to cause serious physical harm to self and the severity
8 of the harm threatened;

9 (B) Absent treatment, the likelihood of such threats being carried out; and

10 (C) Absent treatment, the likelihood of such threats reoccurring.

11 (d) Any past behavior and patterns of deterioration resulting from a mental disorder that
12 contributed to prior involuntary hospitalizations for being a danger to self, how recently the
13 past behavior occurred and the frequency and severity of the past behavior.

14 (3) When determining whether a person is in need of treatment because the person is a
15 danger to others as described in section 2 of this 2025 Act, the court may consider informa-
16 tion that assists the court in making its determination, including but not limited to any of
17 the following:

18 (a)(A) Recent overt acts causing or attempting to cause physical harm to another person;
19 and

20 (B) The frequency and severity of such acts.

21 (b) Recent destructive acts against property that were reasonably likely to place others
22 at risk of physical harm.

23 (c)(A) Recent threats to cause physical harm to another person;

24 (B) The severity of the harm threatened;

25 (C) Absent treatment, the likelihood of such threats being carried out; and

26 (D) Absent treatment, the likelihood of such threats reoccurring.

27 (d)(A) Any past behavior and patterns of deterioration resulting from a mental disorder
28 that contributed to prior involuntary hospitalizations for being a danger to others;

29 (B) How recently the past behavior occurred; and

30 (C) The frequency and severity of the past behavior.

31 (e) When possible, a clinical perspective on the person's risk of causing physical harm
32 to another person.

33 (4) The court may not find that a person is in need of treatment because the person has
34 a chronic mental disorder, as described in section 2 of this 2025 Act, unless the court finds
35 that:

36 (a) The person is exhibiting symptoms or behavior substantially similar to those that
37 preceded and led to one or more of the hospitalizations or inpatient placements referred to
38 in section 2 (5)(b) of this 2025 Act; and

39 (b) Absent treatment, the person will continue, to a reasonable medical probability, to
40 physically or mentally deteriorate so that the person will become a danger to self, a danger
41 to others or unable to provide for the person's basic personal needs, as described in section
42 2 (2) to (4) of this 2025 Act.

43 **SECTION 4.** ORS 426.005 is amended to read:

44 426.005. (1) As used in ORS 426.005 to 426.390, unless the context requires otherwise:

45 (a) "Community mental health program director" means the director of an entity that provides

1 the services described in ORS 430.630 (3) to (5).

2 (b) “Director of the facility” means a superintendent of a state mental hospital, the chief of
3 psychiatric services in a community hospital or the person in charge of treatment and rehabilitation
4 programs at other treatment facilities.

5 (c) “Facility” means a state mental hospital, community hospital, residential facility,
6 detoxification center, day treatment facility or such other facility as the authority determines suit-
7 able that provides diagnosis and evaluation, medical care, detoxification, social services or rehabil-
8 itation to persons who are in custody during a prehearing period of detention or who have been
9 committed to the Oregon Health Authority under ORS 426.130.

10 (d) “Licensed independent practitioner” means:

11 (A) A physician, as defined in ORS 677.010;

12 (B) A nurse practitioner licensed under ORS 678.375 and authorized to write prescriptions under
13 ORS 678.390; or

14 (C) A naturopathic physician licensed under ORS chapter 685.

15 (e) “Nonhospital facility” means any facility, other than a hospital, that is approved by the au-
16 thority to provide adequate security, psychiatric, nursing and other services to persons under ORS
17 426.232 or 426.233.

18 (f) “Person with mental illness” means a person **described in section 2 (1) of this 2025 Act.**
19 *[who, because of a mental disorder, is one or more of the following:]*

20 *[(A) Dangerous to self or others.]*

21 *[(B) Unable to provide for basic personal needs that are necessary to avoid serious physical harm*
22 *in the near future, and is not receiving such care as is necessary to avoid such harm.]*

23 *[(C) A person:]*

24 *[(i) With a chronic mental illness, as defined in ORS 426.495;]*

25 *[(ii) Who, within the previous three years, has twice been placed in a hospital or approved inpatient*
26 *facility by the authority or the Department of Human Services under ORS 426.060;]*

27 *[(iii) Who is exhibiting symptoms or behavior substantially similar to those that preceded and led*
28 *to one or more of the hospitalizations or inpatient placements referred to in sub-subparagraph (ii) of*
29 *this subparagraph; and]*

30 *[(iv) Who, unless treated, will continue, to a reasonable medical probability, to physically or men-*
31 *tally deteriorate so that the person will become a person described under either subparagraph (A) or*
32 *(B) of this paragraph or both.]*

33 **(g) “Physical harm” means physical injury, physical pain or other physiological impair-**
34 **ment, other than an injury, pain or impairment that is trivial in terms of pain or other bodily**
35 **impact.**

36 *[(g)] (h) “Prehearing period of detention” means a period of time calculated from the initiation*
37 *of custody during which a person may be detained under ORS 426.228, 426.231, 426.232 or 426.233.*

38 **(i) “Serious physical harm” means physical injury, physical pain or other physiological**
39 **impairment that places a person at risk of:**

40 **(A) Death;**

41 **(B) Serious and irreversible deterioration of health; or**

42 **(C) Serious and irreversible deterioration of any bodily organ.**

43 (2) Whenever a community mental health program director, director of the facility, superinten-

1 **SECTION 5.** ORS 426.130 is amended to read:

2 426.130. (1) After hearing all of the evidence, and reviewing the findings of the examiners, the
3 court shall determine whether, **by clear and convincing evidence**, the person has a mental illness
4 and is in need of treatment.

5 (2) *[If, in the opinion of the court,]* **If the court determines under subsection (1) of this**
6 **section that** the person:

7 (a) *[Is a person with mental illness based upon clear and convincing evidence,]* **Has a mental**
8 **illness and is in need of treatment**, the court:

9 (A) Shall order the release of the person and dismiss the case if:

10 (i) The person is willing and able to participate in treatment on a voluntary basis; and

11 (ii) The court finds that the person will probably do so.

12 (B) May order conditional release under this subparagraph subject to the qualifications and re-
13 quirements under ORS 426.125. If the court orders conditional release under this subparagraph, the
14 court shall establish a period of commitment for the conditional release.

15 (C) May order commitment of the person *[with mental illness]* to the Oregon Health Authority
16 for treatment if, in the opinion of the court, subparagraph (A) or (B) of this paragraph is not in the
17 best interest of the person. If the court orders commitment under this subparagraph:

18 (i) The court shall establish a period of commitment.

19 (ii) The authority may place the committed person in outpatient commitment under ORS 426.127.

20 (D) Shall order that the person be prohibited from purchasing or possessing a firearm if, in the
21 opinion of the court, there is a reasonable likelihood the person *[would constitute]* **is** a danger to self
22 or others, or to the community at large, as a result of the person's mental or psychological state
23 as demonstrated by past behavior or participation in incidents involving unlawful violence or threats
24 of unlawful violence, or by reason of a single incident of extreme, violent, unlawful conduct. When
25 a court makes an order under this subparagraph, the court shall cause a copy of the order to be
26 delivered to the sheriff of the county who will enter the information into the Law Enforcement Data
27 System.

28 (b) *[Is not a person with mental illness]* **Is not a person with a mental illness who is in need**
29 **of treatment**, the court shall release the person from custody if the person has been detained under
30 ORS 426.070, 426.180, 426.228, 426.232 or 426.233 and:

31 (A) Dismiss the case; or

32 (B) Order the person to participate in assisted outpatient treatment in accordance with ORS
33 426.133. The court may continue the proceeding for no more than seven days to allow time for the
34 community mental health program director to develop the person's assisted outpatient treatment
35 plan.

5 **SECTION 6.** ORS 426.070 is amended to read:

6 426.070. (1) Any of the following may initiate commitment procedures under this section by giv-
7 ing the notice described under subsection (2) of this section:

8 (a) Two persons;

9 (b) The local health officer; or

10 (c) [Any] **A** magistrate **mentioned in ORS 133.030** or a judge of a court of a federally recog-
11 nized Indian tribe located in this state.

12 (2) For purposes of subsection (1) of this section, the notice must comply with the following:

13 (a) It must be in writing under oath;

14 (b) It must be given to the community mental health program director or a designee of the di-
15 rector in the county where the person alleged to have a mental illness resides;

16 (c) It must state that a person within the county other than the person giving the notice [*is a*
17 *person with*] **has a** mental illness and is in need of treatment, care or custody;

18 (d) If the commitment proceeding is initiated by two persons under subsection (1)(a) of this sec-
19 tion, it may include a request that the court notify the two persons:

20 (A) Of the issuance or nonissuance of a warrant under this section; or

21 (B) Of the court's determination under ORS 426.130 [(1)]; and

22 (e) If the notice contains a request under paragraph (d) of this subsection, it must also include
23 the addresses of the two persons making the request.

8 person to be brought before it at a time and place as it may direct, for a hearing under ORS 426.095
9 to determine whether the person [*is a person with mental illness*] **has a mental illness and is in**
10 **need of treatment**. The person shall be given the opportunity to appear voluntarily at the hearing
11 unless the person fails to appear or unless the person is detained pursuant to paragraph (b) of this
12 subsection.

13 (b)(A) If the court finds that there is probable cause to believe that failure to take the person
14 into custody pending the investigation or hearing would pose serious harm or danger to the person
15 or to others, the court may issue a warrant of detention to the community mental health program
16 director or designee or the sheriff of the county or designee directing the director, sheriff or a
17 designee to take the person alleged to have a mental illness into custody and produce the person
18 at the time and place stated in the warrant.

19 (B) At the time the person is taken into custody, the person shall be informed by the community
20 mental health program director, the sheriff or a designee of the following:

21 (i) The person's rights with regard to representation by or appointment of counsel as described
22 in ORS 426.100;

24 (iii) The person's right, if the community mental health program director, sheriff or designee
25 reasonably suspects that the person is a foreign national, to communicate with an official from the
26 consulate of the person's country. A community mental health program director, sheriff or designee

28 subparagraph. Failure to provide the information required by this sub-subparagraph does not in itself
29 constitute grounds for the exclusion of evidence that would otherwise be admissible in a proceeding.

37 **SECTION 7. Section 8 of this 2025 Act is added to and made a part of ORS 426.070 to**
38 **426.170.**

39 **SECTION 8. (1) At any time before the conclusion of a hearing under ORS 426.095, the**
40 **community mental health program director may offer a person alleged to have a mental ill-**
41 **ness and to be in need of treatment a diversion from commitment as an opportunity for in-**
42 **tensive treatment if:**

43 **(a) The community mental health program director and a licensed independent practi-**
44 **tioner of a hospital or nonhospital facility have probable cause to believe the person has a**
45 **mental illness and is in need of treatment; and**

1 **(b)(A) The hospital or nonhospital facility is approved by the Oregon Health Authority;**
2 **and**

3 **(B) The community mental health program director and the licensed independent prac-**
4 **itioner agree that the hospital or nonhospital facility can provide the intensive care or**
5 **treatment for mental illness that is necessary and sufficient to meet the emergency psychi-**
6 **atric needs of the person.**

7 **(2)(a) The community mental health program director shall provide notice of the offer**
8 **of diversion from commitment:**

9 **(A) In writing to the court having jurisdiction under ORS 426.060; and**

10 **(B) Orally and in writing to the person alleged to have a mental illness and to be in need**
11 **to treatment.**

12 **(b) The notice under this subsection must include all of the following:**

13 **(A) A written statement by the community mental health program director and the li-**
14 **censed independent practitioner, attesting that the director and the practitioner have prob-**
15 **able cause to believe the person has a mental illness and is in need of treatment.**

16 **(B) A diversion treatment plan described in subsection (3) of this section.**

17 **(C) Notice of the person's right to request and be provided with a hearing under ORS**
18 **426.070 to 426.170 at any time during the diversion from commitment.**

19 **(D) Notice of the person's rights regarding representation by or appointment of counsel.**

20 **(E) The date and time the notice was given to the person.**

21 **(3)(a) A licensed independent practitioner who files a statement described in subsection**
22 **(2)(b)(A) of this section must, in consultation with the community mental health program**
23 **director, prepare a diversion treatment plan for the person alleged to have a mental illness**
24 **and to be in need of treatment.**

25 **(b) The treatment plan must describe, in general terms, the types of treatment and**
26 **medication to be provided to the person during the diversion.**

27 **(c) The treatment plan must include, at a minimum:**

28 **(A) A description of the medications to be administered;**

29 **(B) The mental health interventions, therapies or diagnostic procedures to be employed;**

30 **(C) The person's preferences for medications and therapies;**

31 **(D) Limitations on specific medications or therapies;**

32 **(E) The location of services; and**

33 **(F) Other conditions or limitations for treatment the practitioner determines are rele-**
34 **vant.**

35 **(4) Immediately upon receipt of a notice under subsection (2) of this section, the court**
36 **shall:**

37 **(a) Appoint legal counsel for the person, subject to ORS 426.100; and**

38 **(b) Provide notice of the offer of diversion from commitment to the person's legal coun-**
39 **sel.**

40 **(5)(a) Not later than close of the judicial day immediately following receipt of the notice**
41 **under subsection (4) of this section, the person's legal counsel, if any, shall review with the**
42 **person the notice and the contents of the treatment plan.**

43 **(b) If the person, after consultation with the person's legal counsel, if any, does not**
44 **consent to the offer of diversion from commitment, the hearing required by ORS 426.070**
45 **must be held no later than five judicial days following the person's date of detention.**

1 (c) If the person, after consultation with the person's legal counsel, if any, consents to
2 the offer of diversion from commitment as set forth in the notice, the court shall postpone
3 the hearing required by ORS 426.070 for 14 days from the date of consent.

4 (6)(a) The community mental health program director may offer to extend the duration
5 of a person's diversion from commitment for up to 14 additional days if the criteria under
6 subsection (1) of this section continue to be met.

7 (b) If the person consents to the extension, the court shall postpone the hearing required
8 under ORS 426.070 by an additional 14 days from the date of the person's consent to the ex-

10 (c) A person consenting to an extension under this subsection may not be held without
11 a hearing as provided in ORS 426.070 for longer than 28 days from the date the person ini-

13 (7) During the period of a person's diversion from commitment:

14 (a) The person may not be subjected to unusual or hazardous treatment procedures, in-
15 cluding convulsive therapy, and shall receive usual and customary treatment in accordance

18 ent practitioner shall treat the person within the scope of the treatment plan provided to the
19 person with the notice of the offer of diversion from commitment.

20 (c) If the person expressly refuses treatment:

21 (A) The treating licensed independent practitioner shall notify the community mental
22 health program director;

23 (B) The community mental health program director shall immediately notify the person
24 and the person's legal counsel, if any, that the person's refusal of treatment may result in
25 the recommencement of commitment proceedings; and

26 (C) If, after providing the person with at least one judicial day to resume treatment fol-
27 lowing receipt of the notice under subparagraph (B) of this paragraph, the community mental
28 health program director determines that the person is likely to continue to refuse treatment,
29 the community mental health program director may request a hearing as provided in sub-
30 section (12) of this section.

31 (d)(A) If the person is in a hospital, the licensed independent practitioner who is treating
32 the person shall discharge the person from the hospital and the community mental health
33 program director shall transfer the person to the nonhospital facility for the remainder of
34 the diversion from commitment if the community mental health program director and the
35 treating licensed independent practitioner agree that the nonhospital facility can provide the
36 care or treatment for mental illness that is necessary and sufficient to meet the emergency
37 needs of the person.

38 (B) Notwithstanding subparagraph (A) of this paragraph, the treating licensed independ-
39 ent practitioner shall retain the person in the hospital if, in the opinion of the treating li-
40 censed independent practitioner, the person's condition requires the person to receive

42 (e) If the person is in a nonhospital facility, the community mental health program di-
43 rector shall transfer the person to a hospital approved by the authority under the following

2 **(B) The licensed independent practitioner agrees to admit the person to a hospital, ap-**
3 **proved by the authority, where the licensed independent practitioner has admitting privi-**
4 **leges.**

5 **(f) If the person is transferred as provided in paragraph (d) or (e) of this subsection, the**
6 **community mental health program director shall provide notice of the person's location to**
7 **the person's legal counsel, if any, and the circuit court in the county where the notice under**
8 **subsection (2) of this section was filed. The person may appeal the transfer as provided by**
9 **rules of the authority.**

10 **(8) A person may be discharged from the diversion from commitment at any time if:**

11 **(a) The person is in a hospital and the licensed independent practitioner who is treating**
12 **the person has:**

13 **(A) Determined that the person no longer requires care in the hospital setting;**

14 **(B) Informed the community mental health program director; and**

15 **(C) Conferred with the person's next of kin and, if applicable, guardian, to the extent al-**
16 **lowed under ORS 192.567.**

17 **(b) The person is in a nonhospital facility and the community mental health program di-**
18 **rector has:**

19 **(A) Determined that the person no longer requires care in the nonhospital facility;**

20 **(B) Conferred with the licensed independent practitioner who is treating the person; and**

21 **(C) Conferred with the person's next of kin and, if applicable, guardian, if the person**
22 **consented to the consultation.**

23 **(9) Immediately upon a person's discharge from the diversion from commitment, if the**
24 **person was discharged pursuant to subsection (8) of this section, the community mental**
25 **health program director shall provide notice of the person's discharge to the person's legal**
26 **counsel, if any, and the circuit court in the county in which the notice under subsection (2)**
27 **of this section was initially filed.**

28 **(10) The person may agree to voluntary treatment at any time during the diversion from**
29 **commitment. When a person agrees to voluntary treatment under this subsection, the**
30 **community mental health program director shall immediately provide notice of the person's**
31 **agreement to the person's legal counsel, if any, and the circuit court in the county in which**
32 **the notice under subsection (2) of this section was initially filed.**

33 **(11) When the circuit court receives notification under subsection (9) or (10) of this sec-**
34 **tion, the court shall dismiss the case.**

2 custody before the hearing the investigation shall be completed at least 24 hours before the hearing

4 (a) If the person can be located, the investigator shall contact the person within three judicial
5 days from the date the community mental health program director or a designee receives a notice
6 under ORS 426.070 alleging that the person has a mental illness and is in need of treatment.

8 receives a notice under ORS 426.070, one of the following shall occur:

9 (A) The investigation shall be completed and submitted to the court.

10 (B) An application for extension shall be made to the court under paragraph (c) of this sub-

39 (3) A copy of the investigation report shall be provided as soon as possible, but in no event later
40 than 24 hours prior to the hearing, to the person and to the person's counsel. Copies shall likewise
41 be provided to counsel assisting the court, to the examiners and to the court for use in questioning

23 (5) When, after providing the court with notice under subsection (4) of this section, the

26 for purposes of ORS 127.700 to 127.737, the investigation shall continue as provided in sub-
27 sections (1) to (3) of this section.

28 (b) If the court determines that the person is incapable for purposes of ORS 127.700 to

30 (A) The investigator shall, after consultation with the licensed independent practitioner

43 (6) A finding of incapacity under section 15 of this 2025 Act may not be used as evidence
44 that a person subject to investigation has a mental illness and is in need of treatment, as
45 described in section 2 (1) of this 2025 Act. However, evidence supporting a determination of

1 **incapacity under section 15 of this 2025 Act or evidence of a declaration of mental health**
2 **treatment may be considered by the court as the court deems relevant for any determi-**

32 paragraph (b) of this subsection to have [*an attorney*] **legal counsel** appointed may be exercised as

34 (f) In all cases suitable legal counsel shall be present at the hearing and may be present at ex-
35 amination and may examine all witnesses offering testimony, and otherwise represent the person.

36 (4) **When the court is required to appoint counsel for a person under ORS 426.005 to**
37 **426.390, the court shall appoint suitable legal counsel for the person unless:**

- 38 (a) **The person is already represented by legal counsel; or**
- 39 (b) **The person expressly, knowingly and intelligently refuses appointment of legal coun-**
40 **sel.**

41 [(4)] (5) The responsibility for representing the state's interest in commitment proceedings, in-
42 cluding, but not limited to, preparation of the state's case and appearances at commitment hearings
43 is as follows:

44 (a) The Attorney General's office shall have the responsibility relating to proceedings initiated
45 by state hospital staff that are any of the following:

1 (A) Recommitment proceedings under ORS 426.307; or

2 (B) Proceedings under ORS 426.228, 426.232 or 426.233.

3 (b) The district attorney if requested to do so by the governing body of the county.

5 by the governing body of a county shall take the responsibility. A county governing body may des-

13 been changed to voluntary shall be released unless the Oregon Health Authority certifies to the

16 to the director of the treating facility the responsibility for making the certification. The director

20 **SECTION 15. (1) A person is incapable for purposes of ORS 127.700 to 127.737 if:**

21 **(a) The person's ability to receive and evaluate information effectively or communicate**
22 **decisions is impaired to such an extent that the person currently lacks capacity to make**
23 **mental health treatment decisions, taking into consideration such factors as those described**
24 **in subsection (2) of this section; and**

44 **(h) Understands the impact of the person's preferred outcome on important areas of the**
45 **person's life, including relationships, housing, ability to work or ability to exercise future**

2 (i) **Is able to identify behaviors the person needs to adopt to achieve the person's pre-**
3 **ferred treatment outcome.**

4 (3)(a) **Any person, including the person whose capacity is being determined, who is in-**
5 **terested in the affairs or welfare of a respondent may file a petition for a determination of**
6 **capacity for purposes of a respondent's declaration for mental health treatment in the cir-**
7 **cuit court of the county in which the respondent resides or is present.**

8 (b) **The petition must include a copy of the respondent's declaration for mental health**

17 (E) **A statement of the reasons for which a determination of capacity is sought; and**

18 (F) **The name and statement of interest of the person initiating the petition or any per-**

20 (c) **The petitioner shall provide a copy of the petition to the respondent and the**
21 **respondent's attorney, if any.**

22 (d) **After providing the respondent with an opportunity to be heard in person or through**
23 **counsel, the court, upon receiving a petition under paragraph (a) of this subsection or upon**
24 **receiving notice from an investigator under ORS 426.074, shall enter a judgment determining**
25 **by a preponderance of the evidence whether the respondent is incapable, as described in**
26 **subsection (1)(a) of this section.**

27 (e) **At the request of the petitioner or the respondent or on the court's own initiative,**
28 **the court shall include written findings, by a preponderance of the evidence, regarding:**

29 (A) **Whether the respondent has executed a declaration for mental health treatment;**

30 (B) **Whether the respondent's declaration was validly executed;**

31 (C) **Whether the declaration has been revoked or has expired; and**

32 (D) **What treatment is authorized or prohibited under the declaration.**

33 (f) **If the determination of capacity is made following notice from an investigator under**

NOTICE TO PERSON MAKING A DECLARATION FOR MENTAL HEALTH TREATMENT

This is an important legal document. It creates a declaration for mental health treatment. Before signing this document, you should know these important facts:

This document allows you to make decisions in advance about certain types of mental health treatment: psychoactive medication, short-term (not to exceed [*17 days*] **the number of days you indicate above**) admission to a treatment facility, convulsive treatment and outpatient services. Outpatient services are mental health services provided by appointment by licensed professionals

1 and programs. The instructions that you include in this declaration will be followed only if a court
2 or two [*physicians*] **capacity evaluators** believe that you are incapable of making treatment deci-
3 sions. Otherwise, you will be considered capable to give or withhold consent for the treatments.
4 Your instructions may be overridden if you are being held pursuant to [*civil commitment law*] a
5 **court order**.

6 You may also appoint a person as your representative to make treatment decisions for you if
7 you become incapable. The person you appoint has a duty to act consistently with your desires as
8 stated in this document or, if not stated, as otherwise known by the representative. If your repre-
9 sentative does not know your desires, he or she must make decisions in your best interests. For the
10 appointment to be effective, the person you appoint must accept the appointment in writing. The
11 person also has the right to withdraw from acting as your representative at any time. A “representa-
12 tive” is also referred to as an “attorney-in-fact” in state law but this person does not need to be
13 an attorney at law.

14 This document will continue in effect for a period of three years unless you become incapable
15 of participating in mental health treatment decisions. If this occurs, the directive will continue in
16 effect until you are no longer incapable.

17 You have the right to revoke this document in whole or in part at any time you have not been
18 determined to be incapable. **YOU MAY NOT REVOKE THIS DECLARATION WHEN YOU ARE**
19 **CONSIDERED INCAPABLE BY A COURT OR TWO [*PHYSICIANS*] CAPACITY EVALUATORS.**
20 A revocation is effective when it is communicated to your attending physician or other provider.

21 If there is anything in this document that you do not understand, you should ask a lawyer to
22 explain it to you. This declaration will not be valid unless it is signed by a **notary or** two qualified
23 witnesses who are personally known to you and who are present when you sign or acknowledge
24 your signature.

25 **NOTICE TO PHYSICIAN OR PROVIDER**

26 Under Oregon law, a person may use this declaration to provide consent for mental health
27 treatment or to appoint a representative to make mental health treatment decisions when the person
28 is incapable of making those decisions. A person is “incapable” when, in the opinion of a court or
29 two [*physicians*] **capacity evaluators**, the person’s ability to receive and evaluate information ef-
30 fectively or communicate decisions is impaired to such an extent that the person currently lacks the
31 capacity to make mental health treatment decisions. This document becomes operative when it is
32 delivered to the person’s physician or other provider and remains valid until revoked or expired.
33 Upon being presented with this declaration, a physician or provider must make it a part of the
34 person’s medical record. When acting under authority of the declaration, a physician or provider
35 must comply with it to the fullest extent possible. If the physician or provider is unwilling to comply
36 with the declaration, the physician or provider may withdraw from providing treatment consistent

39 or does not administer mental health treatment according to and in good faith reliance upon the
40 validity of this declaration is not subject to criminal prosecution, civil liability or professional dis-

2 426.155. (1) The provisions of this section apply to the release of information about a person who
3 is held in custody either pending a commitment proceeding under ORS 426.070, 426.140, 426.228,
4 426.232, 426.233 or [426.237 (1)(b)] **section 8 of this 2025 Act** or while committed or recommitted
5 under ORS 426.005 to 426.390.

6 (2) Notwithstanding the provisions of ORS 179.495, 179.505 or 192.355 (2) and notwithstanding
7 any other provision of ORS 426.005 to 426.390, a facility or nonhospital facility where a person is
8 held shall establish procedures for releasing information as required under subsections (3) and (4)
9 of this section.

10 (3)(a) If a person described in subsection (1) of this section authorizes disclosure as provided in
11 subsection (5) of this section, upon request of a member of the family of the person, or any other
12 designee of the person, a facility or nonhospital facility where the person is held shall provide the
13 family member or the designee with the following information:

14 (A) The person's diagnosis;

15 (B) The person's prognosis;

16 (C) The medications prescribed for the person and the side effects of medications prescribed, if

18 (D) The person's progress;

19 (E) Information about any civil commitment process, including the date, time and location of the

31 quests that this information not be provided. The facility or nonhospital facility shall make reason-
32 able attempts to notify the person's next of kin, or any other designee of the person, of the person's
33 release, transfer, serious illness, injury or death upon request of the family member or designee,

35 facility or nonhospital facility that the person has the right to request that this information not be

11 (2)(a) At the time the person is admitted to or retained in a hospital under ORS 426.232, the li-
12 censed independent practitioner shall contact the community mental health program director of the
13 county in which the person resides, if the county of residence is different from the county in which
14 the hospital is located. The community mental health program director may request that the licensed
15 independent practitioner notify the circuit court in the county in which the person resides. If the
16 community mental health program director does not make the request, the licensed independent
17 practitioner shall notify, immediately and in writing, the circuit court in the county in which the
18 person is hospitalized.

19 (b) At the time the person is admitted to a hospital under ORS 426.232 after being brought to
20 the hospital by a peace officer under ORS 426.228, the licensed independent practitioner shall con-
21 tact the community mental health program director of the county in which the person is hospital-
22 ized. The community mental health program director of the county in which the person is
23 hospitalized may request that the licensed independent practitioner notify the circuit court in the

6 (c) Wear the clothing of the person;

7 (d) Keep personal possessions, including toilet articles;

8 (e) Religious freedom;

9 (f) A private storage area with free access thereto;

10 (g) Be furnished with a reasonable supply of writing materials and stamps;

11 (h) A written treatment plan, kept current with the progress of the person;

12 (i) Be represented by counsel whenever the substantial rights of the person may be affected;

13 (j) Petition for a writ of habeas corpus;

14 (k) Not be required to perform routine labor tasks of the facility except those essential for
15 treatment;

16 (L) Be given reasonable compensation for all work performed other than personal housekeeping
17 duties;

18 (m) Daily access to fresh air and the outdoors, except that this right may be limited when it
19 would create significant risk of harm to the person or others;

20 (n) Reasonable privacy and security in resting, sleeping, dressing, bathing, personal hygiene and
21 toileting, except that this right may be limited when it would create significant risk of harm to the
22 person or others;

23 (o) Such other rights as may be specified by rule; and

24 (p) Exercise all civil rights in the same manner and with the same effect as one not admitted
25 to the facility, including, but not limited to, the right to dispose of real property, execute instru-
26 ments, make purchases, enter contractual relationships, and vote, unless the person has been adju-
27 dicated incompetent and has not been restored to legal capacity. Disposal of personal property in
28 possession of the person in a state institution described in ORS 426.010 is subject to limitation for

31 (A) Of the right to send or receive sealed mail under subsection (1)(b) of this section;

32 (B) Regarding the disposal of personal property under subsection (1)(p) of this section;

44 **tion for mental health treatment described in** ORS 127.700 to 127.737. This right may be denied
45 to a person for good cause as defined in administrative rule only by the director of the facility in

1 which the person is confined, but only after consultation with and approval of an independent ex-
2 amining physician. Any denial shall be entered into the person's treatment record and shall include
3 the reasons for the denial. A person with mental illness may not be subjected to psychosurgery, as

18 **COMMITMENT OF EXTREMELY DANGEROUS PERSONS**

19
20 **SECTION 37.** ORS 426.701 is amended to read:

21 426.701. (1) For the purposes of this section and ORS 426.702:

22 (a) A person is "extremely dangerous" if the person:

23 (A) Is at least 18 years of age;

24 (B) Is exhibiting symptoms or behaviors of a qualifying mental disorder substantially similar to
25 those that preceded the act described in subsection (3)(a)(C) of this section; and

26 (C) Because of a qualifying mental disorder:

27 (i) Presents a serious danger to the safety of other persons by reason of an extreme risk that
28 the person will inflict grave or potentially lethal physical injury on other persons; and

29 (ii) Unless committed, will continue to represent an extreme risk to the safety of other persons
30 in the foreseeable future.

31 (b) "Qualifying mental disorder" does not include:

32 (A) A disorder manifested solely by repeated criminal or otherwise antisocial conduct; or

33 (B) A disorder constituting solely a personality disorder.

34 (c) A qualifying mental disorder is "resistant to treatment" if, after receiving care from a li-
35 censed psychiatrist and exhausting all reasonable psychiatric treatment, or after refusing psychiatric
36 treatment, the person continues to be significantly impaired in the person's ability to make compe-
37 tent decisions and to be aware of and control extremely dangerous behavior.

38 **(d) A person "attempted to" cause a result or engage in specified conduct if the person**
39 **intentionally engaged in conduct that constituted a substantial step toward causing the re-**
40 **sult or completing the specified conduct, and the substantial step created an actual and ex-**
41 **treme risk of grave or potentially lethal physical injury to another person.**

42 (2)(a) A district attorney may petition the court to initiate commitment proceedings described
43 in this section if there is reason to believe a person is an extremely dangerous person with mental
44 illness. Venue is proper in the county in which the person is alleged to have committed the quali-
45 fying act or the county in which the person lives. The petition shall immediately be served upon the

1 person.

2 (b) If a person is committed to a state hospital under ORS 161.365 or 161.370 and the state
3 hospital intends to discharge the person, the district attorney may provide notice to the super-
4 intendent of the state hospital indicating an intent to file a petition under this section. Upon receipt
5 of the notice, the superintendent may delay discharge of the person for up to seven judicial days to
6 allow for the petition to be filed and for the court to make findings under paragraph (f) of this
7 subsection.

8 (c) The person shall be advised in writing of:

9 (A) The allegation that the person is an extremely dangerous person with mental illness and
10 may be committed to the jurisdiction of the Psychiatric Security Review Board for a maximum pe-
11 riod of 24 months; and

12 (B) The right to a hearing to determine whether the person is an extremely dangerous person
13 with mental illness, unless the person consents to the commitment by waiving the right to a hearing
14 in writing after consultation with legal counsel.

15 (d) A person against whom a petition described in this subsection is filed shall have the follow-
16 ing:

17 (A) The right to obtain suitable legal counsel possessing skills and experience commensurate
18 with the nature of the allegations and complexity of the case and, if the person is without funds to
19 retain legal counsel, the right to have the court appoint legal counsel;

20 (B) The right to subpoena witnesses and to offer evidence on behalf of the person at the hearing;

21 (C) The right to cross-examine any witnesses who appear at the hearing; and

22 (D) The right to examine all reports, documents and information that the court considers, in-
23 cluding the right to examine the reports, documents and information prior to the hearing, if avail-
24 able.

25 (e) Upon receipt of the petition, the court shall schedule a hearing and shall appoint an exam-
26 iner as described in ORS 426.110 to evaluate the person. If the person is in custody or committed
27 while the hearing is pending, the hearing must commence within 30 days of filing the petition unless
28 good cause is found by the court. If the court finds good cause, the hearing must commence no later
29 than 60 days after the filing of the petition or, if the district attorney provided notice under para-
30 graph (b) of this subsection, the date of the notice, whichever occurs first. As used in this paragraph,
31 "good cause" means:

32 (A) The person who would be considered the victim of the act described in subsection (3)(a)(C)
33 of this section if the act were criminally prosecuted, or an essential witness for either the state or
34 the person, is unable to testify within the 30-day period.

35 (B) The attorney for the person cannot reasonably be expected to participate in the hearing
36 within the 30-day period, cannot be adequately prepared to represent the person at the hearing
37 within the 30-day period, or has a schedule conflict that cannot be resolved in a manner that allows
38 the attorney to represent the person at a hearing within the 30-day period.

39 (C) An examiner cannot be appointed to conduct the examination, or conduct the examination
40 and prepare a report, within the 30-day period.

41 (D) If a guardian ad litem is appointed on the case, the guardian ad litem cannot be prepared
42 for a hearing within the 30-day period.

43 (f)(A) The court may order that the person be committed to the custody of the superintendent
44 of a state hospital or the director of a secure mental health facility while the petition is pending if
45 the court finds probable cause that:

- 1 (i) The person is at least 18 years of age;
- 2 (ii) The person has a qualifying mental disorder that is resistant to treatment;
- 3 (iii) The person committed an act described in subsection (3)(a)(C) of this section; and
- 4 (iv) Failure to commit the person while the hearing is pending would pose serious harm or
- 5 danger to the person or others.

6 (B) If a person committed under this paragraph is held in a secure facility other than a state
7 hospital or secure mental health facility, including but not limited to a jail or prison, at the time
8 the petition is filed, the court may further order that the person remain at that placement for suf-
9 ficient time to allow the superintendent or director to safely admit the person. Any order of the
10 court concerning the placement of a person under this subparagraph must be in accordance with the
11 person's constitutional right to due process. If the person remains in a secure facility under this
12 subparagraph, the superintendent, director or designee may consult with the facility to ensure con-
13 tinuity of care for the person.

14 (C) Commitment to the custody of the superintendent of a state hospital or the director of a
15 secure mental health facility under this paragraph may not exceed 60 days. If the hearing does not
16 occur within 60 days, if the district attorney dismisses the petition, or if the court holds the hearing
17 but does not commit the person, the person shall be returned to the county in which the petition
18 was filed and the court shall hold a disposition hearing within five judicial days to determine how
19 to proceed on the petition and any outstanding criminal charges. A person who is returned to a
20 secure facility other than a state hospital or secure mental health facility, including but not limited
21 to a jail or prison, under this paragraph may remain at the placement until the disposition hearing.

22 (g) If the hearing is not commenced within the time period required by paragraph (e) of this
23 subsection, the court shall either dismiss the petition or release the person on personal recogni-
24 zance, to the custody of a third party or upon any additional reasonable terms and conditions the
25 court deems appropriate.

26 (3)(a) At the hearing on the petition, the court shall order the person committed as an extremely
27 dangerous person with mental illness under the jurisdiction of the Psychiatric Security Review
28 Board for a maximum of 24 months if the court finds, by clear and convincing evidence, that:

- 29 (A) The person is extremely dangerous;
- 30 (B) The person suffers from a qualifying mental disorder that is resistant to treatment; and
- 31 (C) Because of the qualifying mental disorder that is resistant to treatment, the person com-
32 mitted one of the following acts:

- 33 (i) Caused **or attempted to cause** the death of another person;
- 34 (ii) Caused **or attempted to cause** serious physical injury to another person by means of a
35 dangerous weapon;
- 36 (iii) Caused **or attempted to cause** physical injury to another person by means of a firearm as
37 defined in ORS 166.210 or an explosive as defined in ORS 164.055;
- 38 (iv) Engaged **or attempted to engage** in oral-genital contact with a child under 14 years of age;
- 39 (v) Forcibly compelled **or attempted to forcibly compel** sexual intercourse, oral-genital contact
40 or the penetration of another person's anus or vagina; or
- 41 (vi) Caused **or attempted to cause** a fire or explosion that damaged, **or was reasonably likely**
42 **to damage**, the protected property of another, as those terms are defined in ORS 164.305, or **that**
43 placed another person in danger of physical injury, and the fire or explosion **or attempted fire or**
44 **explosion** was not the incidental result of normal and usual daily activities.

45 (b) The court shall further commit the person to a state hospital for custody, care and treatment

1 if the court finds, by clear and convincing evidence, that the person cannot be controlled in the
2 community with proper care, medication, supervision and treatment on conditional release.

3 (c) The court shall specify in the order whether any person who would be considered a victim
4 as defined in ORS 131.007 of the act described in paragraph (a)(C) of this subsection, if the act had
5 been criminally prosecuted, requests notification of any order or hearing, conditional release, dis-
6 charge or escape of the person committed under this section.

7 (d) The court shall be fully advised of all drugs and other treatment known to have been ad-
8 ministered to the alleged extremely dangerous person with mental illness that may substantially af-
9 fect the ability of the person to prepare for, or to function effectively at, the hearing.

10 (e) The provisions of ORS 40.230, 40.235, 40.240, 40.250 and 179.505 do not apply to the use of
11 the examiner's report and the court may consider the report as evidence.

12 (4) The findings of the court that a person committed an act described in subsection (3)(a)(C)
13 of this section may not be admitted in a criminal prosecution.

14 (5)(a) If the court commits a person under this section and the person has pending criminal
15 charges at the time of the hearing, the court shall dismiss the criminal charges without prejudice,
16 and if the person is further committed to a state hospital under this section, the dismissal shall not
17 take effect until the person's transportation to the state hospital.

18 (b) If the court commits a person to the state hospital under this section and:

19 (A) The person is in a setting other than a state hospital, the court may additionally order that
20 the person remain in that placement until the person can be safely transported to a state hospital
21 pursuant to the order. Any order of the court concerning the placement of the person under this
22 subparagraph must be in accordance with the person's constitutional right to due process.

23 (B) The person is at a state hospital at the time of the hearing, the person may remain at the
24 state hospital under the commitment.

25 (c) A person committed under this section shall remain under the jurisdiction of the board for
26 a maximum of 24 months unless the board conducts a hearing and makes the findings described in
27 subsection (6)(d) of this section.

28 (6)(a) The board shall hold a hearing six months after the initial commitment described in sub-
29 section (3) of this section, and thereafter six months after a further commitment described in ORS
30 426.702, to determine the placement of the person and whether the person is eligible for conditional
31 release or early discharge. The board shall provide written notice of the hearing to the person, the
32 person's legal counsel and the office of the district attorney who filed the initial petition under
33 subsection (2) of this section within a reasonable time prior to the hearing. The board shall further
34 notify the person of the following:

35 (A) The nature of the hearing and possible outcomes;

36 (B) The right to appear at the hearing and present evidence;

37 (C) The right to be represented by legal counsel and, if the person is without funds to retain
38 legal counsel, the right to have the court appoint legal counsel;

39 (D) The right to subpoena witnesses;

40 (E) The right to cross-examine witnesses who appear at the hearing; and

41 (F) The right to examine all reports, documents and information that the board considers, in-
42 cluding the right to examine the reports, documents and information prior to the hearing if avail-
43 able.

44 (b) If the board determines at the hearing that the person still suffers from a qualifying mental
45 disorder that is resistant to treatment and continues to be extremely dangerous, and that the person

1 cannot be controlled in the community with proper care, medication, supervision and treatment if
2 conditionally released, the person shall remain committed to a state hospital.

3 (c) If the board determines at the hearing that the person still suffers from a qualifying mental
4 disorder that is resistant to treatment and continues to be extremely dangerous, but finds that the
5 person can be controlled in the community with proper care, medication, supervision and treatment
6 if conditionally released, the board shall conditionally release the person.

7 (d) If the board determines at the hearing that the person no longer suffers from a qualifying
8 mental disorder that is resistant to treatment or is no longer extremely dangerous, the board shall
9 discharge the person. The discharge of a person committed under this section does not preclude
10 commitment of the person pursuant to ORS 426.005 to 426.390.

11 (7)(a) At any time during the commitment to a state hospital, the superintendent of the state
12 hospital may request a hearing to determine the status of the person's commitment under the juris-
13 diction of the board. The request shall be accompanied by a report setting forth the facts supporting
14 the request. If the request is for conditional release, the request shall be accompanied by a verified
15 conditional release plan. The hearing shall be conducted as described in subsection (6) of this sec-
16 tion.

17 (b) The board may make the findings described in subsection (6)(c) of this section and condi-
18 tionally release the person without a hearing if the office of the district attorney who filed the ini-
19 tial petition under subsection (2) of this section does not object to the conditional release.

20 (c) At any time during conditional release, a state or local mental health facility providing
21 treatment to the person may request a hearing to determine the status of the person's commitment
22 under the jurisdiction of the board. The hearing shall be conducted as described in subsection (6)
23 of this section.

24 (8)(a) If the board orders the conditional release of a person under subsection (6)(c) of this sec-
25 tion, the board shall order conditions of release that may include a requirement to report to any
26 state or local mental health facility for evaluation. The board may further require cooperation with,
27 and acceptance of, psychiatric or psychological treatment from the facility. Conditions of release
28 may be modified by the board from time to time.

29 (b) When a person is referred to a state or local mental health facility for an evaluation under
30 this subsection, the facility shall perform the evaluation and submit a written report of its findings
31 to the board. If the facility finds that treatment of the person is appropriate, the facility shall in-
32 clude its recommendations for treatment in the report to the board.

33 (c) Whenever treatment is provided to the person by a state or local mental health facility under
34 this subsection, the facility shall furnish reports to the board on a regular basis concerning the
35 progress of the person.

36 (d) Copies of all reports submitted to the board pursuant to this subsection shall be furnished
37 to the person and to the person's legal counsel, if applicable. The confidentiality of these reports is
38 determined pursuant to ORS 192.338, 192.345 and 192.355.

39 (e) The state or local mental health facility providing treatment to the person under this sub-
40 section shall comply with the conditional release order and any modifications of the conditions or-
41 dered by the board.

42 (9)(a) If at any time while the person is conditionally released it appears that the person has
43 violated the terms of the conditional release, the board may order the person returned to a state
44 hospital for evaluation or treatment. A written order of the board is sufficient warrant for any law
45 enforcement officer to take the person into custody. A sheriff, municipal police officer, parole or

1 probation officer or other peace officer shall execute the order, and the person shall be returned to
2 the state hospital as soon as practicable.

3 (b) The director of a state or local mental health facility providing treatment to a person under
4 subsection (8) of this section may request that the board issue a written order for a person on con-
5 ditional release to be taken into custody if there is reason to believe that the person can no longer
6 be controlled in the community with proper care, medication, supervision and treatment.

7 (c) Within 30 days following the return of the person to a state hospital, the board shall conduct
8 a hearing to determine if, by a preponderance of the evidence, the person is no longer fit for con-
9 ditional release. The board shall provide written notice of the hearing to the person, the person's
10 legal counsel and the office of the district attorney who filed the initial petition under subsection
11 (2) of this section within a reasonable time prior to the hearing. The notice shall advise the person
12 of the nature of the hearing, the right to have the court appoint legal counsel and the right to
13 subpoena witnesses, examine documents considered by the board and cross-examine all witnesses
14 who appear at the hearing.

15 (10)(a) If the person had unadjudicated criminal charges at the time of the filing of the petition
16 for the person's initial commitment under this section and the state hospital or the state or local
17 mental health facility providing treatment to the person intends to recommend discharge of the
18 person at an upcoming hearing, the superintendent of the state hospital or the director of the fa-
19 cility shall provide written notice to the board and the district attorney of the county where the
20 criminal charges were initiated of the discharge recommendation at least 45 days before the hearing.
21 The notice shall be accompanied by a report describing the person's diagnosis and the treatment the
22 person has received.

23 (b) Upon receiving the notice described in this subsection, the district attorney may request an
24 order from the court in the county where the criminal charges were initiated for an evaluation to
25 determine if the person is fit to proceed in the criminal proceeding. The court may order the state
26 hospital or the state or local mental health facility providing treatment to the person to perform the
27 evaluation. The hospital or facility shall provide copies of the evaluation to the district attorney,
28 the person and the person's legal counsel, if applicable.

29 (c) The person committed under this section may not waive an evaluation ordered by the court
30 to determine if the person is fit to proceed with the criminal proceeding as described in this sub-
31 section.

32 (11) The board shall make reasonable efforts to notify any person described in subsection (3)(c)
33 of this section of any order or hearing, conditional release, discharge or escape of the person com-
34 mitted under this section.

35 (12) Unless the court orders otherwise or either party objects, any party or witness may attend
36 a hearing held under this section via simultaneous electronic transmission.

37 (13) The board shall adopt rules to carry out the provisions of this section and ORS 426.702.

38 (14) Any time limitation described in ORS 131.125 to 131.155 does not run during a commitment
39 described in this section or a further commitment described in ORS 426.702.

43 **SECTION 38. (1)(a) The Judicial Department shall study tribal and state interactions re-**
44 **lating to the involuntary hospitalization and mental or behavioral health treatment of tribal**
45 **members in the state civil or criminal justice systems.**

1 (b) The department shall collect the following existing data:

2 (A) Data related to civil commitment proceedings involving members of one or more
3 federally recognized tribes;

4 (B) Data related to competency proceedings for criminal defendants who are members
5 of one or more federally recognized tribes;

6 (C) Data related to findings of guilt except for insanity for criminal defendants who are
7 members of one or more federally recognized tribes;

8 (D) Data related to the participation of members of one or more federally recognized
9 tribes in specialty courts, including regarding culturally specific services provided or avail-
10 able to those members in relation to their participation in the specialty court; and

11 (E) Other data determined by the department to be relevant to the intersection between
12 state and tribal mental and behavioral health judicial proceedings.

13 (c)(A) The department shall prepare a report analyzing the data collected under this
14 subsection. The department shall include in the report a descriptive analysis of the barriers,
15 if any, the department encounters collecting or analyzing the data described in this sub-
16 section.

17 (B) Data contained in the report must be aggregated at the statewide, countywide and
18 tribal level for each subject identified in subsection (1) of this section.

19 (C) The report may not include personally identifiable information regarding any indi-
20 vidual.

21 (2)(a) The Oregon Health Authority shall assist the department in the collection of the
22 data described in subsection (1) of this section and, to the extent permitted by state and
23 federal law, provide the department with information the department considers necessary to
24 conduct the study described in subsection (1) of this section.

25 (b) Information and data collected by the department or the authority under this section
26 may be used only for statistical purposes.

27 (3) The department shall submit the report described in subsection (1) of this section in
28 the manner provided by ORS 192.245, and may include recommendations for legislation, to
29 the interim committees of the Legislative Assembly related to the judiciary and behavioral
30 health no later than December 15, 2025.

31 **SECTION 39.** (1) The Task Force on the Intersection of Tribal and State Forensic Be-
32 havioral Health is established.

33 (2) The task force consists of 17 members appointed as follows:

34 (a) The Governor shall appoint four members, as follows:

35 (A) One member who represents the office of the Governor;

36 (B) One member who represents the Oregon Health Authority;

37 (C) One member who represents the Department of Justice; and

38 (D) One member who represents community mental health providers.

39 (b) The Governor, in consultation with the Commission on Indian Services, shall appoint
40 11 members, as follows:

41 (A) Nine members who are tribal court judges or staff or other individuals designated by
42 an Indian tribe, and who shall each represent one of the nine federally recognized Indian
43 tribes located in Oregon; and

44 (B) Two members who represent tribal service providers.

45 (c) The Chief Justice of the Supreme Court shall appoint two members, as follows:

- 1 (A) One member who is a judge with expertise in the competency to proceed process; and
- 2 (B) One member who is a representative of the Tribal, State, and Federal Court Forum.
- 3 (3) The task force shall examine tribal and state interactions relating to involuntary
- 4 hospitalization and mental or behavioral health treatment of tribal members in the state civil
- 5 and criminal systems and:
 - 6 (a) Identify data sharing needs between tribal service providers, tribal courts and non-
 - 7 tribal service providers, the Oregon Health Authority and Oregon courts, and identify
 - 8 methods for resolving barriers to data sharing;
 - 9 (b) Examine mental and behavioral health care services provided within tribal lands and
 - 10 to tribal members and identify barriers to providing care to tribal individuals;
 - 11 (c) Determine barriers to tribal members receiving care at the Oregon State Hospital
 - 12 pursuant to competency restoration orders or civil commitment;
 - 13 (d) Examine models for tribal and state interactions relating to mental or behavioral
 - 14 health;
 - 15 (e) Examine the results of the study described in section 38 of this 2025 Act; and
 - 16 (f) Develop recommendations concerning tribal court needs that intersect with state
 - 17 services and barriers to services.
- 18 (4) The task force shall invite and consider perspectives involving forensic or mental
- 19 health matters before tribal courts, including prosecutors, defenders, people with lived ex-
- 20 perience, family members of persons with unmet behavioral needs and members of tribal
- 21 governments.
- 22 (5) Members of the task force who are appointed by the Chief Justice of the Supreme
- 23 Court are nonvoting members and may act in an advisory capacity only.
- 24 (6) Members of the task force who are tribal court judges or staff appointed under sub-
- 25 section (2)(b)(A) of this section shall act as liaisons between the task force and the tribal
- 26 government of the tribal court on which the member serves if the tribal government desig-
- 27 nates the member to act as a liaison and, if so designated, the member shall coordinate with
- 28 a person designated by the relevant tribal government, if any, to facilitate inviting and con-
- 29 sidering the perspectives of tribal members and to consult with the tribal government on the
- 30 activities of the task force.
- 31 (7) A majority of the voting members of the task force constitutes a quorum for the
- 32 transaction of business.
- 33 (8) Official action by the task force requires the approval of a majority of the voting
- 34 members of the task force.
- 35 (9) The Governor shall select one member of the task force to serve as chairperson and
- 36 another to serve as vice chairperson, for the terms and with the duties and powers necessary
- 37 for the performance of the functions of the offices as the Governor determines.
- 38 (10) If there is a vacancy for any cause, the appointing authority shall make an appoint-
- 39 ment to become immediately effective.
- 40 (11) The task force shall meet at times and places specified by the call of the chairperson
- 41 or of a majority of the voting members of the task force.
- 42 (12) The task force may adopt rules necessary for the operation of the task force.
- 43 (13) The task force shall submit a report in the manner provided in ORS 192.245 regarding
- 44 the task force's examinations, identifications, determinations and recommendations de-
- 45 scribed in subsection (3) of this section, and may include recommendations for legislation,

1 to the interim committees of the Legislative Assembly related to the judiciary and behavioral
2 health no later than December 15, 2026.

3 (14) The Judicial Department shall provide staff support to the task force.

4 (15) Members of the task force serve as volunteers on the task force and, unless they
5 are qualified members, as defined in ORS 292.495, are not entitled to compensation or re-
6 imbursement for expenses.

7 (16) All agencies of state government, as defined in ORS 174.111, are directed to assist
8 the task force in the performance of the duties of the task force and, to the extent permitted
9 by laws relating to confidentiality, to furnish information and advice the members of the task
10 force consider necessary to perform their duties.

11 (17) All appointments to the task force made under subsection (2) of this section must
12 be completed on or before December 31, 2025.

13 (18) The task force shall have its first meeting on or before February 1, 2026.

14 **SECTION 40.** Sections 38 and 39 of this 2025 Act are repealed on January 2, 2027.

36 (L) Fair Dismissal Appeals Board.

37 (m) Governor.

38 (n) Land Conservation and Development Commission.

39 (o) Land Use Board of Appeals.

40 (p) Local government boundary commissions created pursuant to ORS 199.430.

41 (q) Public universities listed in ORS 352.002.

42 (r) Oregon Youth Authority.

43 (s) Psychiatric Security Review Board.

44 (t) **Oregon Health Authority, for purposes of contested case hearings involving informed**
45 **consent at the Oregon State Hospital.**

1 [(t)] (u) Public Utility Commission.

2 [(u)] (v) State Accident Insurance Fund Corporation.

3 [(v)] (w) State Apprenticeship and Training Council.

4 [(w)] (x) State Board of Parole and Post-Prison Supervision.

5 [(x)] (y) State Land Board.

6 [(y)] (z) State Treasurer, except the State Treasurer shall use an administrative law judge for
7 contested cases involving claims arising under ORS 98.302 to 98.436, 98.992 or 116.253 or any other
8 claim to escheated or unclaimed property.

9 (3) The Workers' Compensation Board is exempt from using administrative law judges assigned
10 from the office for any hearing conducted by the board under ORS chapters 147, 654 and 656. Except
11 as specifically provided in this subsection, the Department of Consumer and Business Services must
12 use administrative law judges assigned from the office only for contested cases arising out of the
13 department's powers and duties under:

14 (a) ORS 86A.095 to 86A.198, 86A.990 and 86A.992 and ORS chapter 59;

15 (b) ORS chapter 455;

16 (c) ORS chapter 674;

17 (d) ORS chapters 706 to 716;

18 (e) ORS chapter 717;

19 (f) ORS chapters 723, 725 and 726; and

20 (g) ORS chapters 731, 732, 733, 734, 735, 737, 742, 743, 743A, 743B, 744, 746, 748 and 750.

21 (4) Notwithstanding any other provision of law, in any proceeding in which an agency is re-
22 quired to use an administrative law judge assigned from the office, an officer or employee of the
23 agency may not conduct the hearing on behalf of the agency.

24 (5) Notwithstanding any other provision of ORS 183.605 to 183.690, an agency is not required to
25 use an administrative law judge assigned from the office if:

26 (a) Federal law requires that a different administrative law judge or hearing officer be used; or

27 (b) Use of an administrative law judge from the office could result in a loss of federal funds.

28 (6) Notwithstanding any other provision of this section, the Department of Environmental
29 Quality must use administrative law judges assigned from the office only for contested case hearings
30 conducted under the provisions of ORS 183.413 to 183.470.

31 **SECTION 42. The amendments to ORS 183.635 by section 41 of this 2025 Act apply to**
32 **contested case hearings occurring on or after the effective date of this 2025 Act.**

37 **SECTION 43. Sections 44 to 46 of this 2025 Act are added to and made a part of ORS**
38 **161.355 to 161.371.**

39 **SECTION 44. (1) As used in this section and section 45 of this 2025 Act:**

40 (a) "Authority" means the Oregon Health Authority.

41 (b) "Contempt charge" means a contempt charge alleging the violation of a court order
42 issued under ORS 30.866, 107.700 to 107.735, 124.005 to 124.040, 133.035, 163.730 to 163.750,
43 163.760 to 163.777 or 166.525 to 166.543.

44 (c) "Person Class A misdemeanor" has the meaning given that term in the rules of the
45 Oregon Criminal Justice Commission.

1 (d) "Violent felony" means a felony offense in which there was an actual or threatened
2 serious physical injury to the victim, or a felony sexual offense.

3 (2) When the court has determined that a defendant lacks fitness to proceed under ORS
4 161.370 (2), the provisions of this section and section 45 of this 2025 Act apply
5 notwithstanding any provision to the contrary in ORS 161.370 and 161.371.

6 (3) Notwithstanding ORS 161.370 (4) and 161.371 (8)(a):

7 (a) If the most serious offense in the charging instrument is a violation or a
8 misdemeanor other than a person Class A misdemeanor, the court may not commit the de-
9 fendant to the custody of the superintendent of a state mental hospital or director of a fa-
10 cility designated by the authority if the defendant is at least 18 years of age, or to the
11 custody of the director of a secure intensive community inpatient facility designated by the
12 authority if the defendant is under 18 years of age, under any circumstances.

13 (b) If the most serious offense in the charging instrument is a person Class A
14 misdemeanor or a contempt charge, the maximum time period that the defendant may be
15 committed to the custody of the superintendent of a state mental hospital or director of a
16 facility designated by the authority if the defendant is at least 18 years of age, or to the
17 custody of the director of a secure intensive community inpatient facility designated by the
18 authority if the defendant is under 18 years of age, is 90 days. The time period may be ex-
19 tended by the court as described in subsection (5) of this section by an additional 90 days,
20 up to a total of 180 days.

21 (c) If the most serious offense in the charging instrument is a felony other than aggra-
22 vated murder, a violent felony or a crime listed in ORS 137.700 (2), the maximum time period
23 that the defendant may be committed to the custody of the superintendent of a state mental
24 hospital or director of a facility designated by the authority if the defendant is at least 18
25 years of age, or to the custody of the director of a secure intensive community inpatient
26 facility designated by the authority if the defendant is under 18 years of age, is six months.
27 The time period may be extended by the court as described in subsection (5) of this section
28 by an additional six months, up to a total of 12 months.

29 (d) If the most serious offense in the charging instrument is aggravated murder, a vio-
30 lent felony or a crime listed in ORS 137.700 (2), the maximum time period that the defendant
31 may be committed to the custody of the superintendent of a state mental hospital or director
32 of a facility designated by the authority if the defendant is at least 18 years of age, or to the
33 custody of the director of a secure intensive community inpatient facility designated by the
34 authority if the defendant is under 18 years of age, is 12 months. The time period may be
35 extended by the court as described in subsection (5) of this section by an additional six
36 months, up to a total of 18 months.

37 (4)(a) The superintendent of the state mental hospital or director of another facility to
38 which a defendant is committed shall provide notice to the court and the parties that the
39 defendant is reaching the end of the initial maximum period of commitment described in
40 subsection (3)(b) to (d) of this section at least 60 days before the end of the period.

41 (b) Upon the receipt by the court of a petition or other request for an extension of a
42 maximum period of commitment under subsections (5) to (9) of this section, the defendant
43 shall remain committed at the state mental hospital or other facility pending a decision on
44 the request.

45 (c) Upon reaching a decision on a request for an extension of a maximum commitment

1 period under subsections (5) to (9) of this section, the court shall prepare a written order,
2 and shall include in the order the reasons for granting or denying the request.

3 (5)(a) The court may extend the initial maximum period of commitment, up to the total
4 amounts specified in subsection (3)(b) to (d) of this section, upon the request of a party as
5 provided in this subsection.

6 (b) Upon receipt of the notice described in subsection (4)(a) of this section, a party may
7 petition for an extension to the initial maximum period of commitment. If the most serious
8 offense in the charging instrument is a felony, the petition must be filed within 30 days of
9 receipt of the notice. If the most serious offense in the charging instrument is a
10 misdemeanor, the petition must be filed no later than five days prior to the end of the initial
11 maximum period of commitment.

12 (c) Notwithstanding paragraph (b) of this subsection, if the most serious offense in the
13 charging instrument is a misdemeanor and the evaluation and notice required under ORS
14 161.371 (1) is submitted to the court within five days before the expiration of the initial
15 maximum commitment period, the commitment of the defendant is automatically extended
16 by five days to allow for the filing of a petition under this subsection.

17 (d) The court may grant the petition and extend the initial maximum commitment period,
18 up to the total amounts specified in subsection (3)(b) to (d) of this section, if the court finds:

19 (A) The person continues to meet the requirements for commitment under ORS 161.370
20 (3)(a) or (4)(a), as applicable; and

21 (B) There is a substantial probability that continued commitment will lead to a determi-
22 nation that the defendant has gained or regained fitness to proceed within the extension time
23 period.

24 (e) When making the determinations described in paragraph (d) of this subsection, the
25 court shall consider:

26 (A) Clinical data of the defendant's progress toward gaining or regaining fitness to pro-
27 ceed;

28 (B) Evidence that the defendant's lack of fitness is not due to a condition that is unlikely
29 to result in the defendant gaining or regaining fitness to proceed, such as a significant
30 neurocognitive disorder or a significant neurodevelopmental disability disorder;

31 (C) Evidence regarding the outcome of prior efforts at restoring the defendant's fitness
32 to proceed; and

33 (D) Any other relevant information the court decides to consider.

34 (f) If the court grants the petition and:

35 (A) The most serious offense in the charging instrument is a felony, the superintendent
36 or director must receive any order extending the commitment under this subsection prior
37 to the expiration of the initial maximum commitment period described in subsection (3) of
38 this section or, if the report required by ORS 161.371 (2)(a) is submitted to the court fewer
39 than 10 days prior to the expiration of the initial maximum commitment period, no later than
40 10 days after the receipt of the report.

41 (B) The most serious offense in the charging instrument is a misdemeanor, the super-
42 intendent or director must receive any order extending the commitment under this sub-
43 section prior to the expiration of the initial maximum commitment period described in
44 subsection (3) of this section or, if the evaluation and notice required under ORS 161.371 (1)
45 is submitted to the court fewer than five days prior to the expiration of the initial maximum

1 commitment period, no later than five days after the petition for the extension is filed.

2 (6)(a) The court may extend the period of commitment by up to 30 days for the purposes
3 of discharge planning and coordination, as provided in this subsection.

4 (b) The superintendent of the state mental hospital, the director of the facility to which
5 the defendant is committed, or the designee of the superintendent or director, shall provide
6 notice to the court and to the parties if the defendant cannot be placed immediately in an
7 identified placement after a referral has been submitted, but there is a reasonable expecta-
8 tion that the placement will be secured within 30 days.

9 (c) Prior to the end of the commitment period, either party, or the court on its own
10 motion, may request an extension of the period of commitment of up to 30 days. Either party
11 may object to the extension.

12 (d) The court may grant the request for an extension if the court determines that the
13 defendant cannot be placed immediately in an identified placement after a referral has been
14 submitted, but there is a reasonable expectation that the placement will be secured within
15 30 days.

16 (e) The failure of the community mental health program director to coordinate discharge
17 planning does not constitute justification for granting a request for an extension under this
18 subsection.

19 (f) An order granting a request for an extension under this subsection must be received
20 by the superintendent of the state mental hospital, or the director of the facility to which
21 the defendant is committed, at least five days prior to the expiration of the applicable max-
22 imum period of commitment described in subsection (3) of this section and any extensions
23 previously authorized, or within five days of the request for an extension under this sub-
24 section, if fewer than five days remained in the maximum commitment and extension period
25 when the request was submitted.

26 (g) An extension of commitment under this subsection is independent of and may be au-
27 thorized in addition to any other extension authorized under this section, but when combined
28 with other extensions the total period of commitment may not exceed the time period de-
29 scribed in subsection (10)(d) of this section.

30 (7)(a) Notwithstanding subsection (3) of this section, any maximum periods of commit-
31 ment described in subsection (3)(b) to (d) of this section may be extended when there is evi-
32 dence that the defendant is engaging in malingering or impression management as provided
33 in this subsection.

34 (b) Upon receipt of the notice described in subsection (4)(a) of this section, the district
35 attorney may petition for an extension to the maximum period of commitment. The petition
36 must be submitted within 30 days of receipt of the notice.

37 (c) The court may grant the petition if the court finds that an evaluation prepared by a
38 certified evaluator states that there is evidence that the defendant is engaging in
39 malingering or impression management and the evaluator has determined that additional
40 time is necessary to resolve the defendant's clinical picture for restoration.

41 (d) If the court grants the petition:

42 (A) The superintendent or director must receive any order extending the commitment
43 under this subsection prior to the expiration of the applicable maximum commitment and
44 extension period.

45 (B) The court shall conduct a review hearing on the status of the defendant's fitness to

1 proceed at least every 180 days in accordance with ORS 161.371. At each review hearing, the
2 court may continue the commitment for an additional 180 days if the court makes the
3 findings described in paragraph (c) of this subsection, but under no circumstances may the
4 total commitment period, including any other extension authorized under this section, exceed
5 the time period described subsection (10)(d) of this section.

6 (8)(a) Notwithstanding subsection (3) of this section, if the most serious charge in the
7 charging instrument is aggravated murder, a violent felony or a crime listed in ORS 137.700
8 (2), any maximum period of commitment described in subsection (3)(d) of this section may
9 be extended as provided in this subsection.

10 (b) Upon receipt of the notice described in subsection (4)(a) of this section, the district
11 attorney may petition for an extension to the maximum period of commitment. The petition
12 must be submitted within 30 days of receipt of the notice.

13 (c) The court may grant the petition if the court determines:

14 (A) By clear and convincing evidence, that there is a danger of physical injury or sexual
15 victimization to the victim or a member of the public if the defendant is discharged from the
16 hospital or other facility;

17 (B) The defendant meets the requirements for commitment described in ORS 161.370
18 (3)(a); and

19 (C) There is a substantial probability that continued commitment will lead to a determi-
20 nation that the defendant has gained or regained fitness to proceed within the 180-day ex-
21 tension.

22 (d) When making the determinations described in paragraph (c) of this subsection, the
23 court shall consider:

24 (A) Clinical data of the defendant's progress toward gaining or regaining fitness to pro-
25 ceed;

26 (B) Evidence that the defendant's lack of fitness is not due to a condition that is unlikely
27 to result in the defendant gaining or regaining fitness to proceed, such as a significant
28 neurocognitive disorder or a significant neurodevelopmental disability disorder;

29 (C) Evidence regarding the outcome of prior efforts at restoring the defendant's fitness
30 to proceed; and

31 (D) Any other relevant information the court decides to consider.

32 (e) If the court grants the petition:

33 (A) The superintendent or director must receive any order extending the commitment
34 under this subsection prior to the expiration of the applicable maximum commitment period
35 described in subsection (3) of this section and any extensions previously authorized.

36 (B) The court shall conduct a review hearing on the status of the defendant's fitness to
37 proceed at least every 180 days in accordance with ORS 161.371. At each review hearing, the
38 court may continue the commitment for an additional 180 days if the court makes the de-
39 terminations described in paragraph (d) of this subsection, but under no circumstances may
40 the total commitment period, including any other extension authorized under this section,
41 exceed 36 months.

42 (9)(a) Upon receipt of a report filed under ORS 161.372 (1) concerning the involuntary
43 administration of medication to the defendant, the district attorney may file a petition re-
44 questing an extension to any maximum periods of commitment described in subsection (3)(b)
45 to (d) of this section as provided in this section.

1 (b) If the report filed under ORS 161.372 (1) is received within 10 days prior to the end
2 of a maximum commitment period described in subsection (3)(b) to (d) of this section, the
3 district attorney may file the petition within 10 days after receipt of the report, and the
4 commitment of the defendant shall continue until the end of the 10-day time period.

5 (c) Upon receipt of a petition described in paragraph (a) of this subsection, the court shall
6 hold a hearing. If the court orders the involuntary administration of medication under ORS

12 (e) An extension of commitment under this subsection is independent of and may be au-
13 thorized in addition to any other extension authorized under this section, but when combined
14 with other extensions the total period of commitment may not exceed the time limits de-
15 scribed in subsection (10)(d) of this section.

16 (10) Notwithstanding ORS 161.371 (8):

17 (a) The maximum periods for commitment described in this section shall be calculated
18 beginning on the initial day of commitment.

19 (b) The defendant may not receive credit toward the maximum period of commitment for
20 any day the defendant is held in jail before or after the initial date of commitment.

21 (c) The defendant shall be given credit toward the maximum period of commitment for
22 any day the defendant is committed to a state mental hospital or other secure residential

24 (d) Under no circumstances may the total commitment period, including any extensions

37 other than a person Class A misdemeanor, the maximum time period that the defendant may
38 be ordered to engage in community restoration services is 90 days. The time period may be
39 extended by the court as described in subsection (3) of this section by additional increments
40 of 90 days, to up to a total of 365 days.

41 (c) If the most serious offense in the charging instrument is a person Class A
42 misdemeanor or a contempt charge, the maximum time period that the defendant may be
43 ordered to engage in community restoration services is six months. The time period may be
44 extended by the court as described in subsection (3) of this section by additional increments
45 of six months, to up to a total of 18 months.

1 (d) If the most serious offense in the charging instrument is a felony other than aggra-
2 vated murder, a violent felony or a crime listed in ORS 137.700 (2), the maximum time period
3 that the defendant may be ordered to engage in community restoration services is 12
4 months. The time period may be extended by the court as described in subsection (3) of this
5 section by additional increments of six months, to up to a total of 24 months.

6 (e) If the most serious offense in the charging instrument is aggravated murder, a vio-
7 lent felony or a crime listed in ORS 137.700 (2), the maximum time period that the defendant
8 may be ordered to engage in community restoration services is 18 months. The time period
9 may be extended by the court as described in subsection (3) of this section by additional in-
10 crements of six months, to up to a total of 24 months.

11 (3)(a) The court may extend the maximum time periods of community restoration ser-
12 vices, up to the total amounts specified in subsection (2) this section, upon the request of a
13 party as provided in this subsection.

14 (b) A party may petition for an extension to the maximum period of community resto-
15 ration described in subsection (2) of this section. The petition must be submitted at least five
16 days prior to the expiration of the maximum period of community restoration. The court
17 may extend the deadline for filing a petition for good cause.

18 (c) Upon receipt of a petition described in paragraph (b) of this subsection, the court shall
19 hold a hearing. The hearing must occur within 30 days after the filing of the petition.

20 (d) The court may extend the community restoration period if the court finds:

21 (A) There is clear evidence of progress toward the defendant gaining or regaining fitness
22 to proceed; and

23 (B) That appropriate services are being made available to the defendant.

24 (e) The petitioning party has the burden of proof.

25 (f) The court may continue the order for the defendant to participate in community
26 restoration services pending the outcome of the petition.

27 (4) The following time periods may not be considered when calculating the maximum
28 period of community restoration services under subsection (2) of this section:

29 (a) A period of time between a scheduled court appearance at which the defendant fails
30 to appear and the next scheduled court appearance at which the defendant appears, other
31 than an appearance that occurs for the purpose of addressing the failure to appear;

32 (b) A period of time between a scheduled fitness to proceed evaluation at which the de-
33 fendant fails to appear and the next scheduled court appearance at which the defendant ap-
34 pears;

35 (c) A period of time during which the defendant is in violation of a release agreement
36 condition that the court finds negatively impacts the defendant's ability to participate or
37 engage in community restoration services, as determined by the court;

38 (d) A period of time during which the defendant is in the custody of a local or state
39 correctional facility;

40 (e) A period of time during which the defendant fails to make reasonable efforts toward
41 gaining or regaining fitness to proceed, as determined by the court;

42 (f) A period of time during which the defendant is not attending or complying with com-
43 munity restoration services treatment, and any nonattendance is not excused, as determined
44 by the court;

45 (g) A period of time during which the defendant is noncompliant with taking or receiving,

1 or verbally refuses to take or receive, prescribed medications, as determined by the court;
2 and

3 (h) A period of time between the defendant's absconion from a secure residential treat-
4 ment facility or other secure placement and the next scheduled court appearance at which
5 the defendant appears.

6 (5) When a defendant has been ordered to engage in community restoration services:

7 (a) The court shall conduct regular status reviews at least every 45 days. The status re-
8 view may consist of the court reviewing a report to the court by the community mental
9 health program director concerning the defendant's progress. Any report provided to the
10 court for a status review must include information concerning whether the defendant is
11 making progress toward gaining or regaining fitness to proceed, what services that are being
12 provided to the defendant and the identification of any additional services that are required
13 to meet the defendant's restoration needs.

14 (b) The court shall conduct a review hearing at least every 180 days, or every 90 days if
15 the most serious offense in the charging instrument is a violation, a Class B or Class C
16 misdemeanor or a Class A misdemeanor other than a person Class A misdemeanor. At the
17 review hearing, the court shall determine whether the purpose of community restoration is
18 being met, and the court may take any action authorized under ORS 161.370 (2)(c) at the
19 hearing.

20 (c) The defendant shall be evaluated to determine whether the defendant has gained or
21 regained fitness to proceed at least every 180 days.

22 (d) If the most serious offense in the charging instrument is a violation, a Class B or
23 Class C misdemeanor or a Class A misdemeanor other than a person Class A misdemeanor,
24 the court shall order that an updated evaluation, to determine whether the defendant has

26 to the review hearing occurring 90 days after the order to engage in community restoration

28 (e) A community restoration services provider shall immediately notify the court follow-

19 **SECTION 49.** Section 50 of this 2025 Act is added to and made a part of ORS 161.355 to
20 161.371.

21 **SECTION 50.** (1) When the defendant's fitness to proceed is drawn in question, the issue
22 shall be determined by the court. In making the determination, the court may consider:

23 (a) An examination ordered under ORS 161.365 (1)(c);

24 (b) Evidence of a prior diagnosis of the defendant made by a certified evaluator or a
25 qualified mental health practitioner;

26 (c) A prior examination or evaluation of the defendant conducted under ORS 161.309,
27 161.315, 161.365, 161.370 or 161.371;

28 (d) Prior judicial determinations that the defendant lacked fitness to proceed;

29 (e) Prior commitments of the defendant under ORS 427.235 to 427.292 or ORS chapter 426;

30 (f) The defendant's conduct as observed by the court;

31 (g) Prior court records or assessments relating to actions involving the defendant that
32 contain a mental health diagnosis of the defendant;

33 (h) Relevant information on the defendant's mental health diagnosis in the possession
34 of the local supervisory authority, if the defendant is under active supervision; and

35 (i) Any other information the court deems relevant.

36 (2)(a) The court may hear a motion to find that the defendant is fit to proceed or lacks
37 fitness to proceed from either party. The motion may be made orally or in writing.

38 (b) If a motion under this subsection is uncontested, the court may make the determi-
39 nation of fitness based on the motion and any supporting evidence. If the motion is con-
40 tested, the moving party shall file a written motion and supporting evidence with the court,
41 if a written motion has not already been filed.

42 (3)(a) The court shall hold a hearing on a contested motion as soon as practicable and in
43 accordance with this subsection. If either party requests, or upon the court's own motion,
44 the court shall hold a status conference to determine when the contested motion hearing
45 will occur and take up any preliminary matters, including whether to order an examination

1 under ORS 161.365 or to allow additional time for either party to seek an examination or
2 evaluation, or to make any other orders as necessary to ensure expedient resolution of the
3 motion.

4 (b) When determining when to schedule a contested motion hearing for the purpose of

14 (4) At the hearing:

15 (a) The moving party has the burden of proving that the defendant is fit to proceed or
16 lacks fitness to proceed, as applicable, by a preponderance of the evidence.

17 (b) Either party may call and cross-examine witnesses. Unless the court orders otherwise
18 or either party objects, any party or witness may appear at the hearing by simultaneous
19 electronic transmission at the hearing.

20 (c) ORS 40.450 to 40.475, 40.505, 40.510 and 40.515 do not apply to the following evidence,
21 if offered for the purpose of establishing a prior diagnosis:

22 (A) A report from an examination or evaluation of the defendant filed with the court
23 under ORS 161.365, 161.370 or 161.371 for the same defendant from the preceding five years;
24 or

25 (B) Records from a civil commitment proceeding under ORS 427.235 to 427.292 or ORS
26 chapter 426 concerning the defendant from the preceding five years.

27 (5) Notwithstanding ORS 161.362 and 426.160, the court may enter an order allowing ei-
28 ther party to access or use one or more reports from examinations or evaluations of the
29 defendant filed with the court under ORS 161.365, 161.370 or 161.371 in any case concerning
30 the defendant from the preceding five years, or records from a civil commitment proceeding
31 under ORS 427.235 to 427.292 or ORS chapter 426 concerning the defendant from the preced-
32 ing five years. Records disclosed under this subsection may only be used for the determi-
33 nation of fitness to proceed.

34 (6) After the hearing described in this subsection, the court may enter a finding that the
35 defendant is fit to proceed or lacks fitness to proceed, or may request additional information
36 to aid in its determination.

37 (7) If the court determines that the defendant lacks fitness to proceed, and the court did
38 not receive an examination or evaluation from a certified evaluator for the proceeding before
39 the court, there is a presumption that there is a substantial probability that the defendant
40 may gain or regain fitness to proceed in the foreseeable future.

41 (8) The failure to contest any issue relating to a fitness to proceed determination under
42 this section does not preclude either party from contesting the same issue at a later time.

42 (e) If the court determines that the appropriate action in the case is an order for the defendant
 43 to engage in community restoration services, but the defendant has a pending criminal case, warrant
 44 or hold in one or more other jurisdictions, the other jurisdictions shall, within two judicial days of
 45 becoming aware of the proceeding under this section, communicate with the court and the other

1 jurisdictions, if applicable, to develop a plan to address the interests of all jurisdictions in the de-
2 fendant in a timely manner.

3 (3)(a) If the most serious offense in the charging instrument is a felony, the court shall commit
4 the defendant to the custody of the superintendent of a state mental hospital or director of a facility
5 designated by the Oregon Health Authority if the defendant is at least 18 years of age, or to the
6 custody of the director of a secure intensive community inpatient facility designated by the author-
7 ity if the defendant is under 18 years of age, if the court makes the following findings:

8 (A) The defendant requires a hospital level of care due to public safety concerns if the defendant
9 is not hospitalized or in custody or the acuity of symptoms of the defendant's qualifying mental
10 disorder; and

11 (B) Based on the findings resulting from a consultation described in ORS 161.365 (1), if applica-
12 ble, from any information provided by community-based mental health providers or any other
13 sources, and primary and secondary release criteria as defined in ORS 135.230, the appropriate
14 community restoration services are not present and available in the community.

15 (b) If the defendant is committed under this subsection, the community mental health program
16 director, or director's designee, shall at regular intervals, during any period of commitment, review
17 available community restoration services and maintain communication with the defendant and the
18 superintendent of the state mental hospital or director of the facility in order to facilitate an effi-
19 cient transition to treatment in the community when ordered.

20 (c) If the court does not order the commitment of the defendant under this subsection, the court
21 shall proceed in accordance with subsection (2)(c) of this section to determine and order an appro-
22 priate action other than commitment.

23 (4)(a) If the most serious offense in the charging instrument is a misdemeanor, the court may
24 not commit the defendant to the custody of the superintendent of a state mental hospital or director
25 of a facility designated by the Oregon Health Authority if the defendant is at least 18 years of age,
26 or to the custody of the director of a secure intensive community inpatient facility designated by
27 the authority if the defendant is under 18 years of age, unless the court:

28 (A)(i) Receives a recommendation from a certified evaluator that the defendant requires a hos-
29 pital level of care due to the acuity of symptoms of the defendant's qualifying mental disorder; and

30 (ii) Receives a recommendation from a community mental health program director, or director's
31 designee, that the appropriate community restoration services are not present and available in the
32 community; or

33 (B) Determines that the defendant requires a hospital level of care after making all of the fol-
34 lowing written findings:

35 (i) The defendant needs a hospital level of care due to the acuity of the symptoms of the
36 defendant's qualifying mental disorder;

37 (ii) There are public safety concerns; and

38 (iii) The appropriate community restoration services are not present and available in the com-
39 munity.

40 (b) If at the time of determining the appropriate action for the case, the court is considering
41 commitment under paragraph (a)(A) of this subsection and:

42 (A) Has not received a recommendation from a certified evaluator as to whether the defendant
43 requires a hospital level of care due to the acuity of symptoms of the defendant's qualifying mental
44 disorder, the court shall order a certified evaluator to make such a recommendation.

45 (B) Has not received a recommendation from the community mental health program director or

1 designee concerning whether appropriate community restoration services are present and available
2 in the community, the court shall order the director or designee to make such a recommendation.

3 (c) If the court does not order the commitment of the defendant under this subsection, the court
4 shall proceed in accordance with subsection (2)(c) of this section to determine and order an appro-
5 priate action other than commitment.

6 (d) If the defendant is committed under this subsection, the community mental health program
7 director, or director's designee, shall at regular intervals, during any period of commitment, review
8 available community restoration services and maintain communication with the defendant and the
9 superintendent of the state mental hospital or director of the facility in order to facilitate an effi-
10 cient transition to treatment in the community when ordered.

11 (5) If the most serious offense in the charging instrument is a violation, the court may not
12 commit the defendant to the custody of the superintendent of a state mental hospital or director of
13 a facility designated by the Oregon Health Authority if the defendant is at least 18 years of age,
14 or to the custody of the director of a secure intensive community inpatient facility designated by
15 the authority if the defendant is under 18 years of age.

16 (6)(a) If the court does not order the commitment of the defendant under subsection (3) or (4)
17 of this section, if commitment is precluded under subsection (5) of this section or if the court de-
18 termines that care other than commitment would better serve the defendant and the community, the
19 court shall release the defendant, pursuant to an order that the defendant engage in community
20 restoration services, until the defendant has gained or regained fitness to proceed, or until the court
21 finds there is no substantial probability that the defendant will, within the foreseeable future, gain
22 or regain fitness to proceed. The court may not order the defendant to engage in community resto-
23 ration services in another county without permission from the other county.

24 (b) The court may order a community mental health program director coordinating the
25 defendant's treatment in the community to provide the court with status reports on the defendant's
26 progress in gaining or regaining fitness to proceed. The director shall provide a status report if the
27 defendant is not complying with court-ordered restoration services.

28 (c) A community mental health program director coordinating the defendant's treatment in the
29 community shall notify the court if the defendant gains or regains fitness to proceed. The notice
30 shall be filed with the court and may be filed electronically. The clerk of the court shall cause
31 copies of the notice to be delivered to both the district attorney and the counsel for the defendant.

32 (d) When a defendant is ordered to engage in community restoration services under this
33 subsection[,]:

34 **(A)** The court may place conditions that the court deems appropriate on the release, including
35 the requirement that the defendant regularly report to a state mental hospital or a certified evalu-

4 **safety concerns, and may consider any other information relevant to the court's determi-**

6 **(c) A determination described in this subsection is a critical stage of the proceeding for**
7 **purposes of ORS 147.500 to 147.550.**

8 **(d) The court may reconsider a determination described in this subsection under the**
9 **same circumstances in which the court may modify a release decision as defined in ORS**
10 **135.230.**

11 **(e) A defendant whose release was denied under ORS 135.240 is not eligible for discharge,**
12 **from the state hospital or other facility to which the defendant was committed under this**
13 **section, to any other facility for treatment to gain or regain fitness to proceed.**

14 [(7)] **(8) The Oregon Health Authority shall establish by rule standards for the recommendation**
15 **provided to the court described in subsection (2) of this section.**

19 **SECTION 53.** ORS 161.371 is amended to read:

20 161.371. (1) The superintendent of a state mental hospital or director of a facility to which the
21 defendant is committed under ORS 161.370 shall cause the defendant to be evaluated within 60 days
22 from the defendant's delivery into the superintendent's or director's custody, for the purpose of de-
23 termining whether there is a substantial probability that, in the foreseeable future, the defendant
24 will have fitness to proceed. In addition, the superintendent or director shall:

25 (a) Immediately notify the committing court if the defendant, at any time, gains or regains fit-
26 ness to proceed or if there is no substantial probability that, within the foreseeable future, the de-
27 fendant will gain or regain fitness to proceed.

28 (b) Within 90 days of the defendant's delivery into the superintendent's or director's custody,
29 notify the committing court that:

30 (A) The defendant has present fitness to proceed;

31 (B) There is no substantial probability that, in the foreseeable future, the defendant will gain
32 or regain fitness to proceed; or

33 (C) There is a substantial probability that, in the foreseeable future, the defendant will gain or
34 regain fitness to proceed. If the probability exists, the superintendent or director shall give the court
35 an estimate of the time in which the defendant, with appropriate treatment, is expected to gain or
36 regain fitness to proceed.

37 (c) Notify the court if court-ordered involuntary medication is necessary for the defendant to
38 gain or regain fitness to proceed and, if appropriate, submit a report to the court under ORS 161.372.

39 (2)(a) If the superintendent of the state mental hospital or director of the facility to which the
40 defendant is committed determines that there is a substantial probability that, in the foreseeable
41 future, the defendant will gain or regain fitness to proceed, unless the court otherwise orders, the
42 defendant shall remain in the superintendent's or director's custody where the defendant shall re-
43 ceive treatment designed for the purpose of enabling the defendant to gain or regain fitness to pro-
44 ceed. In keeping with the notice requirement under subsection (1)(b) of this section, the
45 superintendent or director shall, for the duration of the defendant's period of commitment, submit

1 a progress report to the committing court, concerning the defendant's fitness to proceed, at least

8 (3)(a) Notwithstanding subsection (2) of this section, if [*the most serious offense in the charging*
9 *instrument is a felony, and*] the superintendent of the state mental hospital or director of the facility
10 to which the defendant is committed determines that a hospital level of care is no longer necessary
11 due to [*present public safety concerns and*] the acuity of symptoms of the defendant's qualifying
12 mental disorder, the superintendent or director may file notice of the determination with the court.
13 Upon receipt of the notice, the court shall order that a community mental health program director
14 or the director's designee, within five judicial days:

5 (h) A hearing described in this subsection is a critical stage of the proceeding for pur-
6 poses of ORS 147.500 to 147.550.

7 (5)(a) If a motion to object to a proposed placement is not filed, if the court defers
8 hearing an objection to a proposed placement or if an appropriate placement option remains
9 following a hearing described in subsection (4) of this section, the community mental health
10 program director shall continue to attempt to secure all proposed placements for the de-
11 fendant that were not subject to a granted objection and shall provide a placement status
12 update, in the form of a written memo or report, to the court no less frequently than every
13 30 days.

14 (b) As soon as the director has secured a placement for the defendant and obtained an
15 anticipated availability date for the placement, the director shall immediately notify the
16 court and the parties, and when possible provide information concerning the availability date
17 and the timing of transfer to the placement.

27 options remain following the granting of a motion objecting to a proposed placement, or if

29 (A) The community mental health program director shall continue to regularly evaluate
30 placement options for the defendant, using guidance from the consultation report, and pro-
31 vide status updates to the court, in the form of a written memo or report, no less frequently

16 within a reasonable period of time whether there is a substantial probability that, in the foreseeable
17 future, the defendant will gain or regain fitness to proceed. However, regardless of the number of
18 charges with which the defendant is accused, in no event shall the defendant be committed for
19 longer than whichever of the following, measured from the defendant's initial custody date, is
20 shorter:

21 (A) Three years; or

22 (B) A period of time equal to the maximum sentence the court could have imposed if the de-

15 161.362. (1) A recommendation provided by a certified evaluator, pursuant to ORS 161.355 to
16 161.371, that a defendant requires a hospital level of care due to the acuity of the defendant's
17 symptoms must be based upon the defendant's current diagnosis and symptomology, the defendant's
18 current ability to engage in treatment, present safety concerns relating to the defendant and any
19 other pertinent information known to the evaluator. If the defendant is in a placement in a facility,
20 the evaluator may defer to the treatment provider's recommendation regarding whether a hospital
21 level of care is needed.

22 (2) A determination by a community mental health program director, or the director's designee,

17 **SECTION 59. (1) Within an urban growth boundary, a local government shall allow a**
18 **residential treatment facility or residential treatment home, as those terms are defined in**
19 **ORS 443.400, without requiring a plan amendment, zone change or conditional use permit for**
20 **property that is:**

21 (a) Owned by a public body, as defined in ORS 174.109; or

22 (b) Zoned for:

23 (A) Residential uses;

24 (B) Commercial uses;

25 (C) Employment uses;

26 (D) Public lands, not including park land; or

27 (E) Industrial uses, provided that if the property is:

28 (i) Publicly owned or owned by a public benefit corporation as defined in ORS 65.001;

29 (ii) Within 250 feet of lands zoned for residential use; and

30 (iii) Not specifically designated for heavy industrial uses.

31 (2) This section does not apply on land where the local government determines that:

32 (a) The facility cannot be adequately served by water, sewer, storm water drainage or
33 streets, or will not be adequately served at the time that development on the property is
34 complete; or

35 (b) The development of the property is constrained by land use regulations based on
36 statewide land use planning goals relating to:

37 (A) Natural disasters and hazards; or

38 (B) Natural resources, including air, water, land or natural areas, but not including open
39 spaces or historic resources.

40 (3) This section does not trigger any requirement that a local government consider or
41 update an analysis as required by a statewide land use planning goal relating to economic
42 development.

43 (4) A decision made under this section is not a land use decision as defined in ORS 197.015

35 (1) "Residential facility" means a residential care[, *residential training or residential treatment*]
36 or residential training facility, as those terms are defined in ORS 443.400, that provides residential
37 care alone or in conjunction with treatment or training or a combination thereof for six to fifteen
38 individuals who need not be related. Staff persons required to meet licensing requirements shall not
39 be counted in the number of facility residents, and need not be related to each other or to any
40 resident of the residential facility.

41 (2) "Residential home" means a residential treatment or training home, as defined in ORS
