HB 4005

Designates the first Saturday of October of each year through the end of the Sunday of the following weekend as Water Professionals Appreciation Week.

HB 4004

Provides that additional taxes otherwise imposed upon disqualification of land from certain forestland special assessment programs may not be collected if the disqualification is due to the suspension of reforestation requirements as a result of insects or disease.

HB 4097

Authorizes the Oregon Ocean Science Trust to create and maintain a nonprofit organization

HB 4034

Provides that veterinary facilities do not qualify as animal rescue entities for purposes of
