#### **Work Session**

HB 4004 \*\*

\*\*Subsequent Referral(s) to Revenue

Provides that additional taxes otherwise imposed upon disqualification of land from certain forestland special assessment programs may not be collected if the disqualification is due to the suspension of reforestation requirements as a result of insects or disease.

HB 4049

Directs the Water Resources Commission to encourage and approve voluntary agreements between ground water users in the Greater Harney Valley Groundwater Area of Concern to achieve reasonably stable ground water levels.

HB 4065

Modifies provisions relating to late payment of seed production contracts and seed purchase contracts for agricultural seed and other seed.

HB 4153

Allows counties to approve farm stores, instead of farm stands, as nonfarm use on lands zoned for farm use.

#### **Public Hearing**

HB 4105 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs the State Forester to determine the available state forestland, establish sustainable harvest levels for harvesting timber on state forestland and manage available state forestland.
