#### Public Hearing

HB 4092

Prohibits a retailer from selling or offering for sale, and a retail platform operator from permitting a retailer to advertise or offer for sale, a child safety system that does not comply with federal standards or standards the Department of Transportation adopts by rule.

HB 4095

Makes certain semi-independent state agencies subject to certain provisions regarding the budget process and fiscal matters.

HB 4141

Requires a person that provides debt resolution services to consumers in this state to register with the Department of Consumer and Business Services and regulates the activities of debt resolution service providers.

#### Work Session

HB 4098

Provides that a violation of prohibitions against certain practices with respect to insurance is subject to an enforcement action under the Unlawful Trade Practices Act.
