Public Hearing

HB 4050 **

**Subsequent Referral(s) to Ways and Means

Requires the Legislative Policy and Research Director to study processes to align educational funding with educational costs.

HB 4149

Directs school districts to adopt policies that provide for the immediate enrollment, school placement and provision of services to homeless students.

HB 4154

Requires the compilation of data about students who are regular attenders or who are chronically absent.

Work Session

HB 4066

Prohibits the student member of the Oregon Health and Science University Board of Directors from participating in any discussions or action by the board or attending any executive session of the board involving collective bargaining issues that affect students.

HB 4079

Directs school district boards and governing bodies of institutions of higher education to adopt policies that address how the school district or the institution of higher education will respond when a federal immigration authority enters school property or a campus.

HB 4124 **

**Subsequent Referral(s) to Ways and Means

Directs the Higher Education Coordinating Commission to conduct a study of the condition of Oregon's post-secondary education system and to develop detailed recommendations for the design, implementation and operation of a viable and superior institutional framework.
