Please note: HB 4121 is scheduled solely for the purpose of hearing testimony on the -2 amendments from the people who previously signed up to testify at the meeting on February 5, 2026.

Public Hearing

- HB 4121 ** **Subsequent Referral(s) to Ways and Means
Creates statewide emergency preparedness offices and authorities to coordinate emergency management.
- HB 4032 ** **Subsequent Referral(s) to Ways and Means
Directs the State Department of Energy to evaluate and prioritize geographically dispersed emergency fuel storage sites.
- HB 4100
Requires owners or operators of bulk oils or liquid fuels terminals to obtain a certificate of financial responsibility from the Department of Environmental Quality.

Work Session

- HB 4099 ** **Subsequent Referral(s) to Ways and Means
Establishes the Task Force on Responding to Veterans in Crisis and directs the task force to submit a report to the interim committee of the Legislative Assembly related to emergency management and veterans no later than September 15, 2026.
- HB 4152
Modifies provisions regarding solemnization of marriage to permit deployed service members to be married remotely.
