#### Public Hearing and Work Session

HB 4011

Expands the requirement to discuss class size and caseload as mandatory subjects of bargaining for purposes of school district collective bargaining.

#### Work Session

HB 4027 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires the Legislative Policy and Research Director to conduct a study of the manner in which state labor agencies in other states are funded.

HB 4089

Specifically includes in the crime of theft of services the nonpayment of compensation of employees and independent contractors.

HB 4093 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs the Bureau of Labor and Industries to create certain guidance and informational materials to assist employers and employees.

HB 4094

Requires employers who provide paid vacation time to compensate employees for all earned or accrued but unused paid vacation time when employment terminates.
