#### Public Hearing

##### SCR 208

Modifies Legislative Branch Personnel Rule 27 to combine conduct report and conduct complaint processes into a single process. Provides that only the final investigative report is disclosable to the public, under certain conditions.

##### SB 1600

Modifies confidentiality and disclosure standards for records associated with investigations under legislative branch personnel rules.
