Composition³

The commission consists of five members (DONEGAN, **GRAVATT**, MOYNAHAN, TANNER, WEBB). Members serve four-year terms, and no member may serve more than two consecutive terms.

Duties⁴

The commission establishes the policies for the operation of the Department of Environmental Quality (DEQ) consistent with the air and water quality policies and purposes established in statute. The commission must:

- adopt rules and standards necessary to perform duties and functions;
- appoint a Director of DEQ who holds office at the pleasure of the commission and provide policy direction to the director and agency;
- administer, license, permit, certify, and issue other authorizations related to sewage treatment and disposal, air quality, and water quality;
- administer federal air and water quality requirements;
- maintain and administer funds and grants;

- establish specified priorities for DEQ.
