## HOME CARE COMMISSION

---

The Governor has appointed the following individual to the Home Care Commission subject to Senate confirmation.<sup>1</sup>

### Reappointment

Paul Johnson of Salem

### Term

Johnson: May 31, 2026 – May 30, 2029

### Appointment/Confirmation Authority

### Statement of Economic Interest<sup>2</sup>

Not required.

### Composition<sup>3</sup>

The commission consists of nine members, including:

- five current or former consumers of home care services for elderly persons or persons with disabilities (ADAMS, MCINTYRE, WENTZELL, VACANT, VACANT);
- one Governor's Commission on Senior Services representative (MAYER);
- one Department of Human Services representative (**JOHNSON**);
- one Oregon Disabilities Commission representative (KING); and
- one Oregon Association of Area Agencies on Aging and Disabilities representative (VACANT).

Terms are three years, limited to three consecutive terms. The Governor annually selects a chair, and Oregon Department of Human Services (ODHS) appoints one of its employees to be the executive director, subject to the commission's approval. A majority of the members in office constitutes a quorum.

## Duties<sup>4</sup>

The commission's duties, in collaboration with ODHS, include:

- ensuring the equality of home care workers;
- establishing qualifications for homecare and personal support workers;
- maintaining a statewide registry of qualified workers;
- providing training opportunities for workers and the consumers who employ them;
- serving as the "employer of record" for collective bargaining for homecare and personal support workers who receive service payments from public funds;
- providing routine, emergency, and respite home care worker referrals;
- entering into agreements with public and private organizations and individuals to obtain or develop training materials and curriculum or other services; and
- working cooperatively with area agencies and state and local agencies.
