Composition³

The commission consists of nine members, including:

- the Public Health Officer or designee (**JEANNE**);
- a registry identification cardholder (**TAYLOR**);
- a marijuana producer who is a registry identification cardholder (**HARLACHER**);
- an attending provider (**VACANT**);
- an Oregon Health Authority (OHA) representative (**OURSO**);
- an Oregon Liquor Control Commission (OLCC) representative (**BORUP**);
- a local health officer (**LEUDTKE**);
- a law enforcement officer (**BURKE**); and
- a person knowledgeable about research proposal grant protocols (**VACANT**).

Members serve four-year terms and at the pleasure of the Governor. The commission selects its chair and vice chair from its membership and must meet at least once a quarter. A majority of the members constitutes a quorum.

The commission is established within the OHA. It advises OHA on the administration of the Oregon Medical Marijuana Act and the OLCC on the administration of the Adult and Medical Use of Cannabis Act, as it relates to registry identification cardholders and primary caregivers.
