Bill Title: Relating to state financial administration; declaring an emergency.

Government Unit(s) Affected: Department of Administrative Services, Judicial Department, Department of Transportation, Department of Education, Oregon Business Development Department, Board of Parole and Post-Prison Supervision

Measure Description

This measure implements statutory changes necessary to support the 2025-27 legislatively adopted budget and to clarify the application of statutes. This measure, relating to state financial administration, is not an appropriation bill and therefore does not include the appropriation of funds. The measure has an emergency clause and is effective on passage.
