Summary of Revenue Changes

House Bill 4061 provides \$1,185,846 Lottery Funds to the Oregon Business Development Department (OBDD) to provide grants for tariff-impacted businesses and pay for related expenses to administer the new program.

Summary of Transportation and Economic Development Subcommittee Action

House Bill 4061 directs OBDD to establish a micro-enterprise tariff adjustment grant program to help small businesses cover significant cost increases resulting from recently imposed federal tariffs. The bill also requires Business Oregon to collaborate with the Port of Portland, the Oregon Tourism Commission, the State Department of Agriculture, and other stakeholders to update Oregon’s unified trade strategy.

The Subcommittee recommended \$950,000 Lottery Funds expenditure limitation for grants to eligible businesses to cover increased costs incurred because of tariffs. Existing resources will be used to develop, administer, and market the program. Additionally, the Subcommittee recommended the establishment of two limited duration, full-time positions (1.00 FTE) for the 2025-27 biennium: a Procurement and Contract Specialist 1 and an Accounting Technician. The Accounting Technician position is also intended to continue into the 2027-29 biennium through January 2, 2029 (the statutory repeal of the program), to support the disbursement of an estimated 120 grants associated with this program.
