SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes the Transit Funding Task Force and tells the task force to make a report. (Flesch Readability Score: 100).

Establishes the Transit Funding Task Force and directs the task force to report to an interim committee of the Legislative Assembly related to transportation no later than December 1, 2026.

Declares an emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to a transit funding task force; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Transit Funding Task Force is established.**

5 **(2) The task force consists of 22 members appointed as follows:**

6 **(a) From among members of the Senate:**

7 **(A) The President of the Senate shall appoint one nonvoting member; and**

8 **(B) The Senate Minority Leader shall appoint one nonvoting member.**

9 **(b) From among members of the House of Representatives:**

10 **(A) The Speaker of the House of Representatives shall appoint one nonvoting member;**

11 **and**

12 **(B) The House Minority Leader shall appoint one nonvoting member.**

13 **(c) Jointly, the President of the Senate and Speaker of the House of Representatives shall**
14 **appoint the following nonlegislative members:**

15 **(A) One member who represents the City of Portland;**

16 **(B) One member who represents the Amalgamated Transit Union;**

17 **(C) One member who represents a workers' union;**

18 **(D) One member who represents a mass transit provider;**

19 **(E) One member who represents a business association representing the Portland met-**
20 **ropolitan area;**

21 **(F) One member who represents a business association representing businesses outside**
22 **the Portland metropolitan area;**

23 **(G) One member who represents a tribal transit provider;**

24 **(H) One member who represents a transit provider that provides services in a city with**
25 **a population of less than 100,000;**

26 **(I) One member who represents a rural transit provider;**

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (J) One member who represents a transit provider that primarily serves people with
2 disabilities and seniors;

3 (K) One member who represents Metro, as defined in ORS 197.015;

4 (L) One member who represents city governments in this state;

5 (M) One member who represents county governments in this state;

6 (N) One member who represents an organization that advocates for transportation
7 safety;

8 (O) One member who represents transit riders who utilize a low-income transit pass
9 program;

10 (P) One member who represents an employer with over 100 employees;

11 (Q) One member who represents an employer with 100 employees or fewer; and

12 (R) One member who serves as a nonvoting representative of the Department of Trans-
13 portation.

14 (3) The task force shall:

15 (a) Determine the level of funding needed to maintain adequate transit service statewide
16 that is reliable, safe and accessible and allows for population growth over time; and

17 (b) Explore funding mechanisms to achieve the funding needs determined in paragraph
18 (a) of this subsection.

19 (4) A majority of the voting members of the task force constitutes a quorum for the
20 transaction of business.

21 (5) Official action by the task force requires the approval of a majority of the voting
22 members of the task force.

23 (6) The President of the Senate and the Speaker of the House of Representatives shall
24 select one member of the task force to serve as chairperson and another to serve as vice
25 chairperson, with the duties and powers necessary for the performance of the functions of
26 the offices as the President and the Speaker determine.

27 (7) If there is a vacancy for any cause, the appointing authority shall make an appoint-
28 ment to become immediately effective.

29 (8) The task force shall meet at times and places specified by the call of the chairperson
30 or of a majority of the voting members of the task force.

31 (9) The task force may adopt rules necessary for the operation of the task force.

32 (10) The task force shall submit a report in the manner provided by ORS 192.245, and
33 may include recommendations for legislation, to an interim committee of the Legislative
34 Assembly related to transportation no later than December 1, 2026. The report must include
35 recommended revenue mechanisms including the following information about each recom-
36 mended mechanism:

37 (a) The amount of revenue the mechanism is projected to raise;

38 (b) Who would pay; and

39 (c) The likelihood of the revenue source being a reliable source of revenue in the future.

40 (11) The Legislative Revenue Office shall provide staff support to the task force.

41 (12) Members of the Legislative Assembly appointed to the task force are nonvoting
42 members of the task force and may act in an advisory capacity only.

43 (13) Members of the task force who are not members of the Legislative Assembly serve
44 as volunteers on the task force and, unless they are qualified members, as defined in ORS
45 292.495, are not entitled to compensation or reimbursement for expenses.

1 **(14) All agencies of state government, as defined in ORS 174.111, are directed to assist**
2 **the task force in the performance of the duties of the task force and, to the extent permitted**
3 **by laws relating to confidentiality, to furnish information and advice the members of the task**
4 **force consider necessary to perform their duties.**

5 **SECTION 2.** **Section 1 of this 2026 Act is repealed on December 31, 2027.**

6 **SECTION 3.** **This 2026 Act being necessary for the immediate preservation of the public**
7 **peace, health and safety, an emergency is declared to exist, and this 2026 Act takes effect**
8 **on its passage.**
