

House Bill 4013

Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of House Interim Committee on Labor and Workforce Development for Representative Dacia Grayber)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act specifies which federal rules BOLI must use when adopting rules that set work hour limits for minors. (Flesch Readability Score: 62.8).

Clarifies which federal rules apply to the scope of the rulemaking authority of the Bureau of Labor and Industries regarding rules that govern the hours a minor can work.

1 A BILL FOR AN ACT

2 Relating to labor standards; amending ORS 653.307.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 653.307 is amended to read:

5 653.307. (1) In accordance with the applicable provisions of ORS chapter 183, the Bureau of
6 Labor and Industries shall adopt rules governing annual employment certificates required under this
7 section. After September 9, 1995, the rules governing the total hours a minor can work may not be
8 [more] **less** restrictive than the requirements of the federal Fair Labor Standards Act (29 U.S.C. 201,
9 et seq.), [*unless otherwise provided by Oregon law*] **as in effect on January 1, 2026, but may be**
10 **more restrictive only as necessary to implement or conform to changes in the federal Act**
11 **or state law that increase protections for minors.**

12 (2) An employer who hires minors shall apply to the bureau for an annual employment certificate to employ minors. The application shall be on a form provided by the bureau and shall include, but need not be limited to:

13 (a) The estimated or average number of minors to be employed during the year.
14 (b) A description of the activities to be performed.
15 (c) A description of the machinery or other equipment to be used by the minors.

16 (3) Once a year, the bureau shall provide to all employers applying for an annual employment certificate an information sheet summarizing all rules and laws governing the employment of minors.

17 (4) Failure by an employer to comply with ORS 653.305 to 653.340 or with the regulations adopted by the bureau pursuant to this section shall subject the employer to revocation of the right to hire minors in the future at the discretion of the bureau, provided that an employer shall be granted a hearing before the bureau prior to such action being taken.

18 (5) All school districts shall cooperate with the bureau and make available, upon request of the bureau, information concerning the age and schooling of minors.
