

House Bill 4015

Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of House Interim Committee on Revenue for Representative Nancy Nathanson)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Updates the tie date to the federal Internal Revenue Code and other federal tax laws. Becomes law 91 days from sine die. (Flesch Readability Score: 64.9).

Updates the connection date to the federal Internal Revenue Code and other provisions of federal tax law.

Takes effect on the 91st day following adjournment sine die.

A BILL FOR AN ACT

Relating to connection to federal tax law; creating new provisions; amending ORS 178.300, 178.375, 238A.005, 238A.125, 238A.150, 238A.170, 238A.230, 238A.370, 238A.400, 238A.410, 238A.415, 238A.430, 238A.435, 305.239, 305.494, 305.690, 305.842, 314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097, 317A.100, 458.670, 657.010 and 657B.010; and prescribing an effective date.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 178.300 is amended to read:

178.300. As used in ORS 178.300 to 178.360:

(1) "Account" means an individual account established in accordance with ORS 178.300 to 178.360.

(2) "Account owner" means the person who has the right to withdraw funds from the account. The account owner may also be the designated beneficiary of the account.

(3) "Board" means the Oregon 529 Savings Board established under ORS 178.310.

(4) "Designated beneficiary" means, except as provided in ORS 178.350, the individual designated at the time the account is opened as having the right to receive a qualified withdrawal for the payment of qualified higher education expenses, or if the designated beneficiary is replaced in accordance with ORS 178.350, the replacement.

(5) "Financial institution" means a bank, a commercial bank, a national bank, a savings bank, a savings and loan, a thrift institution, a credit union, an insurance company, a trust company, a mutual fund, an investment firm or other similar entity authorized to do business in this state.

(6) "Higher education institution" means an eligible education institution as defined in section 529(e)(5) of the Internal Revenue Code.

(7) "Internal Revenue Code" means the federal Internal Revenue Code as amended and in effect on December 31, [2023] **2025**.

(8) "Member of the family" shall have the same meaning as contained in section 529(e) of the Internal Revenue Code.

(9) "Network" means the Oregon 529 Savings Network established under ORS 178.305.

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (10) "Nonqualified withdrawal" means a withdrawal from an account that is not a qualified
2 withdrawal.

3 (11) "Qualified higher education expenses" means tuition and other permitted expenses as set
4 forth in section 529(e) of the Internal Revenue Code for the enrollment or attendance of a designated
5 beneficiary at a higher education institution, expenses associated with registered apprenticeship
6 programs described in section 529(c)(8) of the Internal Revenue Code and amounts paid as principal
7 or interest on a qualified education loan to the extent allowed under section 529(c)(9) of the Internal
8 Revenue Code.

9 (12) "Qualified withdrawal" means a withdrawal made as prescribed under ORS 178.355 and
10 made:

11 (a) From an account to pay the qualified higher education expenses of the designated benefici-
12 ary;

13 (b) As the result of the death or disability of the designated beneficiary;

14 (c) As the result of a scholarship, allowance or payment described in section 135(d)(1)(A), (B)
15 or (C) of the Internal Revenue Code that is received by the designated beneficiary, but only to the
16 extent of the amount of the scholarship, allowance or payment; or

17 (d) As a rollover or change in the designated beneficiary described in ORS 178.350.

18 **SECTION 2.** ORS 178.375 is amended to read:

19 178.375. As used in this section and ORS 178.380 and 178.385:

20 (1) "ABLE account" means an account established by an eligible individual, owned by the eli-
21 gible individual and maintained under the qualified ABLE program established by the Oregon 529
22 Savings Board under ORS 178.380.

24 (Division B of P.L. 113-295).

20 (5) "Firefighter" means:

21 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job
22 duties include the fighting of fires;

23 (b) The State Fire Marshal, chief deputy state fire marshals and deputy state fire marshals;

24 (c) An employee of the State Fire Marshal whose primary duties include fire investigation, fire
25 prevention, fire safety, fire control or fire suppression;

26 (d) An employee of the State Forestry Department who is certified by the State Forester as a
27 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
28 fires as described in ORS 477.064; and

29 (e) An employee of the Oregon Military Department whose primary duties include fighting

20 (17)(a) "Salary" means the remuneration paid to an active member in return for services to the
21 participating public employer, including remuneration in the form of living quarters, board or other
22 items of value, to the extent the remuneration is, or would be if the member were an Oregon resi-
23 dent, includable in the employee's taxable income under Oregon law. "Salary" includes the addi-
24 tional amounts specified in paragraph (b) of this subsection, but does not include the amounts
25 specified in paragraph (c) of this subsection, regardless of whether those amounts are includable in
26 taxable income.

41 the employer and deducted from the compensation of the employee, as provided under ORS 238A.335

44 by the employer under ORS 238A.335.

45 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS

2 (c) "Salary" does not include the following amounts:

7 leave.

29 period and the denominator of which is 12. The board shall adopt rules adjusting this dollar limit

30 to incorporate cost-of-living adjustments authorized by the Internal Revenue Service.

16 238A.125. (1) Upon retiring at normal retirement age, a vested pension program member shall
17 be paid an annual pension for the life of the member as follows:

18 (a) For service as a police officer or firefighter, 1.8 percent of final average salary multiplied
19 by the number of years of retirement credit attributable to service as a police officer or firefighter.

20 (b) For service as other than a police officer or firefighter, 1.5 percent of final average salary
21 multiplied by the number of years of retirement credit attributable to service as other than a police
22 officer or firefighter.

23 (2) Notwithstanding any provision of ORS 238A.100 to 238A.250, the annual benefit payable to
24 a member under the pension program and under any other tax-qualified defined benefit plan main-
25 tained by the participating public employer may not exceed the applicable limitations set forth in

18 (A) A loan that meets the criteria stated in subsection (5) of this section or that is made to re-
19 finance a loan that meets the criteria described in subsection (5) of this section;

20 (B) The purchase by a lending institution of bonds, the proceeds of which are used to finance
21 or refinance a loan that meets the criteria described in subsection (5) of this section; or

22 (C) A qualified mortgage loan fund.

23 (L) "Qualified mortgage loan fund" means a fund that:

24 (A) Is operated by a lending institution described in subsection (12) of this section;

25 (B) Makes mortgages to first-time home buyers;

26 (C) Makes mortgages for homes subject to a land trust mortgage; and

27 (D) Makes mortgages to households that, at the time of mortgage origination, have income that
28 is 80 percent or less of area median income as defined in ORS 458.610.

29 (m) "Sponsoring entity" means a nonprofit corporation, nonprofit cooperative, state govern-
30 mental entity, local unit of government as defined in ORS 466.706, housing authority or any other
31 person, provided that the person has agreed to restrictive covenants imposed by a nonprofit corpo-
32 ration, nonprofit cooperative, state governmental entity, local unit of government or housing au-
33 thority.

34 (2) The Department of Revenue shall allow a credit against taxes otherwise due under this
35 chapter for the tax year to a lending institution that makes a qualified loan certified by the Housing
36 and Community Services Department as provided in subsection (7) of this section. The amount of the
37 credit is equal to the difference between:

38 (a) The amount of finance charge charged by the lending institution during the tax year at an
39 annual rate less than the market rate for a qualified loan that complies with the requirements of this
40 section; and

41 (b) The amount of finance charge that would have been charged during the tax year by the
42 lending institution for the qualified loan for housing construction, development, acquisition or re-
43 habilitation measured at the annual rate charged by the lending institution for nonsubsidized loans
44 made under like terms and conditions at the time the qualified loan for housing construction, de-
45 velopment, acquisition or rehabilitation is made.

1 (3) The maximum amount of credit for the difference between the amounts described in sub-
2 section (2)(a) and (b) of this section may not exceed four percent of the average unpaid balance of
3 the qualified loan during the tax year for which the credit is claimed.

4 (4) Any tax credit allowed under this section that is not used by the taxpayer in a particular
5 year may be carried forward and offset against the taxpayer's tax liability for the next succeeding
6 tax year. Any credit remaining unused in the next succeeding tax year may be carried forward and
7 used in the second succeeding tax year, and likewise, any credit not used in that second succeeding
8 tax year may be carried forward and used in the third succeeding tax year, and any credit not used
9 in that third succeeding tax year may be carried forward and used in the fourth succeeding tax year,
10 and any credit not used in that fourth succeeding tax year may be carried forward and used in the
11 fifth succeeding tax year, but may not be carried forward for any tax year thereafter.

12 (5) To be eligible for the tax credit allowable under this section, a lending institution must make
13 a qualified loan by either purchasing bonds, the proceeds of which are used to finance or refinance
14 a loan that meets the criteria stated in this subsection, or making a loan directly to:

15 (a) An individual or individuals who own a dwelling, participate in an owner-occupied commu-
16 nity rehabilitation program and are certified by the local government or its designated agent as
17 having an income level when the loan is made of 80 percent of the area median income or less;

18 (b) A qualified borrower who:

19 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation
20 of housing, including housing in the form of a limited equity cooperative; and

21 (B) Provides a written certification executed by the Housing and Community Services Depart-
22 ment that the:

23 (i) Housing created by the loan is or will be occupied by households earning 80 percent of the
24 area median income or less; and

25 (ii) Full amount of savings from the reduced interest rate provided by the lending institution is
26 or will be passed on, in the form of reduced housing payments, to the tenants or to the holders of
27 proprietary leases in a limited equity cooperative;

28 (c) Subject to subsection (14) of this section, a qualified borrower who:

29 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation
30 of housing consisting of a manufactured dwelling park; and

31 (B) Provides a written certification executed by the Housing and Community Services Depart-
32 ment that the housing will continue to be operated as a manufactured dwelling park during the pe-
33 riod for which the tax credit is allowed;

34 (d) A qualified borrower who:

35 (A) Uses the loan proceeds to finance acquisition or rehabilitation of housing consisting of a
36 preservation project; and

37 (B) Provides a written certification executed by the Housing and Community Services Depart-
38 ment that the housing preserved by the loan:

39 (i) Is or will be occupied by households earning 80 percent of the area median income or less;
40 and

41 (ii) Is the subject of a rent assistance contract with the United States Department of Housing
42 and Urban Development or the United States Department of Agriculture that will be maintained by
43 the qualified borrower;

44 (e) A qualified borrower who:

45 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation

1 of housing; and

2 (B) Provides a written certification executed by the Housing and Community Services Depart-
3 ment or the governmental party to the rent assistance contract that the housing preserved by the
4 loan:

5 (i) Is or will be occupied by households earning 80 percent of the area median income or less;
6 and

7 (ii) Is the subject of a rent assistance contract with the federal government or with a state or
8 local government that will be maintained by the qualified borrower and that limits a tenant's rent
9 to no more than 30 percent of their income;

10 (f) A qualified borrower who:

11 (A) Uses the loan proceeds to finance preservation or rehabilitation of housing; and

12 (B) Provides a written certification executed by the Housing and Community Services Depart-
13 ment that the housing preserved or rehabilitated by the loan:

14 (i) Is or will be occupied by households earning 80 percent of the area median income or less;
15 and

16 (ii) Is currently characterized by financial or physical distress that threatens its ongoing vi-
17 ability as an affordable housing resource; or

18 (g) A qualified mortgage loan fund.

19 (6) A loan made to refinance a loan that meets the criteria stated in subsection (5) of this sec-
20 tion must be treated the same as a loan that meets the criteria stated in subsection (5) of this sec-
21 tion.

22 (7) For a qualified loan to be eligible for the tax credit allowable under this section, the Housing
23 and Community Services Department must execute a written certification for the qualified loan that:

24 (a) States that the qualified loan is within the limitation imposed by subsection (8) of this sec-
25 tion; and

26 (b) Specifies the period, as determined by the Housing and Community Services Department,
27 during which the tax credit is allowed for the qualified loan, not to exceed:

28 (A) 30 years, for a qualified loan with a contract for rent assistance or financing resources from
29 the United States Department of Agriculture, for new housing construction, acquisition of housing
30 or a preservation project; or

31 (B) 20 years, for any other type of qualified loan.

32 (8) The Housing and Community Services Department may certify qualified loans that are eligi-
33 ble under subsection (5) of this section if the total credits attributable to all qualified loans eligible
34 for credits under this section and then outstanding do not exceed \$35 million for any fiscal year. In
35 making loan certifications under subsection (7) of this section, the Housing and Community Services
36 Department shall attempt to distribute the tax credits statewide, but shall concentrate the tax
37 credits in those areas of the state that are determined by the Oregon Housing Stability Council to
38 have the greatest need for affordable housing.

39 (9) The tax credit provided for in this section may be taken whether or not:

40 (a) The financial institution is eligible to take a federal income tax credit under section 42 of
41 the Internal Revenue Code with respect to the project financed by the qualified loan;

42 (b) The project receives financing from bonds, the interest on which is exempt from federal
43 taxation under section 103 of the Internal Revenue Code; or

44 (c) The project receives moneys from the Elderly and Disabled Housing Fund under ORS 456.535.

45 (10) For a qualified loan defined in subsection (1)(k)(B) of this section financed through the

1 purchase of bonds, the interest of which is exempt from federal taxation under section 103 of the
2 Internal Revenue Code, the amount of finance charge that would have been charged under sub-
3 section (2)(b) of this section is determined by reference to the finance charge that would have been
4 charged if the federally tax exempt bonds had been issued and the tax credit under this section did
5 not apply.

6 (11) A lending institution may sell a qualified loan for which a certification has been executed
7 to a qualified assignee whether or not the lending institution retains servicing of the qualified loan
8 so long as a designated lending institution maintains records, annually verified by a loan servicer,
9 that establish the amount of tax credit earned by the taxpayer throughout each year of eligibility.

10 (12) Notwithstanding any other provision of law, a lending institution that is a community de-
11 velopment corporation organized under the Oregon Nonprofit Corporation Law may transfer all or
12 part of a tax credit allowed under this section to one or more other lending institutions that are
13 stockholders or members of the community development corporation or that otherwise participate
14 through the community development corporation in the making of one or more qualified loans for
15 which the tax credit under this section is allowed.

16 (13) The lending institution shall file an annual statement with the Housing and Community
17 Services Department, specifying that it has conformed with all requirements imposed by law to
18 qualify for a tax credit under this section.

19 (14) Notwithstanding subsection (1)(j) and (m) of this section, a qualified borrower on a loan to
20 finance the construction, development, acquisition or rehabilitation of a manufactured dwelling park
21 under subsection (5)(c) of this section must be:

22 (a) A nonprofit corporation, manufactured dwelling park nonprofit cooperative, state govern-
23 mental entity, local unit of government as defined in ORS 466.706 or housing authority; or

24 (b) A nonprofit corporation or housing authority that has a controlling interest in the real
25 property that is financed by a qualified loan. A controlling interest includes a controlling interest
26 in the general partner of a limited partnership that owns the real property.

27 (15) The Department of Revenue may require that a lending institution that has earned the
28 credit and a lending institution that intends to claim the credit jointly file a notice, as prescribed
29 by the Department of Revenue. The notice must comply with ORS 315.056 (2) or 315.058 (2).

30 (16) The Housing and Community Services Department shall provide information to the Depart-
31 ment of Revenue about all certifications executed under this section, if required by ORS 315.058.

32 (17) The Housing and Community Services Department and the Department of Revenue may
33 adopt rules to carry out the provisions of this section.

34 **SECTION 28.** ORS 317A.100, as amended by section 6, chapter 502, Oregon Laws 2025, is

9 (b) "Commercial activity" does not include:
10 (A) Interest income except:
11 (i) Interest on credit sales; or
12 (ii) Interest income, including service charges, received by financial institutions;
13 (B) Receipts from the sale, exchange or other disposition of an asset described in section 1221
14 or 1231 of the Internal Revenue Code, without regard to the length of time the person held the asset;
15 (C) If received by an insurer, federally reinsured premiums or income from transactions between
16 a reciprocal insurer and its attorney in fact operating under ORS 731.142;
17 (D) Receipts from hedging transactions, to the extent that the transactions are entered into
18 primarily to protect a financial position, including transactions intended to manage the risk of ex-
19 posure to foreign currency fluctuations that affect assets, liabilities, profits, losses, equity or in-
20 vestments in foreign operations, risk of exposure to interest rate fluctuations or risk of commodity
21 price fluctuations;
22 (E) Proceeds received attributable to the repayment, maturity or redemption of the principal of
23 a loan, bond, mutual fund, certificate of deposit or marketable instrument;
24 (F) The principal amount received under a repurchase agreement or on account of any trans-
25 action properly characterized as a loan to the person;
26 (G) Contributions received by a trust, plan or other arrangement, any of which is described in

33 pending care spending account, legal services plan, any cafeteria plan described in section 125 of
34 the Internal Revenue Code or any similar employee reimbursement;

41 homeowners' or condominium associations, payments received for educational courses, meetings or
42 meals, or similar payments to a trade, professional or other similar association, and fundraising re-
43 ceipts received by any person when any excess receipts are donated or used exclusively for chari-
44 table purposes;
45 (L) Damages received as the result of litigation in excess of amounts that, if received without

1 litigation, would be treated as commercial activity;

2 (M) Property, money and other amounts received or acquired by an agent on behalf of another
3 in excess of the agent's commission, fee or other remuneration;

4 (N) Tax refunds from any tax program, other tax benefit recoveries and reimbursements for the
5 tax imposed under ORS 317A.100 to 317A.158 made by entities that are part of the same unitary
6 group as provided under ORS 317A.106, and reimbursements made by entities that are not members
7 of a unitary group that are required to be made for economic parity among multiple owners of an
8 entity whose tax obligation under ORS 317A.100 to 317A.158 is required to be reported and paid
9 entirely by one owner, as provided in ORS 317A.106;

10 (O) Pension reversions;

11 (P) Contributions to capital;

12 (Q) Receipts from the sale, transfer, exchange or other disposition of motor vehicle fuel or any
13 other product used for the propulsion of motor vehicles;

14 (R) In the case of receipts from the sale of cigarettes or tobacco products by a wholesale dealer,
15 retail dealer, distributor, manufacturer or seller, an amount equal to the federal and state excise
16 taxes paid by any person on or for such cigarettes or tobacco products under subtitle E of the
17 Internal Revenue Code or ORS chapter 323;

18 (S) In the case of receipts from the sale of malt beverages or wine, as defined in ORS 471.001,
19 cider, as defined in ORS 471.023 or distilled liquor, as defined in ORS 471.001, by a person holding
20 a license issued under ORS chapter 471, an amount equal to the federal and state excise taxes paid
21 by any person on or for such malt beverages, wine or distilled liquor under subtitle E of the Internal

33 (W) Receipts realized by a vehicle dealer certified under ORS 822.020 or a person described in
34 ORS 320.400 (8)(a)(B) from the sale or other transfer of a motor vehicle, as defined in ORS 801.360,
35 to another vehicle dealer for the purpose of resale by the transferee vehicle dealer, but only if the
36 sale or other transfer was based upon the transferee's need to meet a specific customer's preference
37 for a motor vehicle or is an exchange of new vehicles between franchised motor vehicle dealerships;

38 (X) Registration fees or taxes collected by a vehicle dealer certified under ORS 822.020 or a
39 person described in ORS 320.400 (8)(a)(B) at the sale or other transfer of a motor vehicle, as defined
40 in ORS 801.360, that are owed to a third party by the purchaser of the motor vehicle and passed to
41 the third party by the dealer;

42 (Y) Receipts from a financial institution for services provided to the financial institution in

44 the financial institution and the recipient of the receipts have at least 50 percent of their ownership
45 interests owned or controlled, directly or constructively through related interests, by common own-

1 ers;

2 (Z) In the case of amounts retained as commissions by a holder of a license under ORS chapter
3 462, an amount equal to the amounts specified under ORS chapter 462 that must be paid to or col-
4 lected by the Department of Revenue as a tax and the amounts specified under ORS chapter 462 to
5 be used as purse money;

6 (AA) Receipts of residential care facilities as defined in ORS 443.400 or in-home care agencies
7 as defined in ORS 443.305, to the extent that the receipts are derived from or received as compen-
8 sation for providing services to a medical assistance or Medicare recipient;

9 (BB) Dividends received;

10 (CC) Distributive income received from a pass-through entity;

11 (DD) Receipts from sales to a wholesaler in this state, if the seller receives certification at the
12 time of sale from the wholesaler that the wholesaler will sell the purchased property outside this

14 (EE) Receipts from the wholesale or retail sale of groceries, including receipts of a person that
15 owns groceries at the time of sale and compensation of any consignee engaged in effecting the sale
16 of groceries on behalf of the owner of the groceries, but only to the extent that the compensation re-
17 lates to grocery sales;

18 (FF) Receipts from transactions among members of a unitary group;

19 (GG) Moneys, including public purpose charge moneys collected under ORS 757.612 and moneys
20 collected to plan for and pursue cost-effective energy efficiency resources under ORS 757.054, that
21 are collected from customers, passed to a utility and approved by the Public Utility Commission and
22 that support energy conservation, renewable resource acquisition and low-income assistance pro-
23 grams;

24 (HH) Moneys collected by a utility from customers for the payment of loans through on-bill fi-
25 nancing;

26 (II) Surcharges collected under ORS 757.736;

27 (JJ) Moneys passed to a utility by the Bonneville Power Administration for the purpose of
28 effectuating the Regional Power Act Exchange credits or pursuant to any settlement associated with
29 the exchange credit;

30 (KK) Moneys collected or recovered, by entities listed in ORS 756.310, cable operators as de-
31 fined in 47 U.S.C. 522(5), telecommunications carriers as defined in 47 U.S.C. 153(51) and providers
32 of information services as defined in 47 U.S.C. 153(24), for fees payable under ORS 756.310, right-of-
33 way fees, franchise fees, privilege taxes, federal taxes and local taxes;

34 (LL) Charges assessed under ORS 759.685 and paid into the Residential Service Protection Fund;

35 (MM) Universal service surcharge moneys collected or recovered and paid into the universal
36 service fund established in ORS 759.425;

37 (NN) Moneys collected for public purpose funding as described in ORS 759.430;

38 (OO) Moneys collected or recovered and paid into the federal universal service fund as deter-
39 mined by the Federal Communications Commission;

40 (PP) In the case of a seller or provider of telecommunications services, the amount of tax im-
41 posed under ORS 403.200 for access to the emergency communications system that is collected from
42 subscribers or consumers;

43 (QQ) In the case of a transient lodging tax collector, the amount of tax imposed under ORS
44 320.305 and of any local transient lodging tax imposed upon the occupancy of transit lodging;

45 (RR) In the case of a seller of bicycles, the amount of tax imposed under ORS 320.415 upon retail

1 sales of bicycles;

2 (SS) In the case of a qualified heavy equipment provider, the amount of tax imposed under ORS
3 307.872 upon the rental price of heavy equipment;

4 (TT) Farmer sales to an agricultural cooperative in this state that is a cooperative organization
5 described in section 1381 of the Internal Revenue Code;

6 (UU) Revenue received by a business entity that is mandated by contract or subcontract to be
7 distributed to another person or entity if the revenue constitutes sales commissions that are paid
8 to a person who is not an employee of the business entity, including, without limitation, a split-fee
9 real estate commission;

10 (VV) Receipts from the sale of fluid milk by dairy farmers that are not members of an agricultural
11 cooperative; and

12 (WW)(i) Cost paid by a dealer for items of precious metal.

13 (ii) As used in this subparagraph, "item of precious metal" means an item of gold, silver,
14 platinum, rhodium or palladium that has been put through a process of smelting or refining and that
15 is in a state or condition that its value depends on its contents and not its form.

16 (2) "Cost inputs" means:

17 (a) The cost of goods sold as calculated in arriving at federal taxable income under the Internal
18 Revenue Code; or

19 (b) In the case of a taxpayer that is engaged in a farming operation, as defined in ORS 317A.102,
20 and that does not report cost of goods sold for federal tax purposes, the taxpayer's operating ex-
21 penses excluding labor costs.

22 (3) "Doing business" means engaging in any activity, whether legal or illegal, that is conducted

39 (j) Any person with commercial activity that does not exceed \$750,000 for the tax year, other
40 than a person that is part of a unitary group as provided in ORS 317A.106 with commercial activity
41 in excess of \$750,000.

42 (k) Hospitals subject to assessment under ORS 414.855, long term care facilities subject to as-
43 sessment under ORS 409.801 or any entity subject to assessment under ORS 414.880 or section 3 or
44 5, chapter 538, Oregon Laws 2017.

45 (L) Manufactured dwelling park nonprofit cooperatives organized under ORS chapter 62.

1 (5) "Financial institution" has the meaning given that term in ORS 314.610, except that "financial
2 institution" does not include a credit union.

3 (6)(a) "FR Y-9" means the consolidated or parent-only financial statements that a holding company
4 is required to file with the Federal Reserve Board pursuant to 12 U.S.C. 1844.

5 (b) In the case of a holding company required to file both consolidated and parent-only financial
6 statements, "FR Y-9" means the consolidated financial statements that the holding company is required
7 to file.

8 (7) "Governmental entity" means:

9 (a) The United States and any of its unincorporated agencies and instrumentalities.

10 (b) Any incorporated agency or instrumentality of the United States wholly owned by the United
11 States or by a corporation wholly owned by the United States.

12 (c) The State of Oregon and any of its unincorporated agencies and instrumentalities.

13 (d) Any county, city, district or other political subdivision of the state.

14 (e) A special government body as defined in ORS 174.117.

15 (f) A federally recognized Indian tribe.

16 (8) "Groceries" means food as defined in 7 U.S.C. 2012(k), but does not include cannabinoid
17 edibles or marijuana seeds.

18 (9)(a) "Hedging transaction" means a hedging transaction as defined in section 1221 of the
19 Internal Revenue Code or a transaction accorded hedge accounting treatment under Financial
20 Accounting Standards Board Statement No. 133.

21 (b) "Hedging transaction" does not include a transaction in which an actual transfer of title of
22 real or tangible property to another entity occurs.

23 (10) "Insurer" has the meaning given that term in ORS 317.010.

24 (11) "Internal Revenue Code," except where the Legislative Assembly has provided otherwise,
25 refers to the laws of the United States or to the Internal Revenue Code as they are amended and
26 in effect on December 31, [2023] 2025.

27 (12) "Labor costs" means total compensation of all employees, not to include compensation paid

43 from, by or under the guidance of an instructor or teacher;

44 (b) That is accredited, registered, approved, licensed or issued a permit to operate as a school
45 by the Department of Education or other government agency, or that offers courses for credit that

1 are transferable to an approved, registered or accredited school;

2 (c) In which the course or courses of study or training that it offers may be academic, technical,
3 trade or preparation for gainful employment in a recognized occupation; and

4 (d) In which the course or courses of study or training are offered on a regular and continuing
5 basis.

6 (10) "Employment office" means a free public employment office or branch thereof, operated by
7 this state or maintained as a part of a state-controlled system of public employment offices.

8 (11) "Hospital" has the meaning given that term in ORS 442.015.

9 (12) "Institution of higher education" means an educational institution that:

10 (a) Admits as regular students only individuals having a certificate of graduation from a high
11 school, or the recognized equivalent of such a certificate;

12 (b) Is legally authorized in this state to provide a program of education beyond high school;

13 (c) Provides an educational program for which it awards a bachelor's or higher degree, or pro-
14 vides a program that is acceptable for full credit toward such a degree, a program of post-graduate
15 or post-doctoral studies, or a program of training to prepare students for gainful employment in a
16 recognized occupation; and

17 (d) Is a public or other nonprofit institution.

18 (13) "Instructional capacity" does not include services performed as an instructional assistant
19 as defined in ORS 342.120.

20 (14) "Internal Revenue Code" means the federal Internal Revenue Code, as amended and in ef-
21 fect on December 31, [2023] **2025**.

22 (15) "Labor dispute" means any concerted or deliberate action by two or more individuals or
23 by an employing unit resulting in either a strike or lockout in which wages, hours, working condi-
24 tions or terms of employment of the individuals are involved.

25 (16) "Lockout" means any refusal by an employer to permit employees to work as a result of a
26 dispute with the employees affecting wages, hours or other terms or conditions of their employment.

27 (17) "Nonprofit employing unit" means an organization, or group of organizations, described in
28 section 501(c)(3) of the Internal Revenue Code that is exempt from income tax under section 501(a)
29 of the Internal Revenue Code.

30 (18) "PEO relationship" means an agreement between a PEO and a client employer under which
31 certain employer responsibilities for some or all of the client employer's workers are allocated.

32 (19)(a) "Professional employer organization" or "PEO" means a person required to be licensed
33 under ORS 656.855 that enters into a PEO relationship with a client employer.

34 (b) "Professional employer organization" or "PEO" does not mean a person that solely provides
35 workers to a client on a temporary basis or a person that provides payroll processing or similar
36 administrative services without assuming employer responsibilities for client workers.

37 (20) "State" includes, in addition to the states of the United States of America, the District of
38 Columbia and Puerto Rico. However, for all purposes of this chapter the Virgin Islands shall be
39 considered a state on and after the day on which the United States Secretary of Labor first approves
40 the Virgin Islands' law under section 3304(a) of the Federal Unemployment Tax Act as amended by
41 Public Law 94-566.

42 (21) "Strike" means any concerted act of employees in a lawful refusal under applicable state
43 or federal law to perform work or services for an employer.

44 (22) "Taxes" means contributions.

45 (23) "Temporary basis" means providing workers to a client:

1 (a) For special situations, including but not limited to employee absences, employee leaves, professional skill shortages, seasonal workloads and special assignments and projects with the expectation that the position will be terminated when the special situation ends.

4 (b) As probationary new hires with a reasonable expectation of transitioning to permanent employment with the client, if the client uses a preestablished probationary period in its overall employment selection program.

7 (24) "Valid claim" means any claim for benefits made in accordance with ORS 657.260 if the 8 individual meets the wages-paid-for-employment requirements of ORS 657.150.

9 (25) "Week" means any period of seven consecutive calendar days ending at midnight, as the 10 director may prescribe by rule.

11 **SECTION 32.** ORS 657B.010 is amended to read:

12 657B.010. As used in this chapter:

13 (1) "Alternate base year" means the last four completed calendar quarters preceding the benefit 14 year.

15 (2) "Average weekly wage" means the amount calculated by the Employment Department as the 16 state average weekly covered wage under ORS 657.150 (4)(e) as determined not more than once per 17 year.

18 (3) "Base year" means the first four of the last five completed calendar quarters preceding the benefit year.

20 (4) "Benefits" means family and medical leave insurance benefits.

21 (5)(a) "Benefit year" means, except as provided in paragraph (b) of this subsection, a period of 22 52 consecutive weeks beginning on the Sunday immediately preceding the date on which family 23 leave, medical leave or safe leave commences.

24 (b) "Benefit year" means, in the event that the 52-week period described in paragraph (a) of this 25 subsection would result in an overlap of any quarter of the base year of a previously filed valid 26 claim, a period of 53 consecutive weeks beginning on the Sunday immediately preceding the date 27 on which family leave, medical leave or safe leave commences.

28 (6) "Child" means:

29 (a) A biological child, adopted child, stepchild or foster child of a covered individual or of the 30 covered individual's spouse or domestic partner;

31 (b) A person who is or was a legal ward of a covered individual or of the covered individual's 32 spouse or domestic partner; or

33 (c) A person who is or was in a relationship of in loco parentis with a covered individual or 34 with the covered individual's spouse or domestic partner.

35 (7) "Claimant" means an individual who has submitted an application or established a claim for 36 benefits.

37 (8) "Contribution" or "contributions" means the money payments made by any of the following 38 under ORS 657B.150:

39 (a) An employer;

40 (b) An employee;

41 (c) A self-employed individual;

42 (d) A tribal government; or

43 (e) An employee of a tribal government.

44 (9) "Covered individual" means any one of the following who qualifies under ORS 657B.015 to 45 receive family and medical leave insurance benefits:

1 (a) An eligible employee;
2 (b) A self-employed individual; or
3 (c) An employee of a tribal government.

4 (10) "Domestic partner" means an individual joined in a domestic partnership.

5 (11) "Domestic partnership" has the meaning given that term in ORS 106.310.

6 (12) "Eligible employee" means:
7 (a)(A) An employee who has earned at least \$1,000 in wages during the base year; or
8 (B) If an employee has not earned at least \$1,000 in wages during the base year, an employee
9 who has earned at least \$1,000 in wages during the alternate base year; and
10 (b) An employee to whom paid family and medical leave insurance benefits may be available
11 under ORS 657B.015.

12 (13) "Eligible employee's average weekly wage" means an amount calculated by the Director of
13 the Employment Department by dividing the total wages earned by an eligible employee during the
14 base year by the number of weeks in the base year.

15 (14)(a) "Employee" means:
16 (A) An individual performing services for an employer for remuneration or under any contract
17 of hire, written or oral, express or implied.
18 (B) A home care worker as defined in ORS 410.600.
19 (b) "Employee" does not include:
20 (A) An independent contractor as defined in ORS 670.600.
21 (B) A participant in a work training program administered under a state or federal assistance
22 program.
23 (C) A participant in a work-study program that provides students in secondary or postsecondary
24 educational institutions with employment opportunities for financial assistance or vocational training.
25
26 (D) A railroad worker exempted under the federal Railroad Unemployment Insurance Act.
27 (E) A volunteer.
28 (F) A judge as defined in ORS 260.005.
29 (G) A member of the Legislative Assembly.
30 (H) A holder of public office as defined in ORS 260.005.

31 (15)(a) "Employer" means any person that employs one or more employees working anywhere in
32 this state or any agent or employee of such person to whom the duties of the person under this
33 chapter have been delegated.

34 (b) "Employer" includes:
35 (A) A political subdivision of this state or any county, city, district, authority or public corpor-
36 ation, or any instrumentality of a county, city, district, authority or public corporation, organized
37 and existing under law or charter;
38 (B) An individual;
39 (C) Any type of organization, corporation, partnership, limited liability company, association,
40 trust, estate, joint stock company or insurance company;
41 (D) Any successor in interest to an entity described in subparagraph (C) of this paragraph;
42 (E) A trustee, trustee in bankruptcy or receiver; or
43 (F) A trustee or legal representative of a deceased person.
44 (c) "Employer" does not include the federal government or a tribal government.
45 (16) "Employment agency" has the meaning given that term in ORS 658.005.

1 (17) "Family and medical leave insurance benefits" means the wage replacement benefits that
2 are available to a covered individual under ORS 657B.050 or under the terms of an employer plan
3 approved under ORS 657B.210, for family leave, medical leave or safe leave.

4 (18)(a) "Family leave" means leave from work taken by a covered individual:

5 (A) To care for and bond with a child during the first year after the child's birth or during the
6 first year after the placement of the child through foster care or adoption;

7 (B) To effectuate the legal process required for placement of a foster child or the adoption of
8 a child; or

9 (C) To care for a family member with a serious health condition.

10 (b) "Family leave" does not mean:

11 (A) Leave described in ORS 659A.159 (1)(a) except for leave to care for a child who requires
12 home care due to an illness, injury or condition that is a serious health condition;

13 (B) Leave described in ORS 659A.159 (1)(b); or

14 (C) Leave authorized under ORS 659A.093.

15 (19) "Family member" means:

16 (a) The spouse of a covered individual;

17 (b) A child or the child's spouse or domestic partner;

18 (c) A parent or the parent's spouse or domestic partner;

19 (d) A sibling or stepsibling of a covered individual or the sibling's or stepsibling's spouse or
20 domestic partner;

21 (e) A grandparent of a covered individual or the grandparent's spouse or domestic partner;

22 (f) A grandchild of a covered individual or the grandchild's spouse or domestic partner;

23 (g) The domestic partner of a covered individual; or

24 (h) Any individual related by blood or affinity whose close association with a covered individual
25 is the equivalent of a family relationship.

26 (20) "Medical leave" means leave from work taken by a covered individual that is made neces-
27 sary by the individual's own serious health condition.

28 (21) "Parent" means:

29 (a) A biological parent, adoptive parent, stepparent or foster parent of a covered individual;

30 (b) A person who was a foster parent of a covered individual when the covered individual was
31 a minor;

32 (c) A person designated as the legal guardian of a covered individual at the time the covered
33 individual was a minor or required a legal guardian;

34 (d) A person with whom a covered individual was or is in a relationship of in loco parentis; or

35 (e) A parent of a covered individual's spouse or domestic partner who meets a description under
36 paragraphs (a) to (d) of this subsection.

37 (22) "Safe leave" means leave taken for any purpose described in ORS 659A.272.

38 (23) "Self-employed individual" means:

39 (a) An individual who has self-employment income as defined in section 1402(b) of the Internal
40 Revenue Code as amended and in effect on December 31, [2023] 2025; or

41 (b) An independent contractor as defined in ORS 670.600.

42 (24) "Serious health condition" means:

43 (a) An illness, injury, impairment or physical or mental condition that requires inpatient care
44 in a hospital, hospice or residential medical care facility;

45 (b) An illness, disease or condition that in the medical judgment of the treating health care

1 provider poses an imminent danger of death, is terminal in prognosis with a reasonable possibility
 2 of death in the near future, or requires constant care;

3 (c) Any period of disability due to pregnancy, or period of absence for prenatal care; or
 4 (d) Any period of absence for the donation of a body part, organ or tissue, including preoperative
 5 or diagnostic services, surgery, post-operative treatment and recovery.

6 (25) "Third party administrator" means a third party that enters into an agreement with the
 7 Director of the Employment Department to implement and administer the paid family and medical
 8 leave program established under this chapter.

9 (26) "Tribal government" means:

10 (a) A tribal government as defined in ORS 181A.940; or
 11 (b) A federally recognized Indian tribe.

12 (27)(a) "Wages" has the meaning given that term in ORS 657.105.

13 (b) "Wages" does not mean contribution amounts paid to the Paid Family and Medical Leave
 14 Insurance Fund by an employer on behalf of an employee under ORS 657B.150 (5).

15 **SECTION 33.** (1) Except as provided in subsections (2) and (3) of this section, the
 16 amendments to statutes by sections 1 to 32 of this 2026 Act apply to transactions or activities
 17 occurring on or after January 1, 2026, in tax years beginning on or after January 1, 2026.

18 (2) The effective and applicable dates, and the exceptions, special rules and coordination
 19 with the Internal Revenue Code, as amended, relative to those dates, contained in federal law
 20 amending the Internal Revenue Code and enacted before January 1, 2026, apply for Oregon
 21 personal income and corporate excise and income tax purposes, to the extent they can be
 22 made applicable, in the same manner as they are applied under the Internal Revenue Code
 23 and related federal law.

24 (3)(a) If a deficiency is assessed against any taxpayer for a tax year beginning before
 25 January 1, 2026, and the deficiency or any portion thereof is attributable to any retroactive
 26 treatment under the amendments to ORS 178.300, 178.375, 305.239, 305.494, 305.690, 305.842,
 27 314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and 317A.100 by sections 1, 2
 28 and 16 to 29 of this 2026 Act, then any interest or penalty assessed under ORS chapter 305,
 29 314, 315, 316, 317, 317A or 318 with respect to the deficiency or portion thereof shall be can-
 30 celed.

31 (b) If a refund is due any taxpayer for a tax year beginning before January 1, 2026, and
 32 the refund or any portion thereof is due the taxpayer on account of any retroactive treat-
 33 ment under the amendments to ORS 178.300, 178.375, 305.239, 305.494, 305.690, 305.842, 314.011,
 34 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and 317A.100 by sections 1, 2 and 16
 35 to 29 of this 2026 Act for a tax year beginning before January 1, 2026, then notwithstanding
 36 ORS 305.270 or 314.415 or any other law, the refund or portion thereof shall be paid without
 37 interest.

38 (c) Any changes required because of the amendments to ORS 178.300, 178.375, 305.239,
 39 305.494, 305.690, 305.842, 314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and
 40 317A.100 by sections 1, 2 and 16 to 29 of this 2026 Act for a tax year beginning before January
 41 1, 2026, shall be made by filing an amended return within the time prescribed by law.

42 (d) If a taxpayer fails to file an amended return under paragraph (c) of this subsection,
 43 the Department of Revenue shall make any changes under paragraph (c) of this subsection
 44 on the return to which the changes relate within the period specified for issuing a notice of
 45 deficiency or claiming a refund as otherwise provided by law with respect to that return, or

1 **within one year after a return for a tax year beginning on or after January 1, 2026, and be-**
2 **fore January 1, 2027, is filed, whichever period expires later.**

3 **SECTION 34. This 2026 Act takes effect on the 91st day after the date on which the 2026**
4 **regular session of the Eighty-third Legislative Assembly adjourns sine die.**
