SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Requires schools to have a plan for a cardiac emergency, which must include AEDs. (Flesch Readability Score: 65.7).

Directs schools to have a cardiac emergency response plan as part of the procedures for responding to medical emergencies. Prescribes the requirements of a cardiac emergency response plan, including requirements related to automated external defibrillators.

Takes effect July 1, [2026] **2027**.

A BILL FOR AN ACT

2 Relating to procedures for medical emergencies in schools; creating new provisions; amending ORS
3 339.345 and 339.405; and prescribing an effective date.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 339.405 is amended to read:

6 339.405. (1) As used in this section:

7 (a) "Evacuate" means a procedure used when students and staff need to move from one location
8 to another.

9 (b) "Hold" means a procedure used to keep students and staff in classrooms while a disruption
10 or minor emergency is resolved.

11 (c) "Lockdown" means a procedure used when a threat or hazard is inside the building.

12 (d) "Secure" means a procedure used when a threat or hazard is outside the building.

13 (e) "Shelter in place" is a procedure used to respond to and take protective actions based on a
14 threat or hazard that may include an earthquake, tsunami or other natural or environmental hazard.

15 (2) Each school district must maintain a comprehensive safety program for all students and staff.

16 The program must include procedures for:

17 (a) Responding to emergency situations that address an immediate threat to safety, including an
18 evacuation, a hold, a lockdown, a secure and a shelter in place;

19 (b) Providing communicable disease management;

20 (c) Responding to medical emergencies, **including a cardiac emergency response plan that**
21 **complies with ORS 339.345;** and

22 (d) Providing instruction as described in ORS 339.408.

23 (3) The State Board of Education may adopt rules related to a program required under this
24 section.

25 **SECTION 2.** ORS 339.345 is amended to read:

26 339.345. [*Each school campus in a school district, private school campus and public charter school*

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 *campus shall have on the premises at least one automated external defibrillator.] Every kindergarten*
2 **through grade 12 public or private school is required to have a plan for cardiac emergency**
3 **responses. The plan must:**

4 (1) **To the greatest extent practicable, align with core elements established by a national**
5 **organization focused on emergency cardiovascular care.**

6 (2) **Include the provision of at least one automated external defibrillator at the school.**

7 (3) **Provide for the placement of automated external defibrillators in a manner that:**

8 (a) **To the greatest extent practicable, is in accordance with guidelines established by a**
9 **national organization focused on emergency cardiovascular care; and**

10 (b) **Is in locations that are clearly identified, unlocked and accessible when:**

11 (A) **Students are at school; and**

12 (B) **Students are at athletic practices or competitions at the school.**

13 (4) **Establish a procedure for the sharing of the locations of automated external**
14 **defibrillators at the school with local emergency medical services providers.**

15 (5) **Require the maintenance and testing of automated external defibrillators at the**
16 **school as provided by the manufacturer's guidelines.**

17 (6) **Require every coach, as defined in ORS 336.485, and other appropriate staff, as de-**
18 **termined by the school, to be trained in cardiopulmonary resuscitation and the use of auto-**
19 **mated external defibrillators.**

20 (7) **Provide for an annual review of the plan and review of whether the school is in**
21 **compliance with the plan.**

22 **SECTION 3. The amendments to ORS 339.345 and 339.405 by sections 1 and 2 of this 2026**
23 **Act first apply to the 2027-2028 school year.**

24 **SECTION 4. This 2026 Act takes effect on July 1, 2027.**

25
