

Senate Bill 1547

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Early Childhood and Behavioral Health for The Ballmer Institute for Children's Behavioral Health at the University of Oregon)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes a new profession called a licensed behavioral health and wellness practitioner. The Act says what the licensee can do. The Act also says that the licensee has to report some kinds of abuse. (Flesch Readability Score: 67.7).

Authorizes the Oregon Board of Psychology to issue a license to practice behavioral health promotion, prevention and brief intervention to a qualified applicant. Defines the "practice of behavioral health promotion, prevention and brief intervention" and "licensed behavioral health and wellness practitioner." Prohibits a person from using the title "licensed behavioral health and wellness practitioner" without a license.

Creates a licensed behavioral health and wellness practitioner-client privilege for certain communications. Requires a licensed behavioral health and wellness practitioner to report certain types of abuse.

Takes effect on the 91st day following adjournment sine die.

6 **Be It Enacted by the People of the State of Oregon:**

LICENSED BEHAVIORAL HEALTH AND WELLNESS PRACTITIONERS

SECTION 1. As used in sections 1 to 7 of this 2026 Act:

12 (1) **"Licensed behavioral health and wellness practitioner" means an individual licensed**
13 **under section 2 of this 2026 Act to practice behavioral health promotion, prevention and brief**
14 **intervention.**

15 (2) **"Licensed psychologist" has the meaning given that term in ORS 675.010.**

16 (3) **"Practice of behavioral health promotion, prevention and brief intervention" includes**
17 **the provision of the following services, either directly or indirectly, in an individual or group**
18 **format, with or without client caregivers or families:**

19 (a) **Early identification of behavioral health concerns, including identification through the**
20 **use of behavioral health screening;**

21 (b) **Psychoeducation;**

22 (c) **Skills training and skills support;**

23 (d) **Brief, evidence-based behavioral health interventions and prevention services;**

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (e) Risk identification and referral; and

2 (f) Collaboration, consultation and care coordination with other behavioral health pro-
3 viders.

4 **SECTION 2.** (1) The Oregon Board of Psychology may issue a license to practice behav-
5 ioral health promotion, prevention and brief intervention to an applicant who:

6 (a)(A) Holds a bachelor's degree or higher in behavioral health from a program approved
7 by the board that includes at least 700 hours of supervised practice in the delivery of be-
8 havioral health promotion, prevention and brief intervention services; or

9 (B) Holds a bachelor's degree or higher in a field other than behavioral health if the ap-
10 plicant has also completed a certification program approved by the board that includes at
11 least 700 hours of supervised practice in the delivery of behavioral health promotion, pre-
12 vention and brief intervention services;

13 (b) Has successfully completed any training required by the board by rule;

14 (c) Passes, to the satisfaction of the board, an examination required by the board by rule;

15 (d) Is determined by the board to be of good moral character, as described in ORS 675.030;

16 (e) Pays an application fee; and

17 (f) Meets other requirements established by the board by rule.

18 (2) The supervised practice described in subsection (1) of this section must be performed
19 under the supervision of an individual described in section 4 of this 2026 Act.

20 (3) The board may adopt rules to establish requirements for the renewal of a license is-
21 sued under this section.

22 (4) Moneys from fees collected under this section shall be deposited in the Oregon Board
23 of Psychology Account established under ORS 675.140.

24 **SECTION 3.** An individual whose license issued under section 2 of this 2026 Act has ex-
25 pired may apply as follows to the Oregon Board of Psychology to be relicensed:

26 (1) If the previous license has been expired for more than two years, the individual must
27 apply and qualify for the new license in the same manner as an individual who has never
28 been licensed.

29 (2)(a) If the previous license has been expired for two years or less, the individual must:

30 (A) Apply for relicensure in a manner required by the board;

31 (B) Meet any requirements for relicensure established by the board by rule; and

32 (C) Pay the fee established by the board.

33 (b) An individual who applies for relicensure under paragraph (a) of this subsection may
34 not be required to meet the requirements described in section 2 (1)(a) to (c) of this 2026 Act.

35 **SECTION 4.** (1) A licensed behavioral health and wellness practitioner may practice be-
36 havioral health promotion, prevention and brief intervention only under the direct super-
37 vision of a:

38 (a) Licensed psychologist;

39 (b) Physician licensed under ORS chapter 677 who has a specialty in psychiatry;

40 (c) Licensed professional counselor, as defined in ORS 675.705;

41 (d) Licensed marriage and family therapist, as defined in ORS 675.705;

42 (e) Clinical social worker licensed under ORS 675.530; or

43 (f) Nurse practitioner licensed under ORS 678.375 to 678.390 who has a specialty in psy-
44 chiatric mental health.

45 (2) The Oregon Board of Psychology may adopt rules to carry out this section, including

1 rules to establish requirements for supervision and a process for an individual described in
2 subsection (1) of this section to be an approved supervisor.

3 **SECTION 5.** An individual may not use the title “licensed behavioral health and wellness
4 practitioner” or similar title or initials unless the individual is a licensed behavioral health
5 and wellness practitioner.

6 **SECTION 6.** A licensed behavioral health and wellness practitioner may not:

7 (1) Engage in the practice of psychology, as described in ORS 675.010;

8 (2) Practice medicine, as described in ORS 677.085;

9 (3) Diagnose any physical, behavioral, emotional or mental disorder;

10 (4) Independently treat any physical, behavioral, emotional or mental disorder;

11 (5) Administer or interpret any individually administered intelligence, academic achieve-
12 ment or neuropsychological tests; or

13 (6) Evaluate the effects of any medical or psychotropic drugs.

14 **SECTION 7.** (1) If any of the grounds enumerated in subsection (2) of this section exist,
15 the Oregon Board of Psychology may impose any of the following sanctions:

16 (a) Deny a license to practice behavioral health promotion, prevention and brief inter-
17 vention;

18 (b) Refuse to renew or suspend or revoke a license to practice behavioral health pro-
19 motion, prevention and brief intervention;

20 (c) Issue a letter of reprimand;

21 (d) Impose probation with authority to require practice under increased supervision; or

22 (e) Impose a civil penalty as described under subsection (3) of this section.

23 (2) Subject to subsection (7) of this section, the board may impose a sanction listed in
24 subsection (1) of this section against a licensed behavioral health and wellness practitioner,
25 an applicant for a license to practice behavioral health promotion, prevention and brief
26 intervention or, if applicable, an unlicensed individual found in violation of sections 1 to 7 of
27 this 2026 Act, if, in the board’s judgment, the licensee, applicant or individual:

28 (a) Has an impairment as defined in ORS 676.303;

29 (b) Has been convicted of a violation of law related to controlled substances;

30 (c) Has been convicted of a felony or misdemeanor involving moral turpitude;

31 (d) Is guilty of immoral or unprofessional conduct or of gross negligence in the practice
32 of behavioral health promotion, prevention and brief intervention, including but not limited
33 to:

34 (A) Conduct or practice contrary to recognized standards of ethics of the profession or
35 that constitutes a danger to the health or safety of a patient or the public;

36 (B) Conduct, practice or a condition that adversely affects the ability of a licensed be-
37 havioral health and wellness practitioner or an applicant for a license to practice behavioral
38 health promotion, prevention and brief intervention to practice safely and skillfully; or

39 (C) Having practiced outside the authorized scope of practice for a licensed behavioral
40 health and wellness practitioner;

41 (e) Has obtained, or attempted to obtain, a license to practice behavioral health pro-
42 motion, prevention and brief intervention by fraud or material misrepresentation;

43 (f) Has impersonated a licensed behavioral health and wellness practitioner, or allowed
44 another individual to use the license of a licensed behavioral health and wellness practi-
45 tioner;

1 (g) Has violated a provision of sections 1 to 7 of this 2026 Act or ORS 675.850, any appli-
 2 cable rule of the board or the code of professional conduct adopted under ORS 675.110; or

3 (h) Notwithstanding ORS 670.280, has been convicted of a sex crime as defined in ORS
 4 163A.005 or has been convicted in another state or jurisdiction of a crime that is substan-
 5 tially equivalent to a sex crime as defined in ORS 163A.005.

6 (3) The board may impose a civil penalty under subsection (1) of this section in an
 7 amount not to exceed:

8 (a) \$2,500; or

9 (b) \$5,000, if any of the following conditions exist:

10 (A) The conduct giving rise to the penalty had a serious detrimental effect on the health
 11 or safety of another person;

12 (B) The individual subject to the penalty has a history of discipline for the same or sim-
 13 ilar conduct;

14 (C) The conduct giving rise to the penalty involves a willful or reckless disregard for the
 15 law;

16 (D) The conduct giving rise to the penalty was perpetrated against a minor, elderly per-
 17 son or person with a disability; or

18 (E) The individual subject to the penalty violated section 5 of this 2026 Act.

19 (4) Except as provided in subsection (7) of this section, if a conviction described in sub-
 20 section (2) of this section is used as grounds for discipline described in subsection (1) of this
 21 section, a certified copy of the record of the conviction shall be conclusive evidence.

22 (5) The board may license an applicant or renew or restore a licence suspended or re-
 23 voked under subsection (2)(a) of this section due to a mental health condition if the board
 24 determines that the applicant or previously licensed individual no longer has an impairment
 25 due to a mental health condition.

26 (6) Except as provided in subsection (7) of this section, license suspension or revocation
 27 in another state is grounds for license denial or other disciplinary action by the board.

28 (7) The board may not suspend or revoke an individual’s license, or refuse to grant a li-
 29 cense to an individual, because of a conviction or license suspension or revocation resulting
 30 solely from the individual’s provision of licensed services related to reproductive or gender-
 31 affirming health care that are otherwise lawful in this state but unlawful in the jurisdiction
 32 in which the individual provided the services, so long as the services provided were per-
 33 formed in accordance with the standard of care applicable to the services.

34 **SECTION 8.** ORS 675.010 is amended to read:

35 675.010. As used in ORS 675.010 to 675.150, unless the context requires otherwise:

36 (1) “Approved doctoral program in psychology” means a doctoral program in psychology ac-
 37 credited by the American Psychological Association or a doctoral program in psychology accredited
 38 individually or as part of an institutional accreditation by another private or governmental accred-
 39 iting agency, when the association’s or agency’s standards and procedures have been approved by
 40 the Oregon Board of Psychology by rule.

41 [(2) “Board” means the Oregon Board of Psychology.]

42 (2) “Licensed behavioral health and wellness practitioner” has the meaning given that
 43 term in section 1 of this 2026 Act.

44 (3) “Licensed psychologist” means a person licensed to practice psychology under the provisions
 45 of ORS 675.010 to 675.150.

1 **(4) “Practice of behavioral health promotion, prevention and brief intervention” has the**
 2 **meaning given that term in section 1 of this 2026 Act.**

3 [(4)] **(5) “Practice of psychology”** means rendering or offering to render supervision, consulta-
 4 tion, evaluation or therapy services to individuals, groups or organizations for the purpose of diag-
 5 nosing or treating behavioral, emotional or mental disorders. “Practice of psychology” also includes
 6 delegating the administration and scoring of tests to technicians qualified by and under the direct
 7 supervision of a licensed psychologist.

8 [(5)] **(6) “State”** means any state or territory of the United States and the District of Columbia.

9 **SECTION 9.** ORS 675.075 is amended to read:

10 675.075. (1) Any information that the Oregon Board of Psychology obtains under ORS 675.070
 11 or 675.085 **or section 7 of this 2026 Act** is confidential as provided under ORS 676.175.

12 (2) Any person who in good faith provides information to the board shall not be subject to an
 13 action for civil damages as a result thereof.

14 **SECTION 10.** ORS 675.085 is amended to read:

15 675.085. (1) Upon receipt of a complaint under ORS 675.010 to 675.150 **or sections 1 to 7 of this**
 16 **2026 Act**, the Oregon Board of Psychology shall conduct an investigation as described under ORS
 17 676.165.

18 (2) Where the board proposes to refuse to issue a license or to impose any disciplinary action
 19 under ORS 675.070 **or section 7 of this 2026 Act**, opportunity for hearing shall be accorded as
 20 provided in ORS chapter 183. The board shall render its decision within 30 days after the hearing.

21 (3) Adoption of rules, conduct of hearings, issuance of orders and judicial review of rules and
 22 orders shall be as provided in ORS chapter 183.

 26 chology or by the decision of a court of law, or the voluntary surrender of a license by a licensee,
 27 does not deprive the board of jurisdiction to proceed with any investigation of or any action or
 28 disciplinary proceeding against the licensee or to revise or render null and void an order suspending
 29 or revoking the license.

30 **SECTION 12.** ORS 675.110 is amended to read:

31 675.110. In addition to the powers otherwise granted under ORS 675.010 to 675.150 **and sections**
 32 **1 to 7 of this 2026 Act**, the Oregon Board of Psychology has all powers necessary or proper to:

33 (1) Determine qualifications of applicants to practice psychology **and behavioral health pro-**
 34 **motion, prevention and brief intervention** in this state, prepare, conduct and grade examinations
 35 and license qualified applicants who comply with the provisions of ORS 675.010 to 675.150 **or**
 36 **sections 1 to 7 of this 2026 Act** and the rules of the board.

37 (2) Grant or deny renewal of licenses and renew licenses that have lapsed for nonpayment of the
 38 renewal fee, subject to the provisions of ORS 675.010 to 675.150 **and sections 1 to 7 of this 2026**
 39 **Act.**

40 (3) Suspend or revoke licenses, subject to ORS 675.010 to 675.150 **and sections 1 to 7 of this**
 41 **2026 Act.**

42 (4) Issue letters of reprimand and impose probationary periods with the authority to restrict the

44 **(a)** Licensed psychologist or to require practice under supervision.

45 **(b) Licensed behavioral health and wellness practitioner or to require practice under in-**

1 **creased supervision.**

2 (5) Impose civil penalties as provided in ORS 675.070 **and section 7 of this 2026 Act.**

3 (6) Restore licenses that have been suspended or revoked or voided by nonpayment of the re-
4 newal fee.

5 (7) Collect fees for application, examination and licensing of applicants, for renewal of licenses
6 and for issuance of limited permits and use the fees to defray the expenses of the board as provided
7 in ORS 675.140.

8 (8) Collect a delinquent renewal fee for licenses renewed after the deadline for renewal but be-
9 fore the grace period for renewal has expired.

10 (9) Investigate alleged violations of ORS 675.010 to 675.150 **and sections 1 to 7 of this 2026**
11 **Act and any rules adopted thereunder.**

27 for the issuance of licenses for areas of special competence.

28 **(b) Providing ethical services as a licensed behavioral health and wellness practitioner in**
29 **this state, including the formulation of standards for the issuance of licenses for areas of**
30 **special competence.**

31 (15) Formulate and enforce continuing education requirements for duly licensed psychologists
32 **and licensed behavioral health and wellness practitioners** to ensure the highest quality of pro-
33 fessional services to the public.

34 (16) Deny renewal of a license **to practice psychology**, or renewal of a license **to practice**
35 **psychology** that has lapsed for nonpayment of the renewal fee, unless the applicant completes, or
36 provides documentation of completion within the previous 36 months of:

37 **(a)** A one-hour pain management education program approved by the board and developed based
38 on recommendations of the Pain Management Commission; or

39 **(b)** An equivalent pain management education program, as determined by the board.

40 (17) Assess costs associated with a disciplinary action to the person against whom the board
41 takes the disciplinary action, as follows:

42 **(a)** For total costs of \$3,000 or less, the board may not assess any costs.

43 **(b)** For total costs greater than \$3,000 but not greater than \$6,000, the board may assess up to
44 50 percent of the total costs.

41 Oregon Board of Psychology Account are continuously appropriated to the board for the purpose

45 675.145. Unless state or federal laws relating to confidentiality or the protection of health in-

 3 prohibited conduct as defined in ORS 676.150 shall report the prohibited conduct in the manner

6 675.150. *[The Oregon Board of Psychology may institute and commence injunction proceedings in*
 7 *any circuit court in Oregon to enjoin the unlawful practice of psychology. In any such proceeding it*
 8 *shall not be necessary to show that any person is individually injured by the actions complained of.*
 9 *If the person complained of is found by the court to have unlawfully engaged in practice of psychology,*
 10 *the court may enjoin the person from so practicing. Procedure in such cases shall be the same as any*
 11 *other injunction suit. The remedy by injunction hereby given is in addition to criminal prosecution and*
 12 *punishment.]*

13 **(1) The Oregon Board of Psychology may institute and commence injunction proceedings**
 14 **in any circuit court in Oregon to enjoin:**

28 675.166. The Mental Health Regulatory Agency shall provide administrative and regulatory
 29 oversight and centralized service for:

30 (1) The Oregon Board of Licensed Professional Counselors and Therapists, as provided in ORS
 31 675.715 to 675.835; and

32 (2) The Oregon Board of Psychology, as provided in ORS 675.010 to 675.150 **and sections 1 to**
 33 **7 of this 2026 Act.**

35 675.178. (1) The Mental Health Regulatory Agency is under the supervision and control of the
 36 Director of the Mental Health Regulatory Agency, who is responsible for the performance of the

19 a medical institution or any care or services for any individual who has attained 65 years of age
20 or is under 22 years of age, and who is a patient in a private or public institution for mental dis-
21 eases. Except as provided in ORS 411.439 and 411.447, "medical assistance" does not include care
22 or services for a resident of a nonmedical public institution.

23 (21) "Mental health drug" means a type of legend drug, as defined in ORS 414.325, specified by
24 the Oregon Health Authority by rule, including but not limited to:

25 (a) Therapeutic class 7 ataractics-tranquilizers; and

26 (b) Therapeutic class 11 psychostimulants-antidepressants.

27 (22) "Patient centered primary care home" means a health care team or clinic that is organized
28 in accordance with the standards established by the Oregon Health Authority under ORS 414.655
29 and that incorporates the following core attributes:

30 (a) Access to care;

31 (b) Accountability to consumers and to the community;

32 (c) Comprehensive whole person care;

33 (d) Continuity of care;

34 (e) Coordination and integration of care; and

35 (f) Person and family centered care.

36 (23) "Peer support specialist" means any of the following individuals who meet qualification
37 criteria adopted by the authority under ORS 414.665 and who provide supportive services to a cur-
38 rent or former consumer of mental health or addiction treatment:

39 (a) An individual who is a current or former consumer of mental health treatment; or

40 (b) An individual who is in recovery, as defined by the Oregon Health Authority by rule, from
41 an addiction disorder.

42 (24) "Peer wellness specialist" means an individual who meets qualification criteria adopted by
43 the authority under ORS 414.665 and who is responsible for assessing mental health and substance
44 use disorder service and support needs of a member of a coordinated care organization through
45 community outreach, assisting members with access to available services and resources, addressing

1 barriers to services and providing education and information about available resources for individ-
2 uals with mental health or substance use disorders in order to reduce stigma and discrimination
3 toward consumers of mental health and substance use disorder services and to assist the member
4 in creating and maintaining recovery, health and wellness.

5 (25) "Person centered care" means care that:

6 (a) Reflects the individual patient's strengths and preferences;

7 (b) Reflects the clinical needs of the patient as identified through an individualized assessment;
8 and

9 (c) Is based upon the patient's goals and will assist the patient in achieving the goals.

10 (26) "Personal health navigator" means an individual who meets qualification criteria adopted
11 by the authority under ORS 414.665 and who provides information, assistance, tools and support to
12 enable a patient to make the best health care decisions in the patient's particular circumstances and
13 in light of the patient's needs, lifestyle, combination of conditions and desired outcomes.

14 (27) "Prepaid managed care health services organization" means a managed dental care, mental
15 health or chemical dependency organization that contracts with the authority under ORS 414.654
16 or with a coordinated care organization on a prepaid capitated basis to provide health services to
17 medical assistance recipients.

18 (28) "Quality measure" means the health outcome and quality measures and benchmarks identi-
19 fied by the Health Plan Quality Metrics Committee and the metrics and scoring subcommittee in
20 accordance with ORS 413.017 (4) and 413.022 and the quality metrics developed by the Behavioral
21 Health Committee in accordance with ORS 413.017 (5).

22 (29)(a) "Quality of life in general measure" means an assessment of the value, effectiveness or
23 cost-effectiveness of a treatment that gives greater value to a year of life lived in perfect health than
24 the value given to a year of life lived in less than perfect health.

25 (b) "Quality of life in general measure" does not mean an assessment of the value, effectiveness
26 or cost-effectiveness of a treatment during a clinical trial in which a study participant is asked to
27 rate the participant's physical function, pain, general health, vitality, social functions or other sim-
28 ilar domains.

29 (30) "Resources" has the meaning given that term in ORS 411.704. For eligibility purposes, "re-
30 sources" does not include charitable contributions raised by a community to assist with medical
31 expenses.

32 (31) "Social determinants of health" means:

33 (a) Nonmedical factors that influence health outcomes;

34 (b) The conditions in which individuals are born, grow, work, live and age; and

35 (c) The forces and systems that shape the conditions of daily life, such as economic policies and
36 systems, development agendas, social norms, social policies, racism, climate change and political
37 systems.

38 (32) "Tribal traditional health worker" means an individual who meets qualification criteria
39 adopted by the authority under ORS 414.665 and who:

40 (a) Has expertise or experience in public health;

41 (b) Works in a tribal community or an urban Indian community, either for pay or as a volunteer
42 in association with a local health care system;

43 (c) To the extent practicable, shares ethnicity, language, socioeconomic status and life experi-
44 ences with the residents of the community the worker serves;

45 (d) Assists members of the community to improve their health, including physical, behavioral and

1 oral health, and increases the capacity of the community to meet the health care needs of its resi-
 2 dents and achieve wellness;

3 (e) Provides health education and information that is culturally appropriate to the individuals
 4 being served;

5 (f) Assists community residents in receiving the care they need;

6 (g) May give peer counseling and guidance on health behaviors; and

7 (h) May provide direct services, such as tribal-based practices.

8 (33)(a) “Youth support specialist” means an individual who meets qualification criteria adopted
 9 by the authority under ORS 414.665 and who, based on a similar life experience, provides supportive
 10 services to an individual who:

11 (A) Is not older than 30 years of age; and

12 (B)(i) Is a current or former consumer of mental health or addiction treatment; or

13 (ii) Is facing or has faced difficulties in accessing education, health and wellness services due
 14 to a mental health or behavioral health barrier.

15 (b) A “youth support specialist” may be a peer wellness specialist or a peer support specialist.

16 **SECTION 32.** ORS 675.661 is amended to read:

17 675.661. A public or private entity that employs mental health care providers who supervise
 18 associates, interns or other individuals who must have supervised clinical experience as a condition
 19 of licensure as a mental health care provider shall pay all costs incurred by the supervisor in pro-
 20 viding supervision and the costs of the individual receiving supervision if the supervisor is:

21 (1) A licensed psychologist, as defined in ORS 675.010;

22 (2) A clinical social worker licensed under ORS 675.530;

23 (3) A master’s social worker licensed under ORS 675.533;

24 (4) A licensed marriage and family therapist, as defined in ORS 675.705; [or]

25 (5) A licensed professional counselor, as defined in ORS 675.705[.]; **or**

26 **(6) A licensed behavioral health and wellness practitioner, as defined in section 1 of this**
 27 **2026 Act.**

28 **SECTION 33.** ORS 675.850 is amended to read:

29 675.850. (1) A mental health care or social health professional may not practice conversion
 30 therapy if the recipient of the conversion therapy is under 18 years of age.

31 (2) As used in this section:

32 (a)(A) “Conversion therapy” means providing professional services for the purpose of attempting
 33 to change a person’s sexual orientation or gender identity, including attempting to change behaviors
 34 or expressions of self or to reduce sexual or romantic attractions or feelings toward individuals of
 35 the same gender.

36 (B) “Conversion therapy” does not mean:

37 (i) Counseling that assists a client who is seeking to undergo a gender transition or who is in
 38 the process of undergoing a gender transition; or

39 (ii) Counseling that provides a client with acceptance, support and understanding, or counseling
 40 that facilitates a client’s coping, social support and identity exploration or development, including
 41 counseling in the form of sexual orientation-neutral or gender identity-neutral interventions provided
 42 for the purpose of preventing or addressing unlawful conduct or unsafe sexual practices, as long as
 43 the counseling is not provided for the purpose of attempting to change the client’s sexual orientation
 44 or gender identity.

45 (b)(A) “Mental health care or social health professional” means:

1 (i) A licensed psychologist as defined in ORS 675.010;

2 (ii) A psychologist associate licensed by the Oregon Board of Psychology before January 1, 2022;

3 **(iii) A licensed behavioral health and wellness practitioner as defined in section 1 of this**
4 **2026 Act;**

5 [(iii)] (iv) An occupational therapist or occupational therapy assistant both as defined in ORS
6 675.210;

7 [(iv)] (v) A regulated social worker as defined in ORS 675.510;

8 [(v)] (vi) A licensed marriage and family therapist or licensed professional counselor both as
9 defined in ORS 675.705;

10 [(vi)] (vii) An individual who provides counseling as part of an educational or training program
11 necessary to practice any of the professions described in sub-subparagraphs (i) to [(v)] (vi) of this
12 subparagraph; and

13 [(vii)] (viii) A behavior analyst or assistant behavior analyst licensed under ORS 676.810 or a
14 behavior analysis interventionist registered under ORS 676.815.

15 (B) “Mental health care or social health professional” includes any individual not described in
16 this paragraph who is licensed in this state and whose license authorizes the individual to provide
17 mental health care or social health counseling services.

18 (3) Any state board that regulates licensees described in subsection (2)(b)(B) of this section may
19 impose any form of discipline that the board may impose on a licensee under the laws of this state
20 for violating a law of this state or a rule adopted by the board.

30 **SECTION 35. (1) The amendments to ORS 124.050, 192.556, 414.025, 419B.005, 430.735,**
31 **609.652, 675.661 and 675.850 by sections 25 to 33 of this 2026 Act become operative on January**
32 **1, 2027.**

33 **(2) The Department of Human Services and the Oregon Board of Psychology may take**
34 **any action before the operative date specified in subsection (1) of this section that is neces-**
35 **sary to enable the board and the department to exercise, on and after the operative date**
36 **specified in subsection (1) of this section, all of the duties, functions and powers conferred**
37 **on the board and the department by the amendments to ORS 124.050, 192.556, 414.025,**
38 **419B.005, 430.735, 609.652, 675.661 and 675.850 by sections 25 to 33 of this 2026 Act.**

39 **SECTION 36. This 2026 Act takes effect on the 91st day after the date on which the 2026**
40 **regular session of the Eighty-third Legislative Assembly adjourns sine die.**
