

# Senate Concurrent Resolution 203

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. ## CONCURRENT RESOLUTION

Whereas Moses Ross was born on June 20, 1966; and

Whereas at an early age Moses Ross learned from the example of his hardworking grandparents, immigrants from Mexico to the mid-Willamette Valley, that "as parents, you do what is necessary to provide for your family and strive to ensure the American dream for your progeny and for your community"; and

Whereas Moses Ross attended schools in Utah, Wyoming and Ontario, Canada, before making his home in Portland in the late 1980s; and

Whereas in 1989 Moses Ross began working for the Lake Oswego Review, and that experience motivated him to start his own publication, a 50,000-circulation quarterly magazine for the local licensed holistic healthcare community that ran from 1990 to 1995; and

Whereas spurred on by his grandparents' example, Moses Ross was indeed a fierce advocate for his communities of Multnomah Village and greater Southwest Portland, and was known affectionately by those for whom he fought so tirelessly as the "Mayor of Multnomah Village"; and

Whereas as President of the Multnomah Neighborhood Association, Moses Ross proudly established the first tiny pod village in Southwest Portland, providing a port in a storm for the community's houseless population; and

Whereas Moses Ross was an engaged and accomplished small business owner, operating the nationally recognized and award winning political organizations Smart Voter Contact and PoliticalRobocalls.com; and

Whereas in 2010, the magazine Campaigns & Elections named Moses Ross and PoliticalRobocalls.com as the recipient of a prestigious Reed Award, recognizing his excellence in political campaigning; and

Whereas Moses Ross was also a repeat winner of the American Association of Political Consultants' "Pollie" Award, honoring excellence in polling and voter engagement; and

Whereas Moses Ross was again recognized as a Reed Award winner in 2013 for Best Overall Use of a Telephone Town Hall for Washington State Representative Larry Seaquist; and

Whereas Moses Ross delivered frequent electoral wins and robust voter engagement for congressional and statewide campaigns, school board candidates, city councilors, county commissioners,

1 state legislators, labor unions and nonprofits in Oregon and across the nation; and

2 Whereas Moses Ross was also deeply respected for his volunteer work within the Democratic  
3 Party of Oregon, where he cofounded the Democratic Party of Oregon Latino Caucus and served  
4 as a delegate to the Democratic National Convention in 2008, 2016, 2020 and 2024; and

5 Whereas as a steadfast and outspoken advocate for election reform, Moses Ross served on the  
6 Multnomah County Charter Review Committee, which laid the groundwork for the successful City  
7 of Portland Honest Elections campaign (Measure 26-200), securing more than 87 percent approval  
8 from Portland voters; and

9 Whereas Moses Ross was committed to local news, highlighting community issues as a host of  
10 PDX Progressive Talk Radio on KBOO Community Radio and at the Willamette Falls Media Center;  
11 and

12 Whereas whenever there was an opportunity to fight for a cause, Moses Ross showed up, making  
13 calls, walking turf, marching in parades and working tables; and

14 Whereas Moses Ross always endeavored to find common ground and workable solutions for  
15 Oregon's most challenging issues, and his approach to each and every one of them was built on the  
16 foundations of equity, equality and accessibility; and

17 Whereas Moses Ross was remembered by Willamette Week for his effective volunteer work, his  
18 relentless positivity and kindness and his unrelenting advocacy for all those who call Portland home;  
19 and

20 Whereas whether running for office, taking on new community or political responsibilities, ex-  
21 panding his business or coordinating neighborhood projects, Moses Ross dedicated himself to making  
22 the world a better place for all; and

23 Whereas despite his unrelenting involvement in politics and in his communities, Moses Ross was  
24 also a dedicated single father and best friend to his cherished daughter, Emma, and he strove above  
25 all to teach her that one person truly can make a difference; and

26 Whereas Emma remembers her dad as a loving, nerdy, amazing, one-of-a-kind person who was  
27 "everything good"; and

28 Whereas Moses Ross passed away at his home in Multnomah Village at the tender age of 58 on  
29 April 23, 2025; now, therefore,

30 **Be It Resolved by the Legislative Assembly of the State of Oregon:**

31 That we, the members of the Eighty-third Legislative Assembly, honor and celebrate the life and  
32 legacy of Moses Ross, and we recognize him as a force for good whose dedication improved the lives  
33 of many across our state; and be it further

34 Resolved, That we recognize Moses Ross as the honorary "Mayor Emeritus of Multnomah Vil-  
35 lage"; and be it further

36 Resolved, That a copy of this resolution shall be presented to Emma Ross as an expression of  
37 our sympathy and condolences.
