**PROPOSED AMENDMENTS TO
SENATE BILL 1527**

1 On page 1 of the printed bill, line 2, after “ORS” insert “243.144, 243.877
2 and”.

3 Delete lines 13 and 14 and insert:

4 “(b)(A) ‘Follow-up examination’ means any necessary diagnostic testing
5 required after an abnormal cervical cancer screening result to fully evaluate
6 for potential malignancy.”.

7 In line 17, delete “Except as provided in ORS 742.008.”.

8 In line 24, after “screening.” delete the rest of the line and line 25 and
9 insert “Follow-up examinations include colposcopy, biopsy and additional
10 cytology or human papillomavirus tests.

11 “(3) This section is exempt from ORS 743A.001.”.

12 On page 5, after line 8, insert:

10 **date of this 2026 Act, and to self-insured health benefit plans in effect**
11 **for periods beginning on or after the effective date of this 2026 Act.”.**
