**PROPOSED AMENDMENTS TO
SENATE BILL 1557**

1 On page 1 of the printed bill, line 2, after “33.075” insert “, 109.232”.

2 After line 3, insert:

4 **“CONTEMPT PROCEEDINGS”.**

6 On page 6, delete lines 19 through 21 and insert:

8 **“PARENTAGE PROCEEDINGS**

10 **“SECTION 7.** ORS 109.232 is amended to read:

11 “109.232. (1) *[A petition and any other document related to a surrogacy*
12 *agreement filed with the court shall be sealed,]* **A case for determination**
13 **of parentage of a child born by assisted reproduction under a**
14 **gestational surrogacy agreement shall be confidential**, exempt from
15 public disclosure under ORS 192.311 to 192.478 and may not be disclosed ex-
16 cept:

17 “(a) To a party to the proceeding;

18 “(b) To a child conceived by assisted reproduction under the agreement;

19 “(c) To an attorney of a party to the proceeding or a child conceived by
20 assisted reproduction under the agreement;

21 “(d) The court; or

1 “(e) Pursuant to a court order for good cause shown, and subject to the
2 provisions of ORS 192.324.

3 “(2) The individual seeking to inspect the document may be required to pay
4 the expense of preparing a copy of the document to be inspected.]

5 “(2) If an individual authorized to access the case seeks copies of
6 case documents, the court may require the individual to pay the ex-
7 pense of preparing copies of the documents.

8 **“SECTION 8.** Upon the motion of a party to a case described in ORS
9 109.232 that was initiated before September 29, 2025, the court shall
10 make the case confidential and subject to the confidentiality pro-
11 visions prescribed in ORS 109.232.

“APPLICABILITY

15 **“SECTION 9. Section 6 of this 2026 Act and the amendments to ORS**
16 **33.055, 33.065, 33.075 and 476.274 by sections 1 to 4 of this 2026 Act apply**
17 **to contempt proceedings initiated on or after the effective date of this**
18 **2026 Act.**

19 **“SECTION 10.** The amendments to ORS 109.232 by section 7 of this
20 2026 Act apply to cases initiated on or after September 29, 2025, and,
21 upon motion of a party to the case, to cases initiated before September
22 29, 2025.

26 **“SECTION 11.** The unit captions used in this 2026 Act are provided

29 enactment of this 2026 Act.”.
