**PROPOSED AMENDMENTS TO
HOUSE BILL 4148**

1 On page 1 of the printed bill, delete lines 5 through 22 and delete pages
2 2 and 3 and insert:

3 **“SECTION 1.** ORS 320.350 is amended to read:

4 “320.350. (1) A unit of local government that did not impose a local
5 transient lodging tax on July 1, 2003, may not impose a local transient
6 lodging tax on or after July 2, 2003, unless the imposition of the local tran-
7 sient lodging tax was approved on or before July 1, 2003.

8 “(2) A unit of local government that imposed a local transient lodging tax
9 on July 1, 2003, may not increase the rate of the local transient lodging tax
10 on or after July 2, 2003, to a rate that is greater than the rate in effect on
11 July 1, 2003, unless the increase was approved on or before July 1, 2003.

12 “(3) A unit of local government that imposed a local transient lodging tax
13 on July 1, 2003, may not decrease the percentage of total local transient
14 lodging tax revenues that are actually expended to fund tourism promotion
15 or tourism-related facilities on or after July 2, 2003. A unit of local govern-
16 ment that agreed, on or before July 1, 2003, to increase the percentage of
17 total local transient lodging tax revenues that are to be expended to fund
18 tourism promotion or tourism-related facilities, must increase the percentage
19 as agreed.

20 “(4) Notwithstanding subsections (1) and (2) of this section, a unit of local
21 government that is financing debt with local transient lodging tax revenues

1 on November 26, 2003, must continue to finance the debt until the retirement
2 of the debt, including any refinancing of that debt. If the tax is not otherwise
3 permitted under subsection (1) or (2) of this section, at the time of the debt
4 retirement:

5 “(a) The local transient lodging tax revenue that financed the debt shall
6 be used as provided in subsection (5) of this section; or

7 “(b) The unit of local government shall thereafter eliminate the new tax
8 or increase in tax otherwise described in subsection (1) or (2) of this section.

9 “(5) Subsections (1) and (2) of this section do not apply to a new or in-
10 creased local transient lodging tax if all of the net revenue from the new or
11 increased tax, following reductions attributed to collection reimbursement
12 charges, is used consistently with subsection (6) of this section to:

13 “(a) Fund tourism promotion, [or] tourism-related facilities **or resiliency**
14 **grants for small businesses in the restaurant and lodging industry;**

15 “(b) Fund city or county services, **whether emergency or non-**
16 **emergency services, provided directly by the city or county or by a**
17 **special district in lieu of the city or county;** or

18 “(c) Finance or refinance the debt of tourism-related facilities and pay
19 reasonable administrative costs incurred in financing or refinancing that
20 debt, provided that:

21 “(A) The net revenue may be used for administrative costs only if the unit
22 of local government provides a collection reimbursement charge; and

23 “(B) Upon retirement of the debt, the unit of local government reduces
24 the tax by the amount by which the tax was increased to finance or refinance
25 the debt.

26 “(6)(a) At least [70] **50** percent of net revenue from a new or increased
27 local transient lodging tax shall be used for the purposes described in sub-
28 section (5)(a) or (c) of this section.

29 “(b) No more than [30] **50** percent of net revenue from a new or increased
30 local transient lodging tax may be used for the purpose described in sub-

1 section (5)(b) of this section.

2 **“(7)(a) Notwithstanding subsection (1) of this section, a unit of local**
3 **government may use unexpended net revenue collected before the ef-**
4 **fective date of this 2026 Act from a new tax described in subsection (1)**
5 **of this section in accordance with subsection (6) of this section.**

6 **“(b) Notwithstanding subsection (2) of this section, a unit of local**
7 **government may use unexpended net revenue collected before the ef-**
8 **fective date of this 2026 Act that is attributable to the rate of the local**
9 **transient lodging tax in effect on July 1, 2003, and to any increase in**
10 **the rate made on or after July 2, 2003, in accordance with subsection**
11 **(6) of this section.**

12 **“(c) Notwithstanding subsection (3) of this section, a unit of local**
13 **government may, in accordance with subsection (6) of this section,**
14 **decrease the percentage of total local transient lodging tax revenues**
15 **that are actually expended to fund tourism promotion or tourism-**
16 **related facilities regardless of when the percentage went into effect.**

17 **“SECTION 2. The amendments to ORS 320.350 by section 1 of this**
18 **2026 Act become operative on January 1, 2027.**

19 **“SECTION 3. The amendments to ORS 320.350 by section 1 of this**
20 **2026 Act apply to net revenue collected by units of local government**
21 **before, on or after the effective date of this 2026 Act.**

22 **“SECTION 4. (1)(a) A unit of local government that imposes a local**
23 **transient lodging tax under ORS 320.345 to 320.365 shall file a biennial**
24 **report with the Legislative Revenue Officer no later than September**
25 **1 of each odd-numbered year, beginning in 2027.**

26 **“(b) Upon request by one or more cities or counties, the League of**
27 **Oregon Cities or the Association of Oregon Counties, respectively, may**
28 **file the report on behalf of the cities or counties.**

29 **“(2) The report must include the following information with respect**
30 **to total transient lodging tax revenue:**

1 **“(a) For the preceding two fiscal years:**

2 **“(A) The tax rates imposed, setting forth separately those rates that**
3 **were imposed or increased on or before July 1, 2003, and those rates**
4 **that were imposed or increased on or after July 2, 2003;**

5 **“(B) Total revenue collected;**

6 **“(C) The amount and percentage of revenue used to fund tourism**
7 **promotion, including revenue expended under agreements with desti-**
8 **nation management organizations;**

9 **“(D) The amount and percentage of revenue used to fund tourism-**
10 **related facilities;**

11 **“(E) The amount and percentage of revenue used to fund resiliency**
12 **grants for small businesses in the restaurant and lodging industry; and**

13 **“(F) The amount and percentage of revenue used to fund city or**
14 **county services;**

15 **“(b) The amount of revenue held in capital reserves, with a de-**
16 **scription of its intended purpose;**

17 **“(c) Any changes to allocation methods or use definitions, including**
18 **those approved by the voters or unit of local government; and**

19 **“(d) A summary of advisory board meetings or oversight actions,**
20 **if applicable.**

21 **“(3)(a) Any destination management organization or other entity**
22 **receiving local transient lodging tax revenue under an agreement en-**
23 **tered into with a unit of local government shall submit a biennial re-**
24 **port to the unit of local government for inclusion in the biennial**
25 **report required under subsection (1) of this section.**

26 **“(b) A report required under paragraph (a) of this subsection shall**
27 **include a description of:**

28 **“(A) The uses of the local transient lodging tax revenue received**
29 **under the terms of the agreement, including, but not limited to,**
30 **marketing, staffing and grants;**

1 “(B) Performance metrics of tourism promotion, including cam-
2 paigns executed and audiences reached; and

3 “(C) Compliance with the terms of the agreement and key deliver-
4 ables satisfied.

5 “(4) The Legislative Revenue Officer shall submit an aggregate
6 summary of reports received under subsection (1) of this section for
7 each biennium, in the manner provided in ORS 192.245, to the interim
8 committees of the Legislative Assembly related to revenue, economic
9 development and local government.

10 “**SECTION 5.** Section 4 of this 2026 Act is repealed on January 2,
11 2041.

12 “**SECTION 6.** (1) The Legislative Revenue Officer shall conduct a
13 study of the percentage requirements for allowable uses of local tran-
14 sient lodging tax revenue under ORS 320.350 (6), as amended by section
15 1 of this 2026 Act.

16 “(2) The study shall discuss the following, separately and under
17 such further detailed headings as the Legislative Revenue Officer
18 considers useful:

19 “(a) The amount and percentage of revenue used to fund tourism
20 promotion, including revenue expended under agreements with desti-
21 nation management organizations;

22 “(b) The amount and percentage of revenue used to fund tourism-
23 related facilities;

24 “(c) The amount and percentage of revenue used to fund resiliency
25 grants for small businesses in the restaurant and lodging industry; and

26 “(d) The amount and percentage of revenue used to fund city or
27 county services.

28 “(3)(a) In conducting the study, the Legislative Revenue Officer
29 may consult with interested stakeholders.

30 “(b) Units of local governments shall provide the Legislative Reve-

1 **nue Officer with the data and other information necessary to conduct**
2 **the study, including tax collections and expenditures.**

3 **“(c) The Legislative Revenue Officer may use any information re-**
4 **ceived under section 4 of this 2026 Act for purposes of the study re-**
5 **quired under this section.**

6 **“(4) Not later than September 15, 2034, the Legislative Revenue Of-**
7 **ficer shall submit, in the manner provided by ORS 192.245, to the in-**
8 **terim committees of the Legislative Assembly related to revenue, a**
9 **report of the findings of the study.**

10 **“SECTION 7. Section 6 of this 2026 Act is repealed on January 2,**
11 **2036.**

12 **“SECTION 8. This 2026 Act takes effect on the 91st day after the**
13 **date on which the 2026 regular session of the Eighty-third Legislative**
14 **Assembly adjourns sine die.”.**
