Version 1 — Short, Clean, Professional (Low Effort / High Volume)

Opposition Testimony – HB 4145 (2026)
Submitted to the Oregon Legislature

I oppose HB 4145.

HB 4145 places new burdens on law-abiding citizens while doing nothing meaningful to stop criminals, who by definition do not follow regulations. This bill will not reduce violent crime, but it will increase cost, legal risk, and barriers for ordinary Oregonians acting in good faith.

Equally troubling, the hearing for this bill did not appear on OLIS until last Monday morning, severely limiting public notice and participation. That kind of last-minute scheduling undermines trust in the legislative process.

For both substantive and procedural reasons, HB 4145 should be rejected.

Version 2 — Process + Substance (Balanced, Persuasive)

Opposition to HB 4145

I strongly oppose HB 4145.

HB 4145 follows a familiar pattern: it regulates people who already obey the law while leaving criminal behavior untouched. Criminals do not comply with paperwork, fees, or new restrictions. As a result, this bill burdens lawful citizens without producing real public-safety benefits.

The process is also deeply concerning. The hearing was not posted on OLIS until last Monday morning, leaving many Oregonians without reasonable notice. Whether intentional or not, this suppresses public participation and creates the appearance of a procedural ambush.

If this bill were sound, it would not need to be rushed or hidden.

HB 4145 should be rejected.

Version 3 — Sharper Policy Critique (Enforcement, Cost, Inequality)

Opposition Testimony – HB 4145

I oppose HB 4145.

HB 4145 relies on enforcement against law-abiding people, not criminals. Those who commit violent crimes will not comply with additional regulations. Enforcement will therefore focus on compliant citizens, producing paperwork violations rather than safety improvements.

The bill also diverts public resources—staff time, enforcement effort, and administrative cost—away from targeting repeat violent offenders and illegal activity. That is a poor use of limited state resources.

In addition, the burdens imposed by HB 4145 fall hardest on rural residents, lower-income Oregonians, and the elderly, who face greater costs, travel burdens, and

delays. Rights should not depend on income or geography.

Finally, the hearing was not listed on OLIS until last Monday morning, denying many citizens a fair opportunity to participate.

HB 4145 is ineffective, inequitable, and procedurally flawed. It should be rejected.

Version 4 — Blunt but Still Record-Safe

Opposition to HB 4145
