

Letter in Support of HB 4134

A Modest Increase to the State Transient Lodging Tax Establishes Dedicated Funding Supporting Oregon's Lands, Waters and Wildlife

Dear Chair Nathanson and members of the House Committee on Revenue:

My name is David Moskowitz. I live in Northeast Portland, OR.

I am submitting this testimony in strong support of HB 4134 with the -1 amendment.

As an Oregonian since 1987, I want to see our extraordinary landscapes, species, and the communities that have relied on them to thrive for generations to come. People from around the world come to our state to experience Oregon's stunning natural beauty from the coast to the Snake River and from the Columbia River to the Great Basin.

However, these landscapes also support multiple species of fish and wildlife that are part and parcel with the various ecosystems that make Oregon a beacon for visitors seeking the vistas but also the creatures and plants that rely on Oregon's uniqueness.

HB 4134 will generate the funds we need to protect the places and keep good inventories of their fishy, feathery and furry inhabitants. This investment is also timely as the impacts of climate change continue to unfold throughout Oregon.
