RE: COIN Testimony in Support of HB 4088

Dear Chair Kropf, Vice-Chairs Chotzen and Wallan, and Members of the House Committee on the Judiciary:

Thank you for the opportunity to offer testimony in strong support of HB 4088 which offers meaningful protections to health care providers performing lawful reproductive and gender-affirming care in Oregon, increases medical and legal privacy protections for those seeking reproductive and gender-affirming health care in Oregon, and safeguards the rights of all persons in Oregon to obtain reproductive and gender-affirming care without fear of discrimination or retribution.

COIN is made up of more than 70 Indivisible groups across Oregon. Our members are committed to protecting the long-standing rights of Oregonians to obtain lawful reproductive and gender-affirming care and to assure their privacy in doing so. Oregon has long been a leader nationally with strong laws that protect the rights to reproductive and gender-affirming health care including a shield law passed in 2003 following the 2022 U.S. Supreme Court decision in *Dobbs v. Jackson's Women's Health Organization* that took away the long-established federal constitutional right to abortion health care. See the shield law, OR Rev. Statutes Secs. 435.210, .240, Sec. 25.500(3).

But it is no longer enough. Since *Dobbs* a number of states have banned or restricted the right to abortion and related reproductive health care, and the federal government has actively worked to reduce or cut off access to such care. As a result of these aggressive and cruel laws and policies, women have died and the lives and health of many more have been jeopardized.

Health care providers of reproductive health or gender-affirming care are increasingly targeted for prosecution and retribution as a result of these alarming federal and out of

state attacks on reproductive and gender-affirming health care. The attack on such care care is growing nationwide and has put at risk patients seeking care in Oregon as well as our health care providers. Fears of surveillance, involvement in federal or out of state criminal investigations, and retaliation are not only disruptive to care but certainly deter essential and lawful reproductive and gender-affirming health care. HB 4088 would address these growing attacks and fears and strengthen Oregon's commitment to reproductive and gender-affirming health care with a far-reaching prohibition on any cooperation with any investigation or inquiry into reproductive or gender-affirming health care in Oregon that was lawfully provided or received or attempted to be provided or received, or aided or encouraged. The bill restricts extradition in connection with the provision of any reproductive or gender-affirming health care performed in Oregon. The bill would also protect midwife services in relation to lawful reproductive or gender-affirming health care. And, the bill strengthens privacy protections for health care workers and patients including assuring gender and name changes filed with the courts are regarded as confidential records.

On behalf of the Consolidated Oregon Indivisible Network, I urge the Committee to vote yes on HB 4088.
