Written Testimony Submission Form

If you are not able to submit your testimony during this open record window, you may email your testimony directly to your legislator or to the committee members.

Personal information in written testimony and in the submission form (except email addresses) is posted to OLIS and accessible to all major search engines, including Google, Bing, and Yahoo. DO NOT include any personal information that you do not want made available to the public, such as your address, phone number, or health history.
