My name is Annie Naranjo-Rivera, and I serve as the State Director of the Oregon Working Families Party. We are a grassroots, multiracial political organization made up of community-based organizations and unions committed to building a society that works for all of us—not just the wealthy and well-connected. We advocate for economic justice, racial equity, and a democracy that centers working people and their communities.

Across Oregon, the recent increase in horrifying ICE activity and so-called “immigration enforcement” has created widespread fear and instability in our communities. Immigrant Oregonians, our families, and whole communities across the state have been terrorized and targeted by violent and lawless ICE sweeps, resulting in community-wide fear and devastating family separations. This unacceptable federal overreach impacts immigrants and non-immigrants alike. The reckless federal attacks demand a strong, unified response. Oregonians know we must push back.

The **Protect Your Door Act** would reinforce and protect our constitutional rights to be secure in our own homes. If constitutional protections are violated by someone entering a person’s home without a valid warrant signed by a judge, or the person’s consent, then they could be sued for personal damages and harm they have caused.

Our constitutional rights are currently under attack and we have heard from families across the state that they view this as the *disintegration of the very foundations of our democracy*. We continue to see families across the state (and country) experiencing their rights being violated without accountability. **HB 4114** holds individuals personally responsible for infringing on someone’s right to privacy and security in their home.

For this reason, the Oregon Working Families Party strongly supports **HB 4114—the Protect Your Door Act** and urges the Legislature to advance the full Immigrant Justice Package (IJP).
