Measure, Appointment or Topic: SB1598

Chair, Vice-Chairs, and Members of the Committee,

I am submitting testimony in strong opposition to SB1598, a bill that represents one of the most dangerous expansions of government overreach we have seen in Oregon.

SB1598 shifts medical decision-making away from individuals, parents, doctors, and elected legislators and hands it to unelected bureaucrats who have no accountability to the people. This bill is not about health — it is about control.

Oregon Has Always Championed “My Body, My Choice” — Until Now

For decades, Oregon lawmakers defended bodily autonomy. But now that the federal government has affirmed those same rights for vaccines and for children, the state suddenly rejects them.
