Fraudulent legislation

The legal term when legislation does not follow the legislative laws on the process or procedure of a house bill is often referred to as "fraudulent legislation." This occurs when a bill is not confined to one subject as required by law, which can lead to the bill being deemed void or unenforceable.

Legally, bills must be limited to one subject clearly described by the title and drafted in a specific style to avoid procedural issues. Noncompliance with these requirements can result in the bill being rejected or declared void by the courts.

- VIOLATING LEGISLATION TIMEFRAMES

- VIOLATING THE FEDERAL REQUIREMENT TO REQUIRE A 2/3 VOTE ON THE HOUSE FLOOR, VOTE DID NOT MEET 2/3 MAJORITY
- VIOLATING LEGISLATION LAWS TO HAVE 2/3 MAJORITY RULE ADDED TO THE GENERAL ELECTION AS CONCLUDED IN PREVIOUS YEARS SENATE BILL, HELD IN COMMITTEE
- VIOLATING THE LAW THAT REQUIRES THE REASONING FOR A BILL TO HAVE AN EMERGENCY CLAUSE ADDED TO IT AND INCLUDING THAT IN THE PREAMBLE OF THE BILL
- VIOLATING BASIC HUMAN RIGHTS PER OR. CONSTITUTION
- VIOLATING EQUALITY LAWS WITH SPLIT REQUIREMENTS FOR DIFFERENT CLASSES
- VIOLATING THE REQUIREMENT
- VIOLATING EMERGENCY VOTE
- VIOLATING THE WILL OF THE PEOPLE WHO YOU WORK FOR AS ONLY A FEW COUNTIES VOTED YES ON THE ORIGINAL MEASURE 114, NOT REFLECTING A TRUE VOTE AND EXCLUDING TESTIMONY OF RURAL REPRESENTATIVES ON THE PEOPLE'S BEHALF

- I WITNESSED 24 OUT OF 29 DEMOCRATS SITTING ON THEIR PHONE, COMPUTERS, OR READING BOOKS DURING REPUBLICAN REPRESENTATIVE TESTIMONIES
- PUSHING THIS THROUGH LAST MINUTE THE WAY IT STANDS VIOLATES OUR RIGHTS ON SO MANY LEVELS IT IS DISGUSTING TO SEE
- WHEN MARSHAL LAW IS ENACTED, WHO WILL PROTECT YOU, IT WON'T BE THE CARTEL AND CRIMINALS, YOU WILL WANT PATRIATS AND LAWFUL CITIZENS TO PROTECT AND SERVE
- THERE ARE EXISTING LAWS IN PLACE, MANY FEDERAL LAWS, THAT REQUIRE CERTAIN THINGS TO TAKE PLACE IN SCHOOLS AND OTHER PLACES TO ENSURE ANY GUN VIOLENCE IS ADDRESSED PRIOR TO POTENTIAL GUN VIOLENCE
- VIOLATED DRAFTING LAWS MAKING IT INCREDIBLY HARD TO FOLLOW THE CHANGES, SO MUCH SO THAT THERE IS LITERALLY NOT TIME TO DO IT WITHOUT THE MARKUPS BEING DRAFTED PROPERLY
- DEMOCRATS ARE TRYING TO OVERTAKE THE OREGON SUPREME COURT DECISION BY FORCING THIS BILL AND WITH THE COMMENT ON THE EMERGENCY CLAUSE - LOOK IT UP!
- ONLY MINOR CHANGES ARE ALLOWED TO BE MADE IN A BILL MODIFYING AN ENJOINED MEASURE THROUGH THE HOUSE, CHANGES ALLOWED INCLUDE THINGS THAT MAKE THE ORIGINAL MEASURE IN COMPLIANCE WITH THE REASONS THE MEASURE IS ENJOINED IN THE 1ST PLACE, FIXING LANGUAGE, NOT MAJOR CHANGES
- VIOLATING THE RIGHT TO VOTE IN COMMITTEE
- VIOLATING CIVIL RIGHTS OF FELLOW LEGISLATOR BY INTIMIDATION
- VIOLATING ETHICAL CODE OF CONDUCT
- VIOLATING REQUIREMENT FOR FULL INVESTIGATION INTO ETHICAL CODE OF CONDUCT VIOLATIONS AND PUNISHMENT OF CRIME
- VIOLATING LAWS REGARDING NOT VOTING WITH BIAS
- VIOLATING LAWS REQUIRING BIAS BE PUBLICALLY ANNOUNCED AND PUT ON THE JOURNAL, FOLLOWED UP WITH A WRITTEN DOCUMENT THAT IS REQUIRED TO BE ON THE RECORD FOR THE BILL, REQUIRED PRIOR TO BILL BEING VOTED ON
- VIOLATING REQUIREMENT FOR A COMPLETE FISCAL REVIEW (INTRODUCTION, COMMITTEE REFERRAL & VOTING STATES) PRIOR TO VOTING - REPORT SUBMITTED NOT COMPLETE, MILLIONS AND MILLIONS OF DOLLARS MISSING
- CHANGES MADE TO MEASURE IN THIS BILL EXCEED THE MINIMAL CHANGES LEGISLATION IS LEGALLY ALLOWED TO MAKE WITHOUT SENDING THE CHANGES BACK TO THE VOTERS
